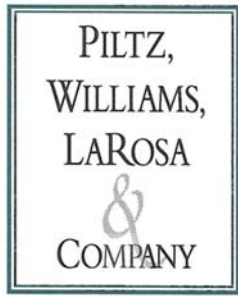

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Windsor Place 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Windsor Place 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure under ERISA*. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure under ERISA* (qualified institution).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 

Note A – Description of Plan

The following description of The Windsor Place 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Windsor Place Nursing Center, Inc. and The Arrington, LLC (Employer) who are age 21 or older, worked for the Employer for at least one year and worked at least 1,000 hours in a year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Secure 2.0 Act of 2022 was signed into law December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans. Plan management is adopting any mandatory provisions as they become applicable and evaluating those provisions deemed discretionary.

Contributions – Each year, participants may contribute up to the maximum percentage allowable, not to exceed the limits of Code Sections 401(k), 404, and 415 of the Internal Revenue Code. Employer matching contributions are discretionary. Contributions are also subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. Employer matching contributions are discretionary. The matching contribution is invested as the participant directs.

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of the Employer contributions and Plan earnings. Each participant's account is also charged with an allocation of administrative expenses, when applicable. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately 100% vested their salary deferral contributions plus actual earnings thereon. Vesting of matching funds is based on years of continuous service with 100% vesting after three years of credited service. However, participants become fully vested at early retirement date or at any time if they should die or become disabled, or if the Plan is terminated. Forfeitures of nonvested employer match contributions will reduce employer's matching contribution.

Payment of benefits – Upon termination of service with the Employer, a participant will receive the lump-sum distribution in the amount equal to the value of his or her vested account balance.

Forfeited accounts – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeiture balances may be used to further reduce Employer contributions or pay administrative expenses.

Note B – Summary of Accounting Policies

Basis of accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of investments – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note D for discussion of fair value measurements.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Employer and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses including record keeper, advisory, and consulting fees, are allocated among participant accounts.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Note D – Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For Level 3 investments, there are no gains or losses for the years ended December 31, 2024 and 2023 included in changes in net assets available for benefits attributable to the changes in unrealized gains or losses relating to assets held at the end of the reporting period.

Note E – Income Tax Status

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Note F – Related Parties

Certain Plan investments held during the year are shares of funds managed by John Hancock Asset Management. John Hancock Life Insurance company is the custodian of the Plan; and, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for the year ended December 31, 2024 totaled \$16,901.

Additionally, the Plan paid fees to a third-party administrator (TPA) during the year. These transactions also qualify as party-in-interest transactions. Fees paid by the Plan to the TPA for the year ended December 31, 2024 totaled \$2,698.

Additionally, the Plan paid fees to the auditor of the plan; and, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the auditor for the year December 31, 2024 totaled \$8,400.

Members of management of the Plan sponsor are participating in the Plan. However, there are no transactions with these individuals other than their participation in the Plan. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note G – Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Note H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note I – Subsequent Events

Management evaluated subsequent events through August 22, 2025, the date on which the financial statements were available to be issued.


