**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the California Health Collaborative Pension Plan (the “Plan”) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering employees of California Health Collaborative. The plan became effective January 1, 1999, and was restated on January 1, 2021. The Plan agreement was written to comply with the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the provisions of the Tax Reform Act of 1986 and has been amended and restated since inception to comply with various changes in legislation and regulation.

**Eligibility**

Employees are eligible to participate in the Plan after they have completed six months of service, provided they are at least 18 years of age at that time. The completion of one year of service is required. Service of this plan applies to HealthPlus, Management Alliance, LLC and The Hospital Council of Northern and Central California, Inc. (the “Company”) can be recognized for the purpose of this Plan. Eligibility enrollment date is the first day of the quarter proceeding eligibility.

**Contributions**

Each year, participants may contribute up to the maximum percentage allowable by law, of pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (“rollover”). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make matching contributions, at a discretionary rate determined by the Company. For the year ended December 31, 2024, the Company elected to match 100% of participant deferred contributions, up to a maximum deferred contribution for each participant of 3% of annual compensation.

The Company may also make non-elective discretionary contributions to the Plan. These contributions are discretionary, which, if any, are allocated among participants who are eligible employees. For the year ended December 31, 2024, the Company elected to match an additional 5% of contributions to eligible employees totaling \$360,655.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

**Vesting of Benefits**

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service. At least 1,000 hours must be worked within a year to qualify as a year of service. A participant becomes 40% vested after a year of service and vested balance increases 20% each year. A participant is generally 100% vested after four years of credited service. Each participant's benefits are limited to the balance in the participant's vested account

**Automatic Enrollment**

The Plan includes an automatic enrollment feature. This feature includes a provision for all non-participating employees to be automatically enrolled in the Plan when eligible at a deferral rate of 3% of the employee's compensation. Contributions for automatically enrolled participants will be invested in the Plan's default investment fund.

**Notes Receivable from Participants**

In accordance with the provisions of the Plan, participants can borrow funds at a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) one-half of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with prevailing market rates. Principal and interest are paid ratably through payroll deductions. Generally, the term of the loan may not exceed five years.

**Distribution of Benefits**

Upon termination of employment, participants may request either immediate distribution of their vested account balance or a deferral of the account until the normal retirement age is met. Participants may receive benefits in (a) a single lump sum, (b) in substantially equal installments, or (c) the purchase of a non-transferable annuity contract. Under certain circumstances, prior to termination, employees may receive hardship or in-service distributions for part or all their vested account balance.

**Forfeited Accounts**

For the years ended December 31, 2024, the forfeited non-vested account totaled \$18,392. Forfeited funds may be used to reduce future employer contributions and/or offset plan expenses. For the year ending December 31, 2024, \$8,000 forfeited funds were used to cover administrative fees.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Valuation of Investments and Income Recognition**

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions made under the terms of the contract. The Plan's Administrative Committee determines the valuation policies utilizing information provided by the investment advisors and the custodian of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded when earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. In the event of participant default through non-payment or other means, foreclosure on the promissory note and attached secured assets may not occur until an event occurs that would allow or require a distribution of the participant's vested account balance.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation of the fair value of investments.

**NOTE 3 – TAX STATUS**

The Plan is qualified under the provisions of the Internal Revenue Code ("IRC") and is not subject to federal and state income taxes.

**NOTE 3 – TAX STATUS (Continued)**

The Plan is relying on an opinion letter dated June 2020, in which the Internal Revenue Service (IRS) states that the Prototype Non-standardized Profit-Sharing Plan with CODA, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC; therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is no longer subject to potential income tax examinations by tax authorities for years for which the statute of limitations has expired.

**NOTE 4 – PRIORITIES UPON TERMINATION**

Although the Company has established the Plan with the bona fide intention and expectation that it will be maintained indefinitely, nevertheless, the Company is not under any obligation or liability to continue the Plan for any given length of time. The Company may in its sole discretion discontinue or terminate the Plan in whole or in part in accordance with its provisions at any time without any liability for such discontinuance or termination.

In the event the Plan terminates, no further contributions will be made to the Plan and all amounts credited to the participants' accounts will continue to be vested in accordance with the Plan document. The Company will direct the distribution of the participants' accounts in a manner permitted by the Plan as soon as practicable.

**NOTE 5 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

ERISA section 412 and related regulations (29 C.F.R. § 2550.412-1 and 29 C.F.R. Part 2580) generally require that every fiduciary of an employee benefit plan and every person who handles funds or other property of such a plan shall be bonded. ERISA's bonding requirements are intended to protect employee benefit plans from risk of loss due to fraud or dishonesty on the part of people who handle plan funds or other property. In conclusion, the Plan is not protected against loss by reason of acts of fraud or dishonesty on the part of persons requires to be bonded, whether the person acts directly or through connivance with others.

**NOTE 6 – INFORMATION CERTIFIED BY CUSTODIAN – UNAUDITED**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that was prepared by Voya Retirement Insurance and Annuity Company (the "Trustee") and furnished to the Plan administrator.

**NOTE 6 – INFORMATION CERTIFIED BY CUSTODIAN – UNAUDITED (Continued)**

The plan administrator has obtained certifications from the Trustee that such information is complete and accurate:

- The value of investments as indicated in the statements of net assets available for benefits and notes to the financial statements, including notes receivable from participants.
- All information indicated in the statement of changes in net assets available for benefits, with the exception of contributions, benefit payments, and administrative fees.
- All information indicated in the supplemental schedules.

**NOTE 7 – PARTIES-IN-INTEREST**

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the trustee and recordkeeper of the Plan; therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. For the year ended December 31, 2024, the Plan incurred direct fees of \$15,600 for administrative services provided to the Plan.

**NOTE 8 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board's Accounting Standards Codification 820 are described as follows:

---

Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2    Inputs to the valuation method include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 8 – FAIR VALUE MEASUREMENTS (Continued)**

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

*Mutual funds:* Valued at the net asset value of shares held by the Plan at year end.

*Pooled Separate Accounts:* The fair value of the investments in this category have been estimated using the net asset value (NAV) per unit provided by the administrator of the fund as a practical expedient. The NAV is not a publicly quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) In accordance with Subtopic 820-10, certain investments that are measured at net asset value per share (or equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

**NOTE 9 – FULLY-BENEFIT RESPONSIVE INVESTMENT CONTRACT**

The Plan offers investments in a stable value fund, which is a fully benefit-responsive investment contract issued by Voya Retirement Insurance and Annuity Company, the custodian, with the backing of their general account. As it is not a portfolio of contracts whose yields are based on changes in the fair value of the underlying assets, this type of investment is considered fairly valued at contract value. The methodology for calculating the interest crediting rate is defined in the contract. Voya Retirement Insurance and Annuity Company guarantees that interest will be credited at the higher of a rate guaranteed in the group annuity contract and the current rate declared by it.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. The Plan may transact according to the terms defined in the contract at any time.

The interest credited to participants in the Contract for years ended December 31, 2024, was estimated at 1.55%. The Contract has a minimum crediting interest rate of 1%. There are no restrictions on the use of Plan assets and there is no valuation reserves recorded to adjust contract amounts. Fund performance, net cash flows of the Plan investments, and duration of assets are factors that could influence the average interest credited rate.

Certain events might limit the availability of the Plan to transact at contract value with the contract issuer. Examples of such events include the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code ("IRC"); premature termination of the contract; Plan termination or merger; changes to the Plan's prohibition on competing investment options; or bankruptcy of the Company or other Company events (for example divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include an uncured violation of the Plan's investment guidelines; a breach of material obligation under the contract; a material misrepresentation; or a material amendment to the agreements without the consent of the issuer.

**NOTE 10 – PLAN ERRORS AND PROHIBITED TRANSACTIONS**

During 2024, the Company inadvertently failed to make deposits of \$18,316 of participants deferrals within the timeframe as required by the Department of Labor ("DOL"). The DOL considers late deposits, without regard to materiality, to be prohibited transactions. The DOL considered these prohibited transactions as uncorrected until lost earnings have been calculated and remitted to the plan. The general rule for deposits of 401(k) withholdings require that the Company remit withheld employee 401(k) deferrals to the plan as of the earliest date on which such amounts can be reasonable by segregated from the Company's general assets, but no later than 15 business days after the end of the month in which the contributions were withheld. Lost earnings from 2023 have not been calculated or paid as of the year ending December 31, 2024.

**NOTE 11 – SUBSEQUENT EVENTS**

Subsequent events have been evaluated through July 24, 2025, which is the date the financial statements were available to be issued. No events were identified that would require additional disclosure.
