## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Relief International Voluntary Tax Deferred Annuity Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Relief International Voluntary Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Relief International Voluntary Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**1. Plan Description**

The following description of the Relief International Voluntary Tax Deferred Annuity Plan (the Plan) provides only general information. Participants and interested parties should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. General – The Plan is tax deferred annuity plan established on October 1, 1995 under section 403(b) of the Internal Revenue Code. The Plan was since restated on May 1, 2013. The Plan covers all full-time employees who work more than 20 hours per week or 1,000 hours a year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. Contributions – Participants may contribute by salary reduction up to 100% of their annual eligible compensation, subject to Internal Revenue Code limitations. The employer makes nonelective contributions to an eligible participant account based on salary and completed years of services as follows:

The employer may also make discretionary matching contributions to eligible participant accounts. The amount of the discretionary matching contributions is determined by the board of directors each year. There were no discretionary matching contributions for 2024 and 2023.

- c. Participant accounts – Each participant's account is credited with the participant's contributions and allocations of employer contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined. The benefits to which a participant is entitled are those which can be provided from the participant's vested account.

- d. Vesting – Participants are 100% vested in their deferral contributions, rollover contributions, and employer discretionary matching contributions if any, plus actual earnings thereon. Participants’ interest in employer nonelective contribution account is vested based on their years of vesting service in accordance with the following schedule:

<u>Years of Vesting Service</u>	<u>Vesting</u>
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

- e. Participant loans - Participant loans, as allowed by the Plan, are limited to the lesser of 50% of the participant’s vested account balance or \$50,000. Terms and conditions are governed by applicable rules and regulations of the Internal Revenue Code.
- f. Forfeited accounts – The non-vested portion of contributions to terminated participants are forfeited and reallocated to other participants’ accounts in proportion to compensation, subject to applicable Code limits. During 2024 and 2023, forfeitures of \$9,390 and \$29,566 was reallocated to participant accounts. At December 31, 2024 and 2023, there were \$35,782 and \$9,390, respectively, in forfeitures available to be reallocated to participant accounts.
- g. Investment options – The Plan offers a select number of investment vehicles in which participants may invest their funds. Upon enrollment in the Plan, a participant may direct the investment of contributions in any of the available investment options. Participants may change their investment options daily. At December 31, 2024 and 2023, these investment options consisted of registered investment companies (mutual funds) and group annuity investment contracts.
- h. Payments of benefits – Distributions from the Plan are permitted upon retirement, attainment of age 59-1/2, hardship, death, or disability. To receive benefits, each participant may select from among several options including annuities offered under the plan and a lump sum payout.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.

Subsequent to year-end, the Plan experienced a reduction in workforce that is expected to result in a partial termination under IRS guidelines. The Plan will vest affected participants 100% in employer contributions, as required.

**3. Fair Value Measurements**

Financial accounting and reporting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**3. Fair Value Measurements (continued)**

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in *mutual funds* are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. Guaranteed Investment Contracts**

The Plan entered into benefit-responsive guaranteed investment contracts (TFLIC Fixed Fund and TFLIC Government Fixed Fund) with Transamerica. Transamerica maintains the contributions in TFLCI Fixed Fund in a general account and the contributions in TFLIC Government Fixed Fund in a guaranteed separate pooled account. The general account and the guaranteed pooled separated account are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that are guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Fixed Funds contain a minimum guaranteed interest rate. The crediting rates are determined by Transamerica but may not be less than the minimum guaranteed rate. Transamerica establishes a crediting rate for new deposits received during a calendar quarter, which will be applicable to such assets through the end of the calendar year.

Transamerica may establish a separate crediting rate for deposits exceeding \$500,000 in any calendar month and for transferred assets.

The crediting rates and the minimum guaranteed rates of the guaranteed investment contracts, as of December 31, 2024 and 2023 were as follows:

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at contract value minus a 5% withdrawal charge. Such events include (1) a noncompliance with the requirements of Section 401(a) or 403(a) of the Internal Revenue Code or of ERISA, (2) a failure to remit required deposits under the terms of the contract to the issuer, (3) the issuer determines that he can no longer provide benefits under the contract because of a change in the plan, (4) the issuer is advised that the issuer service agent, Transamerica, has received or has given notice that it will no longer be providing recordkeeping and administrative services to the plan, (5) the issuer receives written notice from the contract holder to transfer contract assets to a successor funding agent, (6) the plan sponsor files a petition for bankruptcy. The guaranteed investment contract does not permit the insurance company to terminate the agreement unless the Plan is not in compliance with the investment agreement.

The plan management does not believe any event which would limit the Plan's ability to transact at contract value with participants and the issuer, is probable of occurring.

**7. Tax Status**

The Plan obtained its latest opinion letter on March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is likely that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by Transamerica Financial Life Insurance Company. Transamerica Financial Life Insurance Company is the trustee and recordkeeper for the Plan and, therefore, the transactions qualify as party-in-interest transactions as defined by ERISA.
