Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

**NOTE A - DESCRIPTION OF PLAN**

**Plan Description** - The following description of ERS Parent 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan, established January 1, 1999, is a defined contribution plan covering eligible employees of Hub Enterprises, Inc. Effective January 1, 2023, the Plan became the ERS Parent 401(k) Plan to include all wholly-owned subsidiaries of ERS Parent, LLC, (the Company), which includes HUB Enterprises, Inc. Participants are eligible after one year of service or if an employee of an adopted subsidiary as of January, 1 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Each year, participants may contribute up to 100% of their compensation, as defined in the Plan, subject to the maximum allowable deferral per the Internal Revenue Service (IRS) that have met eligibility requirement of one year of service with 1,000 hours. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and cash equivalent options. Contributions are subject to certain limitations.

The Company will make an ADP safe harbor matching contribution of 100% of employee deferrals up to 3% of the employee compensation plus 50% of the employee's deferral up to 5% of the employee compensation.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Forfeited accounts** - Non-vested amounts forfeited by the participant are retained by the Plan and may be used to reduce future employer contributions or pay plan expenses, at the Company's election. The Plan had unallocated forfeitures of \$1,623 and \$1,497 at December 31, 2024 and 2023, respectively.

**Vesting** - Participants are immediately vested in their contributions and ADP safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The participant is 100% vested after four years of credited service, or upon occurrence of the participant's retirement, death, or disability, as defined by the Plan document.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's vested account and bear interest based at the prime rate plus 1%. Notes receivable from participants had rates at 4.25% – 9.50%. Principal and interest is paid ratably through payroll deductions and are reinvested in the participant accounts according to individual investment elections. The Plan had outstanding loans of \$75,684 and \$25,036 at December 31, 2024 and 2023, respectively.

**Payment of Benefits** - Upon normal retirement age, death, disability, or termination, a participant's benefit is payable in partial or a lump-sum withdrawal amount equal to 100% of the participant's vested account balance. The participant also has the option of transferring his or her vested interest to a personal retirement account. In-service withdrawals are permitted for active participants who have attained age 59 ½ of their vested account balance. Hardship withdrawals are permitted in the Plan and are allowed up to a maximum of the vested portion of the participant's account balance.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See **NOTE D** for fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Fees and expenses of the Plan are paid by the Company or the Plan as provided by the Plan document. Expenses paid by the Plan amounted to \$53,287 for the year ended December 31, 2024. Investment fees and commissions are netted against the net appreciation (depreciation) in fair value of investments.

**Excess Contributions Payable**

Corrective distributions include payments made to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions and statutory deferral amount limitations of the Plan. That amount is included in the statements of net assets available for benefits as excess contributions payable, with a corresponding deduction on the statement of changes in net assets available for benefits in accordance with accrual based accounting. There were no excess contributions payable to participants at December 31, 2024 and 2023, respectively.

**NOTE D - FAIR VALUE MEASUREMENT OF FINANCIAL INSTRUMENTS**

The financial statements are prepared in accordance with an accounting standard which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at the daily closing quoted market price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE F - TAX STATUS**

The Plan adopted a Non-Standardized Pre-Approved Profit-Sharing /Money Purchase/ CODA plan from Ascensus, LLC and received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS), that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) for the Plan. The Company believes the Plan, as adopted and amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal returns are generally open for examination for three years following the date filed.

**NOTE G - RELATED PARTY TRANSACTIONS**

Certain Plan investments of the Plan managed by Ascensus Trust Company, the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
