INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of **Wall & Associates, Inc. 401(k) Plan**:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Wall & Associates, Inc. 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **Wall & Associates, Inc. 401(k) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

A. Description of Plan

The following description of Wall & Associates, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution, tax-deferred profit sharing plan covering employees of Wall & Associates, Inc. (the "Company") who are at least 21 years of age and have one year of service (at least 1,000 hours) with the Company. Employees covered by a collective bargaining agreement and nonresident aliens without earned income are exempt from participation in the Plan. Plan entry dates are the first day of the Plan year and the first day of the seventh month of the Plan year after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of compensation, not to exceed the maximum salary deferral limit and other limitations established by law. Compensation is defined in the Plan documents as Wages, Tips and Other Compensation on Form W-2, including bonuses and commissions, and including elective retirement plan deferrals and any contributions made to a qualified cafeteria plan.

Participants may elect deferral contributions as pre-tax or Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code. Participants also may make rollover contributions of distributions from other qualified defined benefit or defined contribution Plans and certain individual retirement accounts and annuities.

The Company makes a safe harbor non-elective contribution to each participant equal to 3% of the participant's annual compensation. The Company allocated \$40,331 and \$72,206 safe harbor non-elective contributions to the Plan for the years ending December 31, 2024 and 2023, respectively. The Company also has the option to make matching contributions and profit sharing contributions to the Plan, although the Company is not required to do so. The amount of any matching contributions will be according to an allocation formula determined by the Company. Profit sharing contributions will be allocated to eligible employees according to the allocation formula specified in the Plan. Company contributions are invested according to participant investment elections.

Participant Accounts

Each participant's account is credited with the participant's contributions, safe harbor non-elective contributions, and any other Company contributions. Investment earnings, losses, and changes in market value are allocated based upon the experience of each investment in the participant account. Certain transactional costs and service charges, if applicable, are allocated to the specific accounts involved in the transaction or receiving the service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their own deferral contributions, safe harbor non-elective contributions, rollover contributions, and the earnings thereon. Participants vest in Company matching and profit sharing contributions and earnings over a six-year vesting schedule. Participants become 100%

vested under certain other circumstances, including attainment of age 65, the Plan's normal retirement age. Non-vested balances are subject to forfeiture upon termination of employment.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms require amortization of principal and interest over a period not to exceed five years, with certain exceptions. Participants may have one loan outstanding at a time. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, and at death. Benefit payments may be elected as a lump-sum payment equal to the value of the participant's vested interest in his or her account or installments over a period of time to meet minimum distribution requirements. Terminated or deceased participants whose account balances do not exceed \$5,000 may be automatically distributed to the participant in a single lump sum payment. If the balance exceeds \$5,000, the participant may elect to remain in the Plan or take a distribution in the form of a rollover or cash.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested balances held in the guaranteed interest contract were \$9,402 and \$8,829, respectively. Forfeitures may be used to pay any Plan expenses and then to offset other employer contributions for the Plan year in which a forfeiture occurs. Forfeitures totaling \$11,648 were used to offset employer contributions during 2024.

B. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair

value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The loans are secured by vested participant account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Per-use transaction fees are charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions, and are included in administrative expenses of the Plan. In addition to per-use transaction fees, participants with account balances share in the operational expense of the Plan. Investment related expenses are included in the net appreciation or depreciation in the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through August 25, 2025, the date the financial statements were available to be issued.

C. Information Certified by the Insurance Company of the Plan

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America, as attorney-in-fact for Talcott Resolution Life Insurance Company, the insurance company of the Plan, has certified as to the completeness and accuracy of all investment balances, related investment activity, notes receivable from participants and related interest income from notes receivable from participants in these financial statements and supplemental schedule, summarized as follows:

D. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts are valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

The following tables sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Guaranteed Investment Contract

The Plan includes investments in a traditional guaranteed investment contract with Talcott Resolution Life Insurance Company (TRLIC). TRLIC maintains the contributions in a general company account. TRLIC is contractually obligated to repay principal and a specified interest rate to the Plan. The crediting interest rate at December 31, 2024 and 2023 was 3.00% and 3.00%, respectively. The guaranteed investment contract does not permit TRLIC to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract is a traditional investment contract for which the contract value was \$637,077 and \$792,903 at December 31, 2024 and 2023, respectively. The Plan holds no synthetic investment contracts.

The guaranteed investment contract meets the fully benefit responsive investment criteria and therefore is presented at contract value on the statements of net assets available for benefits. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Retirement, LLC on behalf of TRLIC, represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its financial obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events, such as Plan termination or merger, bankruptcy of the Plan sponsor, or premature cancellation of the contract may limit the ability of the Plan to transact at contract value with the issuer of the guaranteed interest contract.

F. Party-In-Interest Transactions

Talcott Resolution Life Insurance Company is the insurance company of the Plan and receives fees for investment custodial and transaction services. Empower Retirement, LLC, a wholly owned subsidiary of Empower Annuity Insurance Company of America, is the recordkeeper of the Plan and receives fees for recordkeeping services and per-use transactions that are included in administrative expenses.

A third party administrator receives fees for loan setup, distribution and other administrative services that are included in administrative expenses. A financial advisor receives fees for investment advisory services. Certain investment related expenses are included in net appreciation or depreciation of investments. The company provides the Plan with accounting and administrative services for which no fees are charged to the Plan. The Plan allows loans to participants. The Plan's individual trustee, as an employee, is a participant in the Plan. These transactions qualify as exempt party-in-interest transactions.

G. Tax Status

The Internal Revenue Service has determined and reported in its opinion letter dated November 30, 2020, that the form of adopted pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions have been taken or are expected to be taken that would require recognition or disclosure in the financial statements.

H. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their accounts and the Company will arrange for distributions as soon as administratively feasible.

I. Risks and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks, including interest rate, market, and credit risks. Due to the level of risk associated with such investments, it is at least reasonably possible that changes in the values of Plan investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
