Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Employee Resource Administration, L.P. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [(ERISA Section 103(a)(3)(C) audit)]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of Employee Resource Administration, L.P. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was effective January 1, 2002, restated effective January 1, 2016, and is a multiple employer, defined contribution plan that is participant-directed. The participating employers may choose different eligibility and participation requirements, but generally the Plan covers all full-time employees of the participating employers who have completed one year (at least 1,000 hours) of service and are age twenty-one (21) or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is defined by Section 401(k) of the Internal Revenue Code (IRC).

Eligibility

Any employee who is twenty-one (21) year of age is eligible to become a participant in the Plan on the first day of the first month and of the seventh month of the plan year (semi-annual) coinciding with or next following the date he or she satisfies the eligibility requirements.

Employee Salary Reduction Election

A participant may elect to defer up to one hundred percent (100%) of his or her compensation each year instead of receiving that amount in cash. However, total deferred compensation may not exceed the limits set by Internal Revenue Code Sections 401(k), 404, and 415. In addition, participants who are age fifty (50) or over before the close of the plan year are eligible to make catch-up contributions subject to the limitation imposed by the IRC.

Contributions

Elective Contributions

The participating employers must contribute the amount of the total employee salary reduction elections of all participants made during the plan year. The participating employers must pay elective contributions to the Plan’s custodian as soon as they can be segregated from its general assets, but no later than the fifteenth (15th) business day after the month of receipt of the voluntary contribution.

Contributions (continued)

Employer Matching Contributions

The participating employer makes a matching contribution equal to a discretionary percentage, to be determined by the participating employer, of the participant's deferred compensation. The participating employer may determine a separate discretionary matching contribution for Participants working in different business units or locations. The matching contributions are not immediately fully vested and are subjected to a six-year vesting schedule described below under Vesting section.

Employer Nonelective Contributions

The participating employer may make a discretionary nonelective contribution in an amount to be determined by the participating employer. The nonelective contributions are not immediately fully vested and are subjected to a six-year vesting schedule described below under *Vesting* section.

Rollover Contributions

The Plan may accept a rollover contribution on behalf of all participants as well as any employee, regardless whether such employee has met the age and service requirements of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) participating employer contributions and (b) participating employer earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their voluntary contributions plus actual earnings thereon. Vesting in the discretionary employer matching and nonelective contribution portion of the participant account plus earnings thereon is based on years of continuous services. The vesting for the employer contributions is as follows:

Contributions (continued)

Forfeited Accounts

Forfeitures represent the portion of non-vested employer contributions remaining in the Plan for terminated employees and may be used to reduce the employer matching contribution and to cover the costs of administration of the Plan. Forfeited account balances at December 31, 2024 and 2023 were \$6,975 and \$5,422, respectively. There were no forfeitures applied toward employer contributions for the year ended December 31, 2024.

Distribution of Benefits

Upon Retirement

Distributions may be made to a participant who has not separated from service when he or she attains age fifty-nine and one-half (59 ½). Distributions may be deferred until a participant reaches age sixty-five (65) if that participant continues to be employed by the participating employers. Payment may be in the form of a lump-sum distribution or partial withdrawal.

Upon Termination of Employment

A participant may elect to have his or her account balance distributed as soon as administratively feasible following termination of employment. A participant's account balance will be either paid in a lump-sum distribution, or a direct rollover distribution, or a combination of cash distributions and direct rollover distributions.

Hardship Distributions

A participant may withdraw pre-tax deferrals, including any earnings, in the event of a financial hardship, provided certain conditions are met. Hardship distributions can only be made from salary deferral and rollover accounts which are 100% vested and a participant must be employed with the participating employers at the time of the hardship distribution.

Upon disability

A participant's account is distributable upon a participant's disability. Payment may be in the form of a lump-sum distribution or partial withdrawal.

Upon Death

Distributions upon the death of a participant shall be made to his or her designated beneficiary in lump-sum or partial withdrawal.

Administrative Fees

Distributions are charged directly to the requesting participant's account. The Company absorbs the majority of all other administrative fees of the Plan. If expenses paid by the Plan are allocated to participants, expenses are either proportionately based on the value of the account balances or as an equal dollar amount based on the number of the participants in the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct all of his or her accounts to a variety of investments. Participant's accounts are segregated for purpose of determining the earnings or losses on their investment options.

Notes Receivable from Participants

Participants may borrow from his or her account with a maximum loan amount not to exceed the lesser of (a) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period or (b) one-half ($\frac{1}{2}$) of a participant's vested account balance. The minimum amount of a loan is \$1,000. A participant may only have one (1) loan outstanding at any time. Loans become due upon termination. Principal and interest are repaid by the participant's payroll deductions or checks (only for prepayments). Loans are secured by the vested balance in the participant's account and bear interest at one percent (1%) over the prime interest rate.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value with the exception of the group annuity contract, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments

Benefits are recorded when paid.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts

Pooled separate account ("PSA") invests mainly in domestic stocks or mutual funds. The majority of the underlying securities have observable level 1 quoted pricing inputs. The net asset value ("NAV") of the pooled separate account is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date.

4. Information Prepared and Certified by Custodian

Accordingly, American United Life Insurance Company (“AUL”), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment and notes receivable from participants information included in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Investments at Contract Value

The Plan invests in a group annuity contract, AUL Stable Value Account, which meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Investment contract balances at December 31, 2024 and 2023 were \$3,121,580 and \$3,519,000, respectively.

6. Related-Party Transactions and Party in Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

During the year ended December 31, 2024, the Plan paid \$11,181 to Loren D Stark Company for third-party plan administration fees and \$2,806 American United Life Insurance Company (“AUL”), for recordkeeper fees. AUL provides certain administrative services at no cost to the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

9. Tax Status

The IRS has determined and informed the Company by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Company and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
