### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

#### 1. DESCRIPTION OF PLAN

The following description of The Doyle Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan sponsored by The Doyle Group, Inc. (the Company). The Plan covers certain employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's management is responsible for oversight of the Plan.

##### **Administration**

The Company is the sponsor and administrator of the Plan. Reliance Trust Company (Reliance) serves as the trustee and custodian of the Plan's assets, and Automatic Data Processing, Inc. (ADP) is the third-party administrator and provides record-keeping services for the Plan.

##### **Eligibility**

Employees of the Company that are not nonresident aliens or represented by a collective bargaining agreement are eligible to participate in the Plan. Employees are eligible to participate in the Plan upon completion of three months of service and upon the attainment of age 21. Contributions begin on the first day of the subsequent payroll period following completion of each of these eligibility requirements. Eligibility for any Company contributions requires the participant to be employed on the last day of the Plan year.

##### **Contributions**

Participants may make voluntary tax-deferred contributions of up to 90% of their compensation to the Plan, subject to certain limitations under the terms of the Plan and the Internal Revenue Code (IRC).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible pretax compensation. For participants that are automatically enrolled, the initial automatic deferral amount will increase annually on the participants' anniversary of their Plan entry date by 1%, up to a maximum of 10%.

The Company may make discretionary matching contributions on behalf of participants. In both 2024 and 2023, the Company made discretionary matching contributions equal to 13.5% of the first 6% of compensation that a participant contributed to the Plan.

## 1. DESCRIPTION OF PLAN (Continued)

### **Rollovers**

Participants may transfer funds from other qualified plans with the consent of the Plan administrator.

### **Participant Accounts**

Participants direct the investment of their contributions and company-matching contributions into the various investment options offered by the Plan. Participant accounts are credited with participant contributions, company-matching contributions, and actual earnings and losses thereon. Plan expenses are allocated based on participant compensation and account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings and losses thereon. The Company's matching contributions vest 50% after two years of service and are fully vested after three years of service. A participant also becomes fully vested upon attaining normal retirement age, death, or total and permanent disability.

### **Benefit Payments**

The Plan provides for benefit payments upon termination of service due to death, disability or attainment of retirement age. Participants may elect disbursement of their vested account balance in either a lump-sum amount, in installments, or direct rollover into an individual retirement account or another qualified plan. The normal retirement age is the date a participant reaches the age of 65. Benefit payments from the Plan will be made in a lump sum distribution if the balance is less than \$5,000 and the participant does not direct the Plan otherwise.

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted from a participant's account under certain circumstances. All hardship withdrawals must comply with IRC rules relating to hardships, which are uniformly applicable to all participants.

### **Notes Receivable from Participants**

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless they are used to purchase a primary residence, in which case repayment may be made over a reasonable period of time that may exceed five years up to a maximum of thirty years. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate at the date of the loan application and remained fixed for the duration of the loan. Principal and interest are paid ratably through payroll deductions.

### **Excess Contribution Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions prior to March 15, 2024.

### **Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participant accounts would become fully vested.

## 1. DESCRIPTION OF PLAN (Continued)

### **Forfeitures**

Forfeitures of non-vested account balances are used to reduce company contributions or pay Plan expenses. Forfeited non-vested accounts totaled \$802 and \$473 at December 31, 2024 and 2023, respectively. Forfeitures used to reduce company-matching contributions or pay administrative expenses totaled \$465 for the year ended December 31, 2024. There were no forfeitures used to reduce company-matching contributions or pay administrative expenses for the year ended December 31, 2023.

### **Administrative Expenses**

The Plan pays most of the significant administrative expenses associated with the administration of the Plan. Certain administrative expenses are paid by the plan sponsor. The Plan permits the payment of Plan expenses to be made from the Plan's assets. The expenses are generally allocated among the accounts of all participants in the Plan proportionately based on the value of individual account balances.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

### **Investments**

Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisors and qualified institutions.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### **Fair Value Measurements - Definition and Hierarchy**

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurements - Definition and Hierarchy (Continued)

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement

### Benefit Payments

Benefits are recorded when paid.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based on the terms of the Plan document.

### Risks and Uncertainties

The Plan invests in various investment securities. Investments are exposed to various risks, such as interest rate, currency, market, and credit risk. Due to the level of risk associated with investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the near would materially affect participants' account balances and the amounts reported in the financial statements.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes thereon, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## 3. CERTIFIED INVESTMENT INFORMATION

In accordance with Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the following information was certified as complete and accurate by Reliance, the trustee and custodian of the Plan, as of and for the years ended December 31, 2024 and 2023, respectively, and is included in the accompanying financial statements and supplemental schedule:

*Mutual funds:* Valued at fair value, based on quoted market prices.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Reliance is trustee of the Plan and the custodian of the Plan's assets. As such, transactions involving Reliance and the Plan qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions.

#### 6. INCOME TAX STATUS

The Plan uses a pre-approved plan document developed by ADP, LLC. The IRS has determined and informed ADP, LLC, by letter dated October 6, 2020, that the written form of the underlying pre-approved plan document is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The plan administrator and the Plan's tax counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## 7. RECONCILIATION TO FORM 5500
