Independent Auditor's Report

To the Investment Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of North Valley Endodontics P.A. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Plan Description

The following description of the North Valley Endodontics P.A. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan originally effective February 1, 2010. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective June 1, 2022. The Plan excludes non-resident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility:

The Plan is a defined contribution plan covering all qualified employees of North Valley Endodontics P.A. (the Plan Sponsor) and An Elegant Smile PC. These companies are related entities and are collectively referred to as "the Company". Employees are eligible to participate in the deferral component of the Plan when they attain 21 years of age and after completing two consecutive months of eligible service beginning on the employee's date of hire. Plan entry dates are the first day of the quarter following satisfaction of eligibility requirements. Participants are eligible for discretionary employer matching and discretionary employer non-elective contributions if they meet the eligibility requirements and complete at least 1,000 hours of service during the 12-month service period. Participants must also be employed on the last day of the plan year to be eligible for employer matching contributions; there is no active employment requirement to be eligible for employer non-elective contributions.

Contributions:

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have up to 90% of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, increasing automatically by 1% each year to a maximum of 12%. The automatic increase becomes effective in the second plan year following the year in which the automatic deferral election first becomes effective. Contributions are invested in the designated default fund until changed by the participant. Participants who are age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company may elect to make a discretionary matching or non-elective contribution, as determined and authorized by the Company. There were no discretionary matching or non-elective contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts:

Each participant's account is credited with the participant's contribution, any Company contributions, and an allocation of Plan earnings or losses based on their investment allocation. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the balance of the participant's vested account.

Note 1 – Plan Description (Continued)

Vesting:

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and non-elective contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 20% vested after two years of credited service with an additional 20% vesting per year until the participant is 100% vested after six years of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the balance in the participant's account and bear an interest rate equal to the Prime Rate (7.50% at December 31, 2024) in effect as of the 14th of the month plus 1%. Notes must be repaid over a period not to exceed five years, and an extended repayment period of up to 30 years is permitted if the note is for the purchase of the participant's principal residence. Participants may have a maximum of one note outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name without the participant's consent.

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding deduction to participant contributions. Amounts owed as of December 31, 2024, were refunded to participants in February 2025.

Forfeited accounts:

Forfeitures of non-vested accounts may be used to reduce discretionary employer contributions, restore previously forfeited balances, or pay plan expenses. Forfeited non-vested accounts as of December 31, 2024 and 2023 totaled \$15,606 and \$1,093, respectively. During the year ended December 31, 2024, no forfeitures were used to pay plan expenses. \$10,409 of forfeitures were used to restore previously forfeited balances subsequent to year end.

Note 2 – Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies follows:

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 – Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee and investment advisors. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contribution receivables:

Contributions from participants and any related matching contribution are recorded in the year when the contributions from participants are withheld from compensation.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Administrative expenses for the year ended December 31, 2024 consisted of recordkeeper, third-party administrator, investment advisor, and plan audit fees. In addition, certain expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

Subsequent events:

Plan management has evaluated subsequent events through August 28, 2025, which is the date the financial statements were available to be issued.

Note 3 – Information Certified and Provided by the Trustee

Reliance Trust Company, the trustee of the Plan, has supplied the plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4 – Fair Value Measurement

Fair value measurements are based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust: A collective fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to this investment.

Note 5 – Party-in-Interest Transactions

Reliance Trust Company is the trustee, ADP Retirement Services is the recordkeeper, Pentegra Services, Inc. is the third-party administrator, and Buckman & Corning Financial Strategies Group dba Pathlight Advisors is the investment advisor of the Plan. Administrative expenses of \$48,595 were paid by the Plan for asset-based trustee and recordkeeping services, third party administrative fees, and investment management fees for the year ended December 31, 2024. Additionally, indirect fees are paid to ADP Retirement Services and Pathlight Advisors based on investment account values. These fees range from 0.02% to 0.92% of the investment account value. The fees decrease net appreciation in fair value of investments on the statement of changes in net assets available for benefits. Some fees charged for the above services are paid by the Plan and allocated to participant accounts, while others are paid through revenue sharing and allocated to participants. These transactions are party-in-interest transactions under ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of complete or partial termination of the Plan, participants would become 100% vested in their accounts.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 – Tax Status

The Plan Sponsor has adopted a pre-approved plan provided by ADP, LLC (ADP). ADP obtained an opinion letter dated October 6, 2020, from the IRS pursuant to a requirement to restate pre-approved plan documents every six years in order to maintain the Plan’s tax-qualified status. As a result, effective June 1, 2022, the Plan Sponsor restated the Plan to reflect remedial amendments associated with ADP’s restatement of its pre-approved plan. There were no material changes to plan provisions as a result of this restatement.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
