1. Plan Description

General

The following description of the MFXchange US, Inc. Employee Retirement Plan (the “Plan”) provides only general information. The participants should refer to the Plan document for a more complete description of the Plan’s terms and provisions. The Plan is sponsored and administered by MFXchange US, Inc. (the “Company” and “Plan administrator”).

Eligibility

The Plan is a defined contribution plan established by the Company as of January 1, 2008. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). All employees of the Company are eligible for participation in the Plan if they were an active employee in the predecessor plan, the Individual Retirement Plan of the United States Fire Insurance Company and maintained employment with the Company as of January 1, 2008. Employees hired subsequently become eligible the first of the month following the month of hire.

Contributions

Each Plan year, participants may elect to make voluntary contributions up to 50% of eligible compensation as defined in the Plan document subject to certain IRS statutory limitations. The participant may elect to roll over contributions which were received from another qualified Plan. Participants 50 years of age or older may make an additional pre-tax catch-up contribution subject to IRS limitations.

The Company provides an employer matching contribution, which matches 50% of the participant contribution up to 6% of eligible earnings. Employer contributions are made after each payroll cycle. On an annual basis, the Company may, at its discretion, fund an additional contribution to participants based on a uniform percentage of compensation. To be eligible for the additional discretionary contribution, employees must be employed on the last day of the Plan year or have terminated during the year due to retirement, death or disability. For the year ended December 31, 2024, the Company made matching contributions of \$102,897, true up contributions of \$7,751, and discretionary contributions of \$169,557. For the year ended December 31, 2023, the Company made matching contributions of \$105,165, true up contributions of \$5,349, and discretionary contributions of \$181,995.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer matching and discretionary contributions are based on years of service. A participant is vested at the rate of 20% for each year of credited service, as defined by the Plan document, and fully vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Interest rates are charged at the prime rate as published by the Wall Street Journal, plus 1%. Principal and interest are paid ratably through payroll deductions. Only one loan per participant may be outstanding at any time.

Payment of Benefits

Participants may withdraw all or a portion of their vested balance upon termination of employment, attaining age 59½, disability, retirement or death. In-service distributions are allowed for unusual financial hardships as defined by the Plan. Distributions are paid directly to the participant or can be rolled over to an eligible retirement plan or to an individual retirement account.

Forfeitures

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27,222 and \$30,407, respectively. These accounts will be used to reduce future employer contributions and/or plan expenses. In 2024, funds from forfeited accounts were used to reduce employer contributions and Plan expenses by \$18,969 and \$12,125, respectively. In 2023, funds from forfeited accounts were used to reduce employer contributions by \$17,466.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets and liabilities, revenues and expenses and changes therein, and disclosures of contingent assets and contingent liabilities and accompanying notes. It is reasonably possible that the Plan's estimates may change in the near term.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan's administrator has reviewed subsequent events and transactions that occurred after December 31, 2024 through the date of the independent auditors' report and the date the financial statements were available to be issued, August 6, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles. Management has determined that there are no unrecognized subsequent events that require additional disclosure.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's investments include a common collective trust fund, Capital Preservation Fund, with Federated Investors, Inc. ("Federated Investors"). The fund invests primarily in stable value products, such as traditional guaranteed investment contracts ("GIC"), separate account GICs and synthetic GICs to maintain a stable value of \$10 per unit. The investment's objective is to maintain the stability of the principal while providing high current income.

The crediting interest rate is based on an agreed-upon formula with the issuer but cannot be less than zero. Such interest rates are reviewed on a monthly or quarterly basis for resetting. In addition, participant withdrawals and transfers from the fund are paid at contract value but may be funded through the fair value liquidation of the underlying fixed-income securities, which could impact the interest crediting rate.

Certain circumstances could limit a participant's ability to interact with the common collective trust investment at contract value. These circumstances may include, but are not limited to, the following: mergers, mass layoffs, plan terminations, implementation of early retirement incentive programs or other events within the control of the fund or the plan sponsor resulting in a material and adverse financial impact on the issuers of the underlying GIC investments. Such circumstances are not deemed probable. There are also limited circumstances that would allow the issuer of the underlying GIC investments to terminate the contract at other than contract value including the fund's loss of qualified status, termination of the fund or a failure of the Trustee to meet its material obligations under the contract. These circumstances are also deemed not probable.

5. Party-in-Interest Transactions

Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as exempt party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

The Internal Revenue Service has determined by letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Company believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations at any time within certain statutorily defined periods.

8. Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
