

NOTE 1 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of Bridor USA Inc. 401 (K) Plan (the “Plan”) are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

Date of Management’s Review of Subsequent Events

Subsequent events were evaluated through August 25, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market for the asset or liability. See Note 4 for the fair value measurement disclosures associated with the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. The Statement of Changes in Net Assets Available for Benefits presents the net appreciation (depreciation) in the fair value of investments, reflecting the realized gains and losses and the unrealized appreciation (depreciation) of those investments during the year presented.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or by Bridor USA Inc (the “Company”) as provided in the Plan document. Certain expenses of maintaining the Plan that are paid by the Company are excluded from these financial statements. Record keeping expenses paid to ADP are paid for by the Plan and those expenses are included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 1 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Excess Contributions Payable

Amounts payable to participants totaling \$52,417 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction in 2024 contributions. The Plan distributed the 2024 excess contributions prior to March 15, 2025. Excess contributions payable as of December 31, 2023 was \$22,302.

NOTE 2 – DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Bridor USA Inc. and any participating Affiliates, if applicable, except employees covered by a collective bargaining agreement with the employer. The employees can begin participating in the Plan if they are at least age 21 and have completed 6 months of service. Employees will receive credit for one month of service for each month in which they complete one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Tax-Deferred Participant Contributions

Each active participant may elect to make tax-deferred contributions, which can range from 1% to 90% (in whole percentages) of a participant’s pre-tax compensation in each payroll period. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common trust fund as investment options for participants.

Catch-up Contributions

All employees who are eligible to make tax-deferred participant contributions under the Plan and who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of, the Internal Revenue Code.

Employer Basic Contributions

The Company matching contributions equal 100% for each 1% of compensation contributed by the participant on a pre-tax, up to a maximum of 6% of such compensation.

Employer Nonelective Contributions

The Company may decide to make a nonelective contribution to the Plan, although the Company is not required to do so. The nonelective contribution will be allocated to all employees eligible to participate in the Plan. You must be an eligible participant employed by the Company on December 31 to receive this allocation. If employment terminates prior to December 31 due to death, disability, or attainment of age 65 or early retirement of age 59 1/2, the employee will be eligible to receive any nonelective contribution that the Company may make for the year in which employment terminated.

NOTE 2 – DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contribution and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings and account balances, as defined.

Forfeitures arising from terminated participants' unvested accounts are used to reduce employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Each participant directs his or her individual investment in the Plan's fund options.

Vesting

All participants are immediately 100 percent vested in their elective deferral and rollover (if any) contribution accounts.

If not already previously vested, participants become fully vested upon attainment of normal retirement age, death, or their total and permanent disability, whichever is the first to occur.

If participants leave the Company for any other reason, the vesting schedule for matching contributions and nonelective contribution accounts are as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to the lesser of (a) \$50,000, reduced by the highest outstanding loan balance within the past year or (b) 50% of their vested account balance. The term of the loan cannot exceed five years; however, the term may be extended to 30 years if used to purchase a principal residence. Each loan is secured by the balances in the participant's account and bears interest at prime rate as published in The Wall Street Journal on the 14th of each month, plus two percentage points. Loan principal and interest payments are repaid through payroll deductions. The interest paid on the loan is credited to the participant's account. Interest rates on current loans range from 5.25% to 10.50%. As of December 31, 2024 and 2023, the Plan had outstanding notes receivable from participants with principal balances totaling \$134,898 and \$75,360, respectively.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant is eligible to receive their entire vested account balance in a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

NOTE 2 – DESCRIPTION OF PLAN (Continued)

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$368 and \$175, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$6,050 from forfeited non-vested accounts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their employer contributions.

NOTE 3 – CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, as obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quote prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented, and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

The fair value of investments in common collective trust funds are valued at their respective net asset value per share/unit on the valuation date.

The Plan’s policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers in and out of Level 3.

NOTE 6 – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan administrators to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
