## INDEPENDENT AUDITORS' REPORT

To the 401(k) Committee of Thelen, Inc. 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Thelen, Inc. 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

### ***Opinion***

NOTES TO FINANCIAL STATEMENTS

**NOTE A - Description of Plan:**

The following brief description of the Thelen, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering substantially all employees, excluding union employees, nonresident aliens, and shuttle drivers, of Thelen, Inc. ("the Company"), who have six months of service and are age twenty-one or older. The entry dates are the first day of the month coinciding with or next following the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is provided as a pre-approved plan by ADP, LLC.
2. Contributions - Each year, participants may contribute up to 90% of their annual compensation, as defined in the Plan, as a pre-tax or Roth elective deferral contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 28 mutual funds and a collective investment trust as investment options for participants. The Plan provides for an automatic deferral of 2% of compensation for all eligible participants who have not made a Salary Deferral election that is at least equal to the automatic deferral amount above. The Plan provides for a fixed employer matching contribution equal to 100% of the first 2% of participant elective deferrals. The Plan also allows for discretionary nonelective contributions to be made. The Company did not elect to make discretionary nonelective contributions for the year ended December 31, 2024. Segregated accounts are maintained for each participant. The participant directs the investment of those amounts among the selection of funds offered by ADP, LLC. Contributions are subject to certain limitations.
3. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the portion of their accounts funded by employer matching and nonelective contributions plus earnings thereon is based on years of continuous service according to the following schedule:

5. Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants who have reached age 59<sup>1/2</sup> may elect to take in-service withdrawals. The Plan also permits withdrawals of active participants' account balances only in amounts necessary to satisfy financial hardships as defined by the Plan.

**NOTE A - Description of Plan (continued):**

6. Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23 and \$339, respectively. These accounts will be used to reduce future employer contributions and pay plan fees. Also, in 2024, employer contributions were reduced by \$9,558 from forfeited nonvested accounts.

**NOTE B - Summary of Significant Accounting Policies:**

1. Basis of Accounting - The financial statements of the Plan are maintained on the accrual basis.
2. Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Administrative Expenses - Certain administrative expenses of the Plan are paid directly by the Company and are therefore excluded from these financial statements.
4. Uses of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
5. Payment of Benefits - Benefits are recorded when paid.
6. Subsequent Events - Subsequent events were evaluated through August 22, 2025, which is the date the financial statements were available to be issued.

**NOTE C - Fair Value Measurements:**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE C - Fair Value Measurements (continued):**

Stable Value Collective Investment Trust: Valued at the NAC of shares in the account held by the Plan. NAV is based on the contract value for the stable value collective investment trust ("CIT"). Investments held by a CIT are required to be reported at fair value, however, contract value is the relevant measurement characteristic for that portion of the net assets of a CIT. The NAC of the CIT is not publicly quoted but is the basis for current transactions. The CIT can be redeemed at NAV as of the measurement date and has a readily determinable fair value.

The preceding methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE E - Tax Status:**

The Internal Revenue Service has determined and informed the third-party administrator, ADP, LLC in an opinion letter dated October 6, 2020, that the pre-approved Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE F - Information Certified by Trustees:**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and December 31, 2023 and the Supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**NOTE G - Party-In-Interest/Related-Party Transactions:**

Certain Plan investments included in the investment contract are managed by Reliance Trust Company. Reliance Trust Company is the custodian/trustee as defined by the Plan. ADP, Inc. is the Plan's third-party administrator/recordkeeper. Merrill Lynch, Pierce, Fenner & Smith, Inc. is the investment advisor as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, fees paid by the Plan for the administrative services amount to \$15,952 and fees paid by the Plan for investment advisory services amount to \$23,955.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE H - Risks and Uncertainties:**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
