### **Opinion**

NOTE 1 DESCRIPTION OF PLAN

The following description of the Flexaseal Engineered Seals and Systems, LLC 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan, established on January 1, 1989, the effective date of the Plan is sponsored and administered by Flexaseal Engineered Seals and Systems, LLC, which has sole authority to amend or terminate the Plan.

General

The Plan is a defined contribution plan, covering employees of the Company who have completed six months of service and have attained at least age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100 percent of pretax annual compensation, up to annual IRS limits (\$23,000 and \$22,500 for 2024 and 2023 respectfully). Participants over age 55 may make additional catch-up contributions. The plan also accepts rollover contributions from other qualified plans from eligible participants. Employee contributions are submitted to the trustee bi-weekly.

Matching

The Employer may make a discretionary matching contribution equal to a uniform percentage or dollar amount of your elective deferrals. Discretionary matching contributions were \$443,183 and \$379,309 during the years ended 2024 and 2023, respectively. Employer contributions are submitted to the trustee annually on the due date.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25%-8.5%. Principal and interest are paid ratably through bi-weekly payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified distributions based on the terms of the plan document.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer safe harbor matching contributions are vested from 20% after two years of service to 100% after six years of service.

Forfeitures

Forfeitures can also be used to offset administrative expenses or reduce employer contributions. The amount of forfeitures used to offset administrative expenses and reduce employer contributions in 2024 and 2023 were \$594 and \$0, respectively.

Unallocated Assets

At December 31, 2024 and 2023 the plan had available investment fee credits of \$12 and \$574, respectively. These funds are available to offset future expenses of the plan.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 6 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Adoption of FASB ASU 2016-13 and Related Standards

On January 1, 2023, the Company adopted FASB ASU 2016-03, Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments, as amended, which modifies the measurement of expected credit losses on certain financial instruments. The Company adopted this new guidance utilizing the modified retrospective transition method. The adoption of this Standard did not have a material impact of the company's financial statements but did change how the allowance for doubtful accounts and credit losses is determined.

Allowance for Doubtful Accounts

The plan considers allowance for doubtful accounts to be amounts that would not be collectible by the plan. All participant loans are secured by vested participant balances. Therefore, there is no allowance for doubtful accounts at December 31, 2024, and 2023.

Income Taxes

The IRS has determined and informed the Plan sponsor by a letter dated June 29, 2010, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 3 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan at any time to terminate the Plan subject to the provisions of ERISA.

NOTE 5 RELATED PARTIES AND PARTY IN INTEREST TRANSACTIONS

The employer, Flexaseal Engineered Seals and Systems, LLC, provides administrative services to the plan at no charge.

Capital Bank and Trust Company is the custodian of the plan assets. Capital Bank and Trust Company receives indirect compensation for providing these services and therefore, these transactions qualify as party in interest transactions.

NOTE 6 FAIR VALUE MEASUREMENTS

Fair value measurements establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under are described below:

Basis of Fair Value Measurement

Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly. (market approach).

Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

The following table presents by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023. As required by ASC Topic 820, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.
