## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the SYSTOLIC, Inc. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. DESCRIPTION OF THE PLAN

The following description of the SYSTOLIC, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, which was established on April 1, 2010 by SYSTOLIC, Inc. (the Company). The Plan covers substantially all eligible employees of the Company. The employees may enter the Plan on the first payroll subsequent to their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended effective July 31, 2023 to allow partial withdrawals.

#### Participant Contributions

Participants may contribute up to 84% of their gross compensation, as defined by the Plan, not to exceed the maximum allowable contribution limit under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants may also make Roth elective contributions. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, which totaled \$7,500 for the year ended December 31, 2024, subject to limitations imposed by the Code. Participants are permitted to make rollover contributions to the Plan.

#### Company Contributions

The Company makes safe harbor non-elective contributions to eligible participants on a per-payroll basis. Safe harbor non-elective contributions are equal to 6% of eligible gross compensation. The Company's safe harbor non-elective contributions totaled \$3,634,651 for the year ended December 31, 2024.

The Company may also make additional discretionary profit-sharing contributions to the Plan. Discretionary profit-sharing contributions, if made, are made on a per-payroll basis. During the year ended December 31, 2024, the Company made discretionary profit-sharing contributions totaling \$3,345,143.

#### Participant Accounts

Each participant's account is participant-directed and is credited with participant contributions and Company contributions, in accordance with the investment options selected by the participant. Any earnings, losses, and administrative expenses are allocated to participant accounts based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account balance.

#### Vesting

Participants are immediately vested in their contributions and Company contributions plus earnings thereon.

### 1. DESCRIPTION OF THE PLAN - cont'd.

#### Payment of Benefits

Upon termination of service due to death, disability, normal retirement age, or attainment of age 65 or early retirement at age 59½, a participant or his or her beneficiary, in the event of death, is entitled to a distribution of their vested account balance. Distributions from the Plan are payable in the form of a lump sum or installment payments equal to the value of the participant's vested interest in his or her account. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59½. Distributions are subject to the applicable provisions of the Plan agreement. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions as of year-end.

#### Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance not to exceed \$50,000. The minimum note amount is \$1,000. The notes are collateralized by the participant's vested account balance. The period of repayment may not exceed five years, or ten years for the purchase of a primary residence. All notes bear interest at rates comparable to those offered by financial institutions at the time of note origination, as determined by the Plan Sponsor. Principal and interest is paid ratably through payroll deductions. Certain loans initiated under plans that merged into the SYSTOLIC, Inc. 401(k) Plan have a longer repayment period in accordance with the loan provisions in effect at the time of origination.

#### Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid by the Trustee with net assets of the Plan unless paid by the Company, at its discretion. Administrative expenses totaling \$169,412 were paid directly from the Plan for the year ended December 31, 2024.

Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and changes therein at the date of the financial statements and reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

#### Fair Value Measurement

Accounting Standards Codification, *Fair Value Measurement* (ASC 820), defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Fair Value Measurement – cont'd.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interest-bearing cash:* Valued at amortized cost, which approximates fair value.

*Interests in registered investment companies:* Valued at the closing price reported on the active market on which the funds are traded.

*Interests in self-directed brokerage accounts:* Valued at the closing price of shares held by the Plan at year end. Funds are traded on the active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through July 22, 2025, the date the financial statements were available to be issued, and noted no material subsequent events that warrant disclosure.

### 3. INVESTMENTS

All investment information contained in the accompany financial statements and supplemental schedule, including assets held as of December 31, 2024 and 2023, and interest and dividend income and net realized and unrealized appreciation in the fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by an affiliate of the Trustee of the Plan. The Plan allows for participants to take loans against their vested account balances. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 6. INCOME TAX STATUS

The non-standardized pre-approved profit sharing plan document, upon which the Plan was designed, received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan was amended subsequent to receiving the opinion letter; however, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### 6. INCOME TAX STATUS – cont'd.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, these provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits in progress for any open periods.
