Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

A. Description of Plan

The following description of the Beyer Services 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan sponsored by Beyer Services, LLC (the Plan Sponsor). The Plan Sponsor is a member of a controlled group, which includes the following participating employers (collectively, the Company or Employer):

The Plan covers substantially all employees of the Company other than union, leased, and non-resident alien employees who are 19 years of age or older and have completed one year of service (and 1,000 service hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

2. *Contributions.* Each year, participants may contribute up to 100% of pretax and after-tax annual compensation, as defined in the Plan, or the annual limit defined by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions of 100% of the first 4% of participant deferred compensation. The Company may also make discretionary matching and profit sharing contributions, although this was not elected for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

3. *Participant accounts.* Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. *Vesting.* Participants are vested immediately in their contributions, any Company contributions, and actual earnings thereon. Participants who terminated prior to September 1, 2021 are subject to other vesting terms, as defined in the Plan agreement.
5. *Notes receivable from participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest. A participant is permitted no more than one loan outstanding at any time. Principal and interest is paid ratably through weekly payroll deductions.
6. *Payment of benefits.* On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. For distributions of amounts of \$7,000 or less, no participant consent is required.
7. *Forfeited accounts.* These accounts will be used to reduce future Company contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,472 and \$1, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions or pay Plan expenses.

B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.
5. *Payment of benefits.* Benefits are recorded when paid.
6. *Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees related to withdrawals are included with benefits paid to participants in the statement of changes in net assets available for benefits. Recordkeeping and investment advisory fees are charged directly to administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.
7. *Reclassifications.* Certain prior year amounts have been reclassified for consistency with the current year presentation. These reclassifications had no effect on the reported net assets available for benefits.
8. *Subsequent events.* The Plan has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan adopted super catch-up provisions under SECURE 2.0.

C. Certified Investments

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations under ERISA. Accordingly, the Plan trustee, Charles Schwab Trust Bank, has certified that the following data included in the Plan's financial statements and supplemental schedule is complete and accurate.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">▪ quoted prices for similar assets or liabilities in active markets;▪ quoted prices for identical or similar assets or liabilities in inactive markets;▪ inputs other than quoted prices that are observable for the asset or liability;▪ inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported on the active market on which the individual fund is traded.

Cash equivalent: Balance in deposit account approximates fair value.

E. Party in Interest Transactions

Certain investments are managed by the trustee of the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan also paid fees to parties in interest for recordkeeping and administration for the year ended December 31, 2024.

F. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

G. Tax Status

The Plan adopted a non-standardized defined contribution plan that has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
