INDEPENDENT AUDITORS' REPORT

To the Trustees and Management of the
Precision Roll Grinders Savings & Investment Plan
Allentown, PA

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Precision Roll Grinders Savings & Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Precision Roll Grinders Savings & Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Precision Roll Grinders Savings & Investment Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Precision Roll Grinders Savings & Investment Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note A

Description of Plan

The following description of the Precision Roll Grinders Savings & Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established by Precision Roll Grinders, Inc. (“Company”) under an adoption agreement dated December 23, 1987, effective retroactive to September 1, 1987. The Plan was amended and restated to comply with the IRS Cycle 3 Restatement effective January 1, 2022. The plan provisions cover substantially all full-time employees of the Company, except union employees, leased employees, residents of Puerto Rico, and temporary/seasonal employees (as described in the Plan document). There is no age or service requirement for elective deferrals. To be eligible for the Company discretionary nonelective contributions, participants must complete 1,000 hours of service in a six month period and be employed on the last day of the year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee and Trustees are responsible for the administration of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

On April 1, 2022, Empower Annuity Insurance Company of America (fka Great-West Life & Annuity Insurance Company) acquired the full-service retirement business of Prudential Financial, Inc. As of April 1, 2022, all of Prudential’s full service retirement operations and programs became part of Empower Retirement, LLC (“Empower” or the “Trustee”) a wholly-owned subsidiary of Empower Annuity Insurance Company of America. Empower is a fiduciary of the Plan and also serves as the record keeper to maintain the individual accounts of each Plan participant.

Plan Amendments

Effective January 1, 2024, the Plan was formally amended, as follows:

- to change the compensation amount that will be excluded for Nonelective Contributions from exceeding \$120,000 to exceeding the amount approved by the board of directors.
- to exclude other adjustments (e.g., commissions, bonuses, etc.): "special awards" from compensation for all Contributions types.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, not to exceed the dollar limit set by the Internal Revenue Code annually. Roth contributions are also permitted. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Effective January 1, 2014, participants that make affirmative elections, or who will be automatically enrolled in the Plan, shall have their initial pre-tax elective deferral rate at three percent, and will be increased by two percent of compensation per year and each January 1st thereafter (up to a maximum of 10 percent), unless a participant makes a contrary election. Automatic contributions are deposited into a default investment, as selected by the Plan, until the participant changes their investment option.

The Company may make discretionary nonelective contributions to the Plan based on years of service at the option of its board of directors. The Company elected to make discretionary nonelective contributions in the amount of \$357,065 to the Plan for 2024, which was calculated as follows: (i) participants with nine (9) years of service or less will receive a 3 percent contribution, (ii) participants with ten (10) to nineteen (19) years of service will receive a 4 percent contribution and (iii) participants with twenty (20) or more years of service will receive a 5 percent contribution. The contribution is based on eligible plan compensation subject to Internal Revenue Code ("IRC") limitations.

Participants direct the investments of their contributions as well as Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations prescribed by the Internal Revenue Code.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company nonelective contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes 100% vested in Company contributions after three years of credited service. In addition, if a participant is over the age of 55, the participant becomes automatically 100 percent vested in Company contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate, as stated in the Wall Street Journal, plus 1 percent. Principal and interest are paid ratably through payroll deductions, and must be repaid within 5 years. If the loan is taken for the purchase of a primary residence, the loan must then be repaid within 10 years.

Payment of Benefits

Benefits are payable upon retirement at age 65, or early retirement at age 55. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, installment or partial payments.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,249 and \$731, respectively. These forfeitures will be used in the future in the following sequence: (1) to offset the Plan's administrative costs, (2) any remaining amounts shall be used to reduce future employer contributions. For the year ended December 31, 2024, no forfeitures were used.

Note B

Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and other third-party service providers. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the exdividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Summary of Significant Accounting Policies (Continued)

Contributions

Participant contributions are recognized in the period the participant contribution is withheld from compensation. Company discretionary nonelective contributions are recognized in the period the related eligible compensation is paid to the participant.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain administrative and advisory fees are paid by the Plan and included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

Note C

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the mutual fund. The mutual funds are registered with the SEC and are required to publish their daily net asset value ("NAV") and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at their NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note D

Guaranteed Investment Contract

The Plan is invested in a fully-benefit-responsive guaranteed investment contract (“Guaranteed Income Fund”) with Empower Annuity Insurance Company (formerly Prudential Retirement Insurance and Annuity Company) (“Issuer”), an affiliate of the trustee. The amounts invested, as of December 31, 2024 and 2023, were \$2,257,200 and \$2,906,446, respectively. The Issuer maintains contributions in its general account with no maturity date. The account is credited with earnings and charged for participant withdrawals and administrative expenses.

The contract meets the criteria for a fully benefit-responsive investment contract and, accordingly, is reported at contract value. Contract value is the relevant measure because it represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by the Issuer, represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due under the contract is dependent on the Issuer’s ability to meet its financial obligations. The Issuer’s financial condition may be affected by future economic and regulatory developments. Generally, there are no conditions that would limit the Plan’s ability to transact at contract value, except in certain circumstances where transfers, distributions, or termination disbursements from the contract may be deferred or paid over time if specific thresholds are exceeded, as described in the investment contract. However, routine participant-directed transactions, such as withdrawals for benefits, loans, or required minimum distributions, continue to be permitted at contract value. There are no events or conditions that would allow the Issuer to terminate the contract and settle at other than contract value.

Note E

Related-Party and Party-In-Interest Transactions

Certain Plan investments are managed by affiliates of Empower Annuity Insurance Company and Empower Trust Company, LLC (collectively "Empower"). Empower is the trustee, record-keeper and custodian of the Plan's assets. The Company utilizes CapFinancial Partners LLC as the investment advisors of the Plan. Empower and CapFinancial Partners LLC together provide the Plan with certain administrative services and, therefore, the purchases and sales of these investments and resulting balances qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

During the year ended December 31, 2024, the Company failed to remit to the Plan's trustee certain participant contributions totaling \$87 within the period prescribed by Department of Labor regulations. Consequently, the Plan is considered to have engaged in non-exempt transactions with a party-in-interest. The Company is required to rectify the matter by paying lost earnings on the participant contributions that were remitted late. The Company deposited the lost earnings in April 2025.

Note F

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note G

Tax Status

On December 4, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized profit-sharing plan with CODA adopted by the Plan, as then designated, qualifies under Section 401(a) of the IRC. The Plan administrator timely adopted the approved Plan. The Plan administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain positions that more likely than not would not be sustained upon examination by the tax authorities. The Plan's management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however there are currently no audits for any tax periods in progress.

Note H

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note I

Certification by Trustees

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, the trustees of the Plan.
