Note 1 - Description of Plan

The following description of the Cooper Companies Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a combined defined contribution plan covering all full-time employees of the Cooper Hatchery, Inc. (the “Company”) who have one year of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the governance of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

Contributions - Participants may make contributions through the salary deferral provisions of the 401(k) portion of the Plan subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan has an automatic four percent deferral for all eligible employees unless they proactively opt out. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a fixed annuity contract as investment options for participants. Participants may change their investment options anytime. Each year, the Company contributes to the Plan solely at the option of the Company’s Board of Directors. In 2024 and 2023, the Company made a contribution of 100% of employee withholding up to 4%. Additional profit-sharing amounts may be contributed at the option of the Board of Directors of the Company. Participants may share in the Company match and additional profit-sharing amounts provided they meet certain requirements defined in the Company’s Plan. Contributions are subject to certain statutory limitations.

Participant Accounts - Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s matching contribution and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as follows:

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installments.

Distribution Prior to Termination - In-service withdrawals are subject to varying rules depending on the source of the funds in the participant's account. Participants may withdraw all or part of their deferral contributions account and qualified non-elective contributions account provided they have attained age 59½. Participants may take hardship distributions from their vested account balances. These distributions would be subject to potential penalties and taxation. Participants are advised to consult a tax advisor for the most recent tax laws.

Death Benefits - Upon the death of a participant, the vested portion of the account becomes available for distribution to the participant's beneficiaries.

Forfeited Accounts - Forfeited amounts attributable to the Company matching portion of a participant's account will be applied to reduce the Company contribution for the Plan year in which such forfeitures occur. Forfeited amounts attributable to the Company discretionary portion of a participant's account will be reallocated to all participants based on compensation, as defined. At December 31, 2024 and 2023, forfeited amounts used during the year totaled \$138,629 and \$80,049, respectively. At December 31, 2024 and 2023, amounts of non-vested accounts forfeited during the year totaled \$240,323 and \$137,142, respectively. The balances are reviewed and typically redistributed annually, subject to the discretion of the plan administrator.

Note 2 - Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting - The Plan prepares its financial statements on the accrual basis. Unrealized gains and losses on the Plan's assets are reported even though no sales of such assets actually took place.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. There is no significant change to prior year estimates for the current year.

Contributions - Contributions to the Plan are accrued, if necessary, to the year to which they apply. The Plan evaluates contribution receivables based on risk characteristics, such as historical losses, current economic conditions and on a case-by-case basis. The Plan provides for probable uncollectible contributions through a provision for bad debts and an adjustment to a valuation allowance based on its assessment of the status of the receivables. Balances that are still outstanding after the Plan has made a reasonable collection effort are written off through a charge to the valuation allocation and a credit to the contribution receivable. The allowance for credit losses for the years ended December 31, 2024 and 2023 was \$0 and \$0, respectively.

Note 2 - Summary of Significant Accounting Policies (cont.)

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 5 for discussion of fair value measurements.

Net appreciation (depreciation) in fair value of investments is reflected in the statements of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold and the change in value from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Information Certified by Custodian - The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Empower Annuity Insurance Company of America ("Empower") that all information relating to the Plan's investments and related investment income is complete and accurate. Information as to the value of the investments in the trust fund managed by the custodian, investment income (loss), and all information in the supplemental schedule is presented in reliance solely upon those certifications.

Note 3 - Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 4 - Certified Investments

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower (the Custodian of the Plan). Investments included in the Plan's Net Assets Available for Plan Benefits at December 31, 2024 and 2023, were \$128,677,568 and \$114,773,412, respectively.

The Plan's investments, including gains and losses on investments bought and sold, as well as the change in value for those investments held during the year, appreciated in value by \$9,072,952 and \$12,590,773 for the years ended December 31, 2024 and 2023, respectively. Interest and dividends on all investments totaled \$4,707,259 and \$3,139,417 for the years ended December 31, 2024 and 2023, respectively.

Note 5 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which level 1 inputs were not available. There are no plan assets requiring the use of level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements - The fair value of mutual funds is based on quoted prices in active markets such as the National Securities Clearing Corporation or secondary pricing sources such as Interactive Data Corporation.

Level 2 Fair Value Measurements - The fair value of fixed annuities is based on daily reported values calculated by the annuity provider in accordance with the applicable annuity contracts.

Note 6 - Party-In-Interest

All Plan assets are managed by Empower. Empower is the Plan's directed custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan pays for the recordkeeping services and audit fees. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7 - Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated August 25, 1996, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7 - Income Tax Status (cont.)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Subsequent Events

Management has evaluated subsequent events through August 14, 2025, the date on which the financial statements were available to be issued. There are no subsequent events to disclose.
