We have performed an audit of the financial statements of the Dermatology Consultants of St. Paul Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1: PLAN DESCRIPTION

The following description of the Dermatology Consultants of St. Paul Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all nonunion employees of Dermatology Consultants, P.A. (the Company). Employees are eligible to participate regardless of age or length of service. Plan entry dates are the first day of each month. The Plan was established on June 27, 1972, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 90% of pretax annual compensation, as defined in the Plan and may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and post-tax ROTH contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 3% of eligible compensation and those contributions are invested in a designated fund until changed by the participant. Those participants with a deferral rate greater than zero will also have their deferral increased annually by 1% until a deferral rate of 8% is reached.

The Plan is classified as a safe harbor plan requiring employer contribution of 3% of participant compensation. Additionally, the Plan has a profit-sharing contribution whereby amounts may be contributed at the option of the Company's Board of Directors. The profit-sharing contribution is integrated with participants' social security taxable wage base and is set by the Board of Directors subsequent to the plan year end.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Individually Directed Portfolios

Participants also have the opportunity to invest their contributions in participant-selected mutual funds, interest-bearing cash equivalents, unit investment trusts, common stocks, government obligations, corporate bonds and notes, and other investments through a brokerage account established with the trustee.

Vesting

Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts plus actual earnings thereon is based on years six years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.50%, which is commensurate with the local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service for any reason, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the vested interest in his or her account, substantially equal installments over a fixed period, or may continue their account with the Plan until they become subject to the required minimum distribution rules. The Plan is also subject to certain minimum distribution requirements. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions, subject to Plan provisions. If a participant terminates with a vested balance of less than \$5,000, the amount of their vested balance is required to be removed from the Plan.

Forfeitures

Forfeitures are used to reduce employer contributions and can be used to pay administrative expenses. At December 31, 2024 and 2023, outstanding forfeited non-vested accounts totaling \$37,027 and \$12,113, respectively, were available to reduce future employer contributions. Forfeitures of \$12,165 and \$22,840 were used to reduce employer contributions in 2024 and 2023, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES **(Continued)**

Investment Valuation and Income Recognition

Investments are reported at fair value, and all are participant directed. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment earnings (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued by unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions according to the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net earnings (losses) on investments.

Plan Amendments

During the year ended December 31, 2022, the Plan adopted the provisions of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act). The CARES Act enables a participant who is a qualified individual to obtain a loan for double the normal limits to the lesser of 100% of the vested account balance or \$100,000 reduced by the highest outstanding loan balance within the past twelve months. However, the loan must have been initiated by the close of business on September 22, 2021. The CARES Act also provides special tax treatment for up to \$100,000 in distributions made to qualified individuals on and after January 1, 2022, and before December 31, 2022.

Subsequent Events

The Plan sponsor has evaluated all subsequent events through August 25, 2025, the date the financial statements were available to be issued.

NOTE 4: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Common/collective trust investments generally include shares of common stock and/or fixed income investments whose values are determined on the basis of quoted prices in an active market. The Plan's common/collective investment trust fund investments are valued based on Net Asset Value (NAV) per share or unit as a practical expedient as reported by the fund manager determined using a discounted cash flow or a market approach.

Self-directed brokerage accounts: Accounts primarily consist of cash, mutual funds, exchange-traded funds, and common stocks that are valued on the basis of readily determinable market prices.

The methods described may produce a fair value amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Under the terms of the Fidelity Managed Income Portfolio Fund’s (MIP) Declaration of Trust, withdrawals directed by the Plan sponsor must be preceded by a 12-month written notice to the MIP. As of December 31, 2024, the Plan had not provided the MIP with advance written notice to terminate the Plan’s investments in the MIP.

NOTE 5: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

NOTE 6: TAX STATUS

The Internal Revenue Service has determined and informed Fidelity Management Trust Company by a letter dated June 30, 2020, that the prototype plan document adopted by the Plan is acceptable under appropriate sections of the Internal Revenue Code. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

NOTE 6: TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7: RISKS, CONCENTRATIONS, AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan offers a diversified selection of investments through a portfolio containing a wide variety of investments that fit the particular investment strategy and targeted composition. Of the Plan's total investments, no mutual fund is concentrated for 10% or more. There are 29% concentration in the self-direct brokerage accounts.
