INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Opportune LLP 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Opportune LLP 401(k) Plan (the “Plan”) provides only general information. Users of these financial statements should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan covering all employees of Opportune LLP and related employers (the “Company”). The Plan was adopted and became effective on July 1, 2008 and was most recently amended and restated on November 15, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Plan Recordkeeper and Custodians

Ascensus LLC (the “Recordkeeper”) is the recordkeeper for the Plan, as agent for Ascensus Trust Company and Newport Trust Company, LLC, the custodians for the Plan.

Eligibility

Employees are immediately eligible to participate in the Plan on the date of hire as long as they have attained 21 years of age.

Contributions

The Plan provides for voluntary employee contributions expressed as a percentage of the participant’s eligible pre-tax compensation or a certain dollar amount, as defined. This contribution is not to exceed the limits set by the Internal Revenue Code (“IRC”) which limits the annual amount of salary deferrals that may be made by any participant. Employees who are at least age 50 or will attain age 50 before the end of a calendar year, may elect to defer additional amounts to the Plan as of January 1st of that year.

New employees who are eligible to participate in the Plan are automatically enrolled at a pretax deferral rate of 3% of a participant’s compensation each payroll period unless the participant makes a contrary election.

The Company has the option to make annual discretionary matching and non-elective contributions in an amount to be determined at the Plan year end as determined by the Company. For 2024, the Company matched 25% of the participant’s elective deferrals, up to a maximum of \$10,000 of the participant’s deferrals for the Plan year.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, rollover contributions, if any, the Company’s matching contribution, and Plan earnings/losses. Each participant’s account is charged with an allocation of administrative expenses, if any.

Participants direct the investment of their account balances in any of several investment funds. Participants can change their investment options among the various investment funds either through direct transfers from one fund to another or by changing the percentage of future contributions allocated among the investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting

Participants are 100% vested in their pre-tax contributions and earnings thereon. The Company contributions and earnings thereon vest in accordance with the following:

Forfeitures

Forfeitures of unvested Company matching contributions from terminated participant accounts are used to offset future employer contributions, or to pay expenses of Plan administration, as determined by the Company. For the year ended December 31, 2024, forfeitures totaling \$62,779 and \$35,982 were used to reduce the Company's contributions for the 2024 and 2023 plan years, respectively, which were funded during 2024. In addition, forfeitures of \$34,609 were utilized to pay Plan expenses for the year ended December 31, 2024. As of December 31, 2024 and 2023, forfeitures of \$0 and \$18,559, respectively, were available for use.

Notes Receivable from Participants

Participants are permitted to borrow funds from the balance in their respective accounts subject to a minimum note of \$1,000 and limited to the lesser of 50% of the participant's vested balance or \$50,000. Participant notes bear terms as deemed appropriate by the Plan administrator subject to certain provisions of the Plan and are secured by the participants' account. All notes are amortized over a period not to exceed five years, except for notes used to purchase a primary residence which may be repaid over a longer period.

Benefit Payments

Upon termination of employment or retirement, a participant may elect to receive a lump-sum distribution or payments in equal periodic installments based on the valuation of the participant's account as of the date of termination, death or retirement or defer such benefits until a later date.

If the value of the participant's account balance is less than \$5,000, the payment will be made in cash in a single lump sum. If the participant's account balance is greater than \$1,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accounts of the Plan are maintained and the accompanying financial statements are prepared on the accrual basis of accounting. Benefit payments to participants are recorded upon distribution.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The accounts of the Plan are maintained and the accompanying financial statements are prepared on the accrual basis of accounting. Benefit payments to participants are recorded upon distribution.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions, based upon terms of the Plan Document, upon liquidation of their account balance.

Benefit Payments

Benefits are recorded when paid.

Financial Instruments and Credit Risk

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. Plan participants bear the risk of any investment losses.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation in the fair value of investments held at year-end is determined using the fair value at the beginning of the year or the purchase price if the investment is acquired during the year. The realized gain or loss on the sale of investments is determined using historical cost. Unrealized appreciation or depreciation and realized gains and losses are reported as net appreciation or depreciation in fair value of investments in the statement of changes in net assets available for benefits.

Plan Expenses

All reasonable expenses related to plan administration will be paid from Plan assets, except to the extent the expenses are paid by the Company at its discretion. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments and are not readily determinable.

Subsequent Events

Management has evaluated subsequent events through August 27, 2025, which was the date that the financial statements were available to be issued and has determined that there were no events to be reported.

3. FAIR VALUE MEASUREMENTS

The Plan uses a three-level hierarchy for grouping assets and liabilities, based on the significance of inputs. The hierarchy of fair value measurements is described below:

Level 1 – quoted prices in active markets for identical assets or liabilities;

Level 2 – inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of these assets or liabilities; or

Level 3 – unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan’s investments in a money market fund and mutual funds are valued daily at the net asset value of shares or units held by the Plan based on the quoted market value of the underlying assets. This valuation may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the valuation method is considered appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS

The prototype plan, adopted by the Plan, received its latest favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving its advisory opinion, the plan administrator believes that the Plan is currently designed and is being operated within the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan recognizes in the financial statements the impact of uncertain tax positions taken only if it is more likely than not of being sustained upon examination by the taxing authority based on the technical merits of the position. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST TRANSACTIONS

Notes receivable from participants are managed by Ascensus Trust Company and Newport Trust Company, LLC and, therefore, qualify as party-in-interest transactions, as defined by ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, the net assets would be allocated among the participants of the Plan in accordance with the provisions of the Plan and participants would be 100% vested.
