We have performed audits of the financial statements of Greater Omaha Packing Co., Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Plan Description

---

The following brief description of the Greater Omaha Packing Co., Inc. 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Greater Omaha Packing Co., Inc., Progressive Procurement, Inc., Progressive Protein, LLC, Greater Omaha Express, LLC, Greater Omaha Leasing, LLC, TREX Corporation, Inc., High Country Meats LLC, Omaha, NE Premium Ground Beef, LLC and Stockyards Logistics Company, LLC, (collectively, the Companies).

Employees are eligible to make salary deferral contributions and receive the Companies' safe harbor matching contributions after attaining age 19 and completing 90 days of service. Eligible employees may become participants on the first day of the quarter following the date on which entry requirements were fulfilled.

#### ***Contributions***

The Plan is a "safe harbor 401(k) plan", whereby the Companies make safe harbor matching contributions. The safe harbor matching contributions are made in an amount equal to 100% of salary deferral contributions up to 1%, and 50% of salary deferral contributions between 1% and 6% of the participant's eligible compensation. Participants may contribute up to 100% of pre-tax and designated Roth after-tax annual compensation in connection with the 401(k) provisions of the Plan up to the maximum allowable by law. Participants are automatically enrolled with an initial 3% salary deferral contribution increasing 1% up to a maximum rate of 6% on an annual basis. At any time, a participant may elect not to contribute, may increase or decrease their deferral rate, or may elect out of automatic deferral rate increases. Participants may also contribute amounts representing distributions from other qualified plans. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocation of a) the Companies' safe harbor matching contributions and b) Plan earnings or losses. The Companies' safe harbor matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Principal Trust Company (Principal).

### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. A participant is 100% vested after two years of credited service in safe harbor matching and previous discretionary matching contributions.

### *Notes Receivable from Participants*

Effective May 1, 2024, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are made on a non-discriminatory basis and are secured by the balance in the participant's account. Interest rates are established at current market rates at the time of issuance and range from 8.50% to 9.50% as of December 31, 2024. Principal and interest are paid ratably through monthly payroll deductions.

### *Payment of Benefits*

Upon termination, retirement, disability, or death the participant or beneficiary may elect to receive lump sum, annuity, or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$5,000 (\$7,000, effective May 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants are allowed to take in-service withdrawals upon attainment of age 59.5. Hardship withdrawals are allowed based on certain criteria. Benefits are recorded when paid.

### *Deposits with Insurance Company*

The guaranteed investment contract, which is part of the investment contract with Principal, credits interest daily. The average crediting interest rate during the years ended December 31, 2024 and 2023 was 1.55%. The crediting interest rate is reset upon the maturity of the contract.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement or death, the portion of their Companies' contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce Plan expenses or the Companies' contributions. Any remaining forfeitures will be re-allocated to the participants. During the years ended December 31, 2024 and 2023, \$146 and \$175, respectively, of forfeitures were used to reduce Plan expenses. During the years ended December 31, 2024 and 2023, \$55,775 and \$12,212, respectively, of forfeitures were used to reduce the Companies' contributions. During the years ended December 31, 2024 and 2023, no forfeitures were re-allocated to participant accounts. At December 31, 2024 and 2023, there were \$72,651 and \$55,177, respectively, of forfeited non-vested amounts available.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Other*

Investment management fees and investment related expenses are paid by the Plan and are included in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts and are included in administrative expenses. Audit fees and recordkeeping expenses are paid by the Companies and are excluded from these financial statements.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through August 25, 2025, noting no items requiring disclosure.

### 3. Information Certified by Principal

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Pooled separate accounts are valued at NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements. Participants can redeem the accounts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023. The NAV is the basis for current transactions and the accounts can be redeemed at NAV as of the measurement date.

*Collective Trusts:* Collective trusts are valued at NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meet those requirements. Participants can redeem the trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023. The NAV is the basis for current transactions and the trusts can be redeemed at NAV as of the measurement date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment Contract with Principal

The Plan has entered into an investment contract with Principal. Principal maintains the contributions in pooled separate accounts and a guaranteed investment contract. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Principal.

The pooled separate accounts, as reported to the Plan by Principal, are included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment account. Contract value, as reported to the Plan by Principal, represents contributions made under the account, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 6. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 7. Plan Termination

---

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date.

### 8. Related Party Transactions

---

Plan investments include pooled separate accounts, collective trusts, and a guaranteed investment contract which are managed by Principal. Principal is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.
