- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Notes to Financial Statements

#### Note 1 – Plan Description

The following description of the Keystone Custom Management, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan with a 401(k) provision covering substantially all employees of Keystone Custom Management, LLC and Penn Transfer, LLC, a related entity, (the “Companies”) upon completion of one month of service and having attained the age of 21 years. Employees become participants on the first day of the month following the completion of the eligibility requirements. Employees are automatically enrolled under the provisions of a Qualified Automatic Contribution Arrangement (QACA), unless an election to opt out of the Plan is completed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated in December 2024.

Contributions – Each year, participants may contribute up to the maximum amount allowable under the Internal Revenue Code. Eligible employees that do not affirmatively opt out of the Plan are enrolled under the QACA provisions at 3% of eligible compensation, as defined by the Plan. The initial automatic deferral amount will increase by 1% of compensation on the first day of each Plan year, up to a maximum of 10% of compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. In addition, at the end of the plan year, eligible participants may make catch-up contributions.

The Companies make QACA safe harbor matching contributions equal to the sum of 100% of a participant’s elective deferrals that do not exceed 1% of total compensation, plus 50% of the next 5% of participant’s elective deferrals of the participant’s compensation. The QACA safe harbor matching contribution is applied each payroll period.

Additional profit sharing contributions may be made by the Companies at the discretion of their board of directors. For the years ended December 31, 2024 and 2023, there were no such profit sharing contributions.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Companies’ contribution and (b) plan earnings. Each account is also charged with an allocation of administrative expenses. Allocations are based on participants’ earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Companies’ contribution portion of their accounts is based on years of continuous service. For the Companies’ QACA safe harbor matching contributions, participants are 100% vested upon completion of two years of credited service. For the Companies’ profit sharing contributions, participants are vested based on a six year graded schedule and are 100% vested after six years of credited service.

#### **Note 1 – Plan Description – Continued**

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within five years, unless the proceeds are used to acquire a principal residence. Current maturity dates of the loans range from January 2025 to November 2046. A participant may not have more than two loans outstanding at any time. The loans are secured by the balance in the participant's account and bear interest between 4.50% and 10.50%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits – Upon termination of service, death, disability or retirement, a participant may elect to receive the value of the vested interest in his or her account as a lump sum distribution. Hardship distributions are not permitted in the Plan. In-service distributions are available to participants upon attaining the age of 59 ½. Automatic distributions will be made to terminated participants with vested balances less than \$5,000. If the terminated participant's vested balance exceeds \$5,000 a written request from the participant is required before distribution.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,849 and \$5,738, respectively. These amounts can be used to reduce employer contributions and pay Plan expenses. Forfeitures used to reduce employer contributions totaled \$0 and \$1,399 for the years ended December 31, 2024 and 2023, respectively.

#### **Note 2 – Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The money market fund is valued at the quoted redemption value at year end. Mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold, as well as held during the year.

- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund:* Valued at the quoted redemption price at year end.

*Mutual Funds:* Valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

#### **Note 7 – Party-in-Interest Transactions**

Administrative expenses were paid to the Vanguard Group, Inc. The Vanguard Group, Inc. is the record keeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid to the Vanguard Group, Inc. totaled \$29,044 and \$26,470 for the years ended December 31, 2024 and 2023, respectively.

Additionally, the Plan had several investments managed by the Vanguard Group, Inc. The fair value of these investments totaled \$12,840,832 and \$9,674,888 at December 31, 2024 and 2023, respectively.

The Plan may issue notes receivable to participants that are secured by participant account balances. All of these transactions qualify as party-in-interest transactions.

#### **Note 8 – Income Tax Status**

The Companies adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA which received its latest opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The opinion letter stated that the Plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes has been included in the Plan's financial statements. Required nondiscrimination testing, as applicable, has been completed for the Plan, and any excess deferrals or contributions have been disposed of in accordance with regulations.

#### **Note 8 – Income Tax Status – Continued**

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 – Information Prepared and Certified by Custodian**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC; the custodian.

#### **Note 10 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
