Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Allen Corporation of America, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 7, 2024 and December 31, 2023, and the related statement of changes in net assets available for the period ended June 7, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier ("qualified institution") in accordance with 29 CFR 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 7, 2024 and December 31, 2023, and for the period ended June 7, 2024, stating that the certified investments information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

As discussed in Notes 1 and 6 to the financial statements, the Plan Administrator and Trustee of the Plan terminated the Plan and transferred the assets to a multiemployer plan on June 7, 2024. Plan assets were transferred directly to the multiemployer plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1—Description of the Plan

The following description of the Allen Corporation of America, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Allen Corporation of America, Inc. (the "Company", or "Plan Sponsor", or "Employer") who are at least 21 years old. The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Eligible employees may enter the Plan the first day of the month following or coinciding with the satisfaction of the eligibility requirements. The Plan was established on January 1, 1998 and terminated on June 7, 2024. The Company's management is responsible for oversight of the Plan. The Company's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's trustees.

Effective June 7, 2024, the Company terminated the Plan and transferred all assets from the Plan to an unrelated multiemployer plan. See Note 6.

Participant Contributions – Each year participants may contribute up to 75% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Any newly eligible employee who has not affirmatively elected, or declined, to contribute to the Plan will be automatically enrolled in the Plan with a 6% withholding of pre-tax annual compensation. Participants may direct the investment of contributions on a daily basis into various investment options offered by the Plan.

Employer Contributions – The Plan allows for discretionary matching contributions. Profit sharing amounts may also be contributed at the discretion of the Company. No discretionary matching contributions or profit sharing contributions were made for the period ended June 7, 2024.

Vesting – Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in Employer contributions is based on years of continuous service. A participant is 100% vested after two years of credited service or in the event of death or total and permanent disability.

Forfeitures – Terminating participants forfeit nonvested Plan Sponsor discretionary matching and profit sharing contributions. Forfeitures shall be applied against Plan Sponsor contributions or plan expenses in accordance with specific Plan provisions. At June 7, 2024 and December 31, 2023, there was a balance of \$-0- and \$8,191 in the forfeited nonvested accounts, respectively. Forfeitures of \$8,215 were used during 2024 to offset Plan Sponsor contributions, and forfeitures of \$458 were used during 2024 to offset Plan expenses or transferred on the termination date to the multiemployer plan.

Participant Accounts – Each participant's account is credited with the participant's contributions, the Company's discretionary matching and profit sharing contributions, if any, and Plan earnings and losses, including realized and unrealized gains and losses on investments. Participant accounts are charged with the participant's distributions and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – Participants may direct Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, (the "Custodians" or "Qualified Institutions"), as to the investment of their account balance into various investment options offered by the Plan. Participants may change their investment directions at any time, subject to such restrictions and procedures as established by the recordkeeper, Plan, and Company.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be repaid within five years unless it is for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bore interest at rates ranging from 4.25% to 8.00%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Benefits Paid to Participants – Benefits are payable upon normal retirement date under the Plan or at age 65 if earlier, death, termination of employment, or in certain hardship situations. In the event a participant terminates or retires and the participant's vested account balance is less than \$5,000, the balance will be paid out as a single lump payment. If the vested value of a participant's account exceeds \$5,000, he or she may elect to receive either a lump sum amount, substantially equal payments for a specified term or elect to have the entire distribution paid in a direct rollover to another qualified plan, leave account balance in the Plan, or a combination of the above.

The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw from their account balances while actively employed. These hardship withdrawals are subject to IRC restrictions and penalties.

Administration – Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan administration fees, are charged directly to the participant's account and are included in administrative expenses. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

Note 2—Summary of significant accounting policies

Basis of Presentation – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value, except for fully benefit-responsive investments which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of June 7, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefits Paid to Participants – Benefits paid to participants are recorded when paid.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and these investments are classified within Level 1 of the valuation hierarchy.

Common Collective Trusts ("CCT") – CCTs are public investment vehicles valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. In accordance with Accounting Standards Codification ("ASC") 820-10, these investments have not been classified under the fair value hierarchy.

Pooled Separate Accounts ("PSA") – PSAs are made up of a variety of underlying investments such as equities, preferred stock, bonds, real estate, and mutual funds. These assets are not available in an exchange or an active market; however, NAV is determined based on the fair value of the underlying assets as traded in an exchange or active market. These investments have no redemption restrictions or unfunded commitments as of December 31, 2024 and 2023. In accordance with ASC 820-10, the PSAs have not been classified under the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fixed Income Guaranteed Option – Principal fixed income guaranteed option ("PFIGO") is a single group annuity contract with a fixed rate of interest. PFIGO is a fully benefit-responsive annuity contract issued by Principal Life Insurance Company. The Guaranteed Minimum Interest Rate is 1.00%. Under the terms of the existing contract, the Composite Crediting Rate is currently reset on a semiannual basis and will never be less than the Guaranteed Minimum Interest Rate. Average yield earned by the Plan is calculated by dividing the annualized earnings of all fully benefit-responsive investment contracts by the fair value of all fully benefit-responsive investment contracts. The average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. The interest rate history for the contract is as follows:

December 1, 2022 - May 31, 2023	1.75%
June 1, 2023 – November 30, 2023	1.75%
December 1, 2023 – May 31, 2024	1.55%

The investment is valued at contract value, which is the amount participants would receive if they were to withdraw or transfer funds prior to maturity. This does not include a 5% surrender charge which would be imposed if the Plan decided to terminate this investment contract. Certain events limit the ability of the Plan to transact at contract value with the issuer such as the termination of a Plan's interest or termination of the Plan. The Plan transferred the investment into the multiemployer plan on the balance sheet date as indicated in Note 1 to the financial statements.

Note 3—Information certified by Custodians (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Qualified Institutions, have certified to the completeness and accuracy of the following data included in the accompanying financial statements.

- Investments, at fair value, fully benefit-responsive investment at contract value, as shown in the statements of net assets available for benefits as of June 7, 2024 and December 31, 2023.
- Net appreciation in fair value of investments, and interest and dividends as shown in the statement of changes in net assets available for benefits for the period ended June 7, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of June 7, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year).

Note 6—Plan termination

As discussed in Note 1, the Plan was terminated effective June 7, 2024, and all assets were automatically transferred from the Plan to an outside multi-employer plan. All participant balances became 100% vested as of the termination date and were not subject to forfeiture.

Note 7—Prohibited transactions

During the period ended June 7, 2024, the Plan Sponsor failed to remit to the Plan's trustee certain employee contributions totaling \$994 within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the trustee were due to administrative errors, and the Plan Sponsor has made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays prior to the Plan's termination on June 7, 2024.

Note 8—Tax status

The IRS has determined and informed the Plan administrator by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, it has no income subject to business income tax, and the Plan continues to be tax exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through August 21, 2025, the date these financial statements were available to be issued.
