Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Their report dated July 12, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A -- Description of plan and significant accounting policies

The following description of the J.W. Jung Seed Company 401(k) Profit Sharing Plan (the “plan”) provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions. The employer, as described below, has adopted the Pension Inc. Non-Standardized Defined Contribution Pre-Approved Plan effective July 31, 2022. The original effective date of the plan was June 20, 1963.

General

The Plan is a defined contribution plan covering all eligible employees of J.W. Jung Seed Company, Inc. (“JW”) and Seeds for the World, Inc. (“the employer”) who have one year of service and are age twenty-one or older. Seeds for the World, Inc. was merged into JW in November 2023. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees oversee governance of the plan. The Plan Administrative Committee determine the appropriateness of the plan’s investment offerings, monitors investment performance and report to the Trustees.

The Plan’s federal identification number is 39-0383080, and the Plan’s number is 001.

Contributions

Each year, participants may contribute up to the maximum amount allowed by law of annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. The employer contributes 25% of the first 6% of eligible compensation as a discretionary matching contribution. The employer also has the right to make additional contributions to be allocated to participants pro-rata based on compensation. No additional discretionary contributions were made in 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Contributions receivable

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the company.

Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contributions and allocations of (a) the employer’s matching and discretionary contribution (b) plan earnings and (c) charged with an allocation of administrative expenses. Allocations of plan earnings are based on participant account balances, as defined, and allocation of company contributions are based on participant compensation, as provided in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The plan permits the transfer of funds from other qualified plans to a separate participant’s rollover account.

NOTE A -- Description of plan and significant accounting policies (Continued)

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested ratably after six years of credited service. Participants who leave the Plan because of death or disability, as defined in the Plan, are considered 100 percent vested in all amounts.

Participant loans

Participants may not borrow from their fund accounts.

Benefits

On termination of service due to death, disability, or retirement (age 65), or termination of service due to other reasons, a participant with an account balance less than \$1,000 will receive the value of the vested interest in their account as a lump-sum distribution. An automatic rollover of a participant's account to an IRA will occur if the account is valued between \$1,000 and \$5,000. For accounts exceeding \$5,000, the participant may elect a distribution in the form of a lump-sum, partial distributions, partial distributions to satisfy required minimum distribution rules, or may elect to defer such distribution to any valuation date subsequent to his/her termination but no later than the valuation date of his/her normal retirement date; or the participant may elect to roll over the distribution to another qualified plan. The plan permits hardship distributions if certain criteria are met. The plan permits in-service distributions at age 65 with 10 years of service.

Forfeited accounts

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$964 and \$951, respectively. These accounts will be used as additional nonelective or matching contributions, reduce match or nonelective contributions or pay plan expenses. No forfeitures were used in 2024.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the plan are prepared using accounting principles generally accepted in the United States of America ("U.S. GAAP") under the accrual method of accounting.

Cash

The Plan maintains its cash in bank deposit accounts, which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. Management believes it is not exposed to any significant credit risk on cash and cash equivalents.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's Trustees determines the plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The employer pays some of the administrative expenses of the plan which are excluded from these financial statements. Fees related to the administration of payment of benefits are charged directly to the participant's account. The major administrative expenses are record keeping and investment management fees.

Subsequent events

These financial statements have not been updated for subsequent events occurring after August 19, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE B -- Investments certified by the asset custodian

Certain information related to investments and cash disclosed in the accompanying financial statements and supplemental schedule, including investments and cash held at September 30, 2024 and 2023, and net appreciation for the year ended September 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), the asset custodian of the plan.

NOTE C -- Fair value measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

- Pooled separate accounts. The pooled separate accounts are invested in investments such as stocks, mutual funds, collective investment trusts, etc. John Hancock owns the underlying investments in the separate accounts. The underlying measurements for the separate key prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value of the separate account is not public quoted.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended September 30, 2024, are reported in net appreciation in fair value of investments.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of September 30, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE D -- Party-in-interest transactions

Certain Plan investments are managed by John Hancock. John Hancock is the asset custodian and recordkeeper for the plan, and therefore, these transactions qualify as party in interest transactions.

John Hancock provides certain administrative services to the plan pursuant to a Master Plan Services Agreements (MSA) between the company and John Hancock. John Hancock receives revenue from mutual fund service providers for services John Hancock provides to the funds. This revenue is used to offset certain amounts owed to John Hancock for its administrative services to the plan.

NOTE D -- Party-in-interest transactions (Continued)

If the revenue received by John Hancock from such mutual fund service providers exceeds the amount owed, John Hancock remits the excess to the plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The plan or plan sponsor may make a payment to John Hancock for administrative expenses not covered by revenue sharing.

Fees were also paid by the Plan during the year for investment advisor services rendered by Willshire Associates Inc. and Edward D. Jones & Co., L.P. These transactions also qualify as party-in-interest transactions.

NOTE E -- Plan termination

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their allocated employer contributions.

NOTE F -- Tax status

The Pension Inc. Non-Standardized Defined Contribution Pre-Approved Plan that the Plan has adopted effective July 31, 2022, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Concentration of market risk

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE H – Cash surrender value of life insurance

The plan is the owner of a whole life insurance policy insuring one plan participant through Great West Life Insurance Company. The participant pays the premiums on their policy through their account balances in the plan. Premiums paid for the years ended September 30, 2024 and 2023 were \$0 and \$851, respectively. Death proceeds will be paid to the beneficiary of the policy and surrender proceeds will be paid to the Plan. The cash surrender value of the policy at September 30, 2024 and 2023 was \$0 and \$1,122, respectively. The policy lapsed in 2024.
