1. DESCRIPTION OF THE PLAN

The following description of the Jennison Associates Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established on January 1, 1986, covering all full-time employees of Jennison Associates, LLC (the Company), who have one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Administrative Committee of the Plan is responsible for oversight of the Plan.

Contributions

Each year, participants may contribute up to 30% of eligible compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company contributes to the Plan from its net profits for the Plan year, or from its accumulated net profits, a discretionary amount from 0% - 20% of the total eligible compensation of the participants not to exceed the Internal Revenue Service (IRS) compensation limits. The Company also contributes a fixed amount equal to 5% of the total eligible compensation, which is comprised of a 3% non-elective Safe Harbor contribution and a 2% non-Safe Harbor contribution for participants at the level of Assistant Vice President or lower limited to the IRS compensation limits. For the Plan year 2024, the Company made an annual discretionary contribution of 11% of the total eligible compensation of the participants. For the year ended December 31, 2024, the amount of the annual discretionary contribution was \$10,240,955.

Participant Accounts

Participant accounts are invested in accordance with the participant's directions to allocate among selected investment funds. Each participant's account balance consists of the following: (a) Company contributions, including forfeitures, allocated to the participant's account; (b) any eligible contributions rolled over or transferred from a prior plan or another plan; (c) the participant's elective deferral contributions, including catch-up contributions, if any; (d) the participant's proportionate share of income and losses in each investment fund in which the participant has an interest; (e) the participant's proportional share of net appreciation or depreciation in the value of each investment fund in which the participant has an interest; (f) less any withdrawals made by participant; and (g) less any outstanding loan balance made by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon and the Company's 3% Safe Harbor profit-sharing contribution. The 2% of non-Safe Harbor and the discretionary balances are vested based on years of service as follows:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. The loans are secured by the balance in the participant's account. Loan interest is charged at the prime rate plus 1% per annum. Principal and interest are paid ratably through payroll deductions over the term of the loan. Outstanding loans as of December 31, 2024 and 2023 have interest rates that range from 4.25% to 9.50% and 4.25% to 9.25%, respectively.

Payment of Benefits

On termination of service due to health, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

If a participant terminates employment with the Company, the non-vested portion of the Company contribution and earnings thereon are forfeitable. If the participant is re-employed within five years from the calendar year of termination, the forfeitable amount of the Company contribution may be reinstated, subject to certain Plan provisions. Plan forfeiture reinstatement provisions include the requirement that participants repay distributed account balance amounts attributable to the Company's contribution to the Plan. Any amounts not reinstated to a participant, after the five-year period, will be allocated to the Plan's forfeiture account.

As of December 31, 2024 and 2023, the forfeiture account totaled \$119,751 and \$142,050, respectively.

This account will be used to reduce future employer contributions. For the year ended December 31, 2024, the forfeiture account was used to reduce employer contributions by \$50,676.

Plan Termination

Although it has not expressed any such intent, the Company has the right under the Plan document to discontinue its contributions at any time and amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities as well as the reported amounts of changes in net assets. Actual results could differ from the estimates included in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments, with the exception of the Guaranteed Income Fund (GIF), are reported at fair value. Fair value is the price that would be received from the selling of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The GIF is a group annuity contract product that is fully guaranteed by Empower Annuity Insurance Company (EAIC). This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan Administrator has evaluated subsequent events to December 31, 2024 and through August 26, 2025, the date the financial statements were available to be issued, and has determined that no material subsequent events have occurred that would affect the information presented in the accompanying financial statements or require additional disclosure.

3. INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments held and notes receivable from participants as of December 31, 2024, and for the year then ended, was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate by Empower Trust Company, the trustee of the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2024.

Mutual Funds – Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust – Observable inputs in the valuation methodologies are used whenever they are available and deemed reliable.

Various inputs may be used to determine the value of the Fund's investments, which are summarized in three broad categories defined as Level 1, Level 2, and Level 3. The inputs or methodologies used for valuing securities are not necessarily indicative of the risk associated with investing in those securities. The assignment of an investment to Levels 1, 2, or 3 is based on the lowest level of significant inputs used to determine its fair value.

Level 1 – Quoted prices in active markets for identical securities.

Level 2 – Other significant observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.).

Level 3 – Significant unobservable inputs are used in situations where quoted prices or other observable inputs are not available or are deemed unreliable.

Significant unobservable inputs may include the Fund's own assumptions.

5. GUARANTEED INCOME FUND

The GIF is a group annuity contract product that is fully guaranteed by EAIC.

The contract value of the GIF as of December 31, 2024 and 2023 was \$40,680,942 and \$56,597,373, respectively. EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a semi-annual basis for resetting. The crediting rate for January 1, 2024 to June 30, 2024 was 2.15%, and the crediting rate for July 1, 2024 to December 31, 2024 was 2.20%.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Company is the Plan Sponsor, as defined by the Plan document.

There are not any events that allow the issuer to terminate the contract and which require the Plan Sponsor to settle at an amount different than the contract value paid either within 90 days or over time.

6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Company acts as a subadvisor to some of the Plan's investment funds available to the participant and receives sub-advisory fees associated with being a sub-advisor to the investment funds. In addition, Prudential, through other subsidiaries, receives fees for serving as a sub-advisor or a manager to other investment funds available to participants.

To the extent a party-in-interest is involved, the transactions in these investments qualify as exempt party-in-interest transactions under ERISA.

7. TAX STATUS

The IRS has determined and informed the Company by a letter dated July 17, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (Code). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options that are, in general, are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in such risk factors could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits and changes therein.
