Basis for Disclaimer of Opinion

As described in Note 11, sufficient evidence supporting participant account balances and transactions prior to January 1, 2008 is not available. The Plan's accounting records do not permit the application of other auditing procedures to participant accounts prior to January 1, 2008. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Note 1 - Plan Description

The following description of the Asia Foundation Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of plan provisions.

General - The Plan is a defined contribution plan created for the benefit of eligible employees of The Asia Foundation (the Foundation) under the provisions of Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) are the issuers of the Plan's annuity contracts. TIAA Trust, N.A. is the custodian for certain Plan assets. TIAA also provides recordkeeping services.

Eligibility - All employees, except nonresident aliens, are eligible to make salary deferral contributions to the Plan on their date of hire. All employees, except nonresident aliens and temporary employees, are eligible to receive discretionary employer contributions. Temporary employees who reach one year of eligibility service under the elapsed-time method are eligible to receive discretionary employer contributions.

Contributions - Participants may elect to defer up to 100% of their eligible compensation as pretax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollovers).

The Foundation may make discretionary contributions, as defined by the Plan. During the year ended December 31, 2024, the Foundation authorized discretionary contributions equal to 10% of each qualified participant's compensation.

Contributions are subject to certain IRS limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions, allocations of the Foundation's discretionary contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in their salary deferrals plus actual earnings thereon. Participants are 100% vested in discretionary employer contributions after one year of service.

Plan Loans - Plan loans are funded from the assets of TIAA. Accordingly, Plan loans are not reported on the statements of net assets available for benefits and related interest income is not reported on the statement of changes in net assets available for benefits.

Adequate security is required and a portion of the participant's account is reserved, or held as collateral, to cover 110% of the outstanding loan in case of default. The interest rate for plan loans may be fixed or variable and the initial rate is determined by the terms of the controlling contract. Participants may borrow a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. Principal and interest payments are made by the participant directly to TIAA. Plan loans totaled \$85,134 and \$122,770 as of December 31, 2024 and 2023, respectively. Effective January 1, 2022, the Plan no longer issues plan loans. Loans granted are now issued as notes receivable from participants (described below).

Notes Receivable From Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Loans are repayable through equal installment payments at least quarterly. The maximum loan term is five years unless the loan qualifies as a home loan, in which case the term of the loan can be up to ten years. Loans granted will bear a reasonable rate of interest.

Payment of Benefits - Upon termination of service, retirement, death, or disability, participants or their beneficiaries may elect to receive a lump-sum payment, installment payments, or an annuity. Participants who have attained age 59½ may also elect to receive a distribution from the elective deferral portion of their account balance prior to termination of employment (in-service withdrawals). The Plan also provides for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Forfeitures - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,214 and \$2,535, respectively. During 2024, \$18,756 of forfeitures were used in accordance with the provisions specified in the Plan document.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that may affect the reported amount of assets and liabilities changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Foundation. Expenses that are paid by the Foundation are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through August 25, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no additional changes in the methodologies used as of December 31, 2024 and 2023:

Variable Annuity Accounts - College Retirement Equities Fund (CREF) is a registered investment company and consists of eight accounts which fund variable annuity contracts issued by CREF. TIAA Separate Account VA-3 consists of various TIAA Access accounts which fund variable annuity contract issued by TIAA. The fair values of accumulation units held in CREF accounts and TIAA Access accounts are based on each account's daily published net asset value (NAV). NAV is based on the market value of its underlying securities determined by market quotations or prices obtained from independent pricing sources. The CREF Money Market Account is valued at amortized cost, which approximates fair value. Accumulation units in CREF accounts and TIAA Access accounts are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account - The TIAA Real Estate Account (REA) is a pooled separate account which funds variable annuity contracts issued by TIAA. The fair value of accumulation units held in the REA is published daily and based on market values of the underlying real estate properties determined by external appraisals, which are estimates of property values based on a professional's opinion. The REA may also hold real estate-related marketable securities which are valued using independent pricing sources. Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter.

Fixed Annuity Contracts - The TIAA Traditional Annuity are fixed annuity contracts that are fully and unconditionally guaranteed by TIAA. As an insurance company, TIAA is required to maintain contingency reserves to ensure that it will be able to fulfill its contractual obligations to policyholders. The TIAA Traditional Annuity that is not considered fully benefit-responsive and measured at fair value is offered through the Retirement Annuity (RA), Group Retirement Annuity (GRA), and Retirement Choice (RC) contract types. Under RA, GRA, and RC contracts, participant initiated withdrawals or transfers may be subject to certain liquidity restrictions and/or fees. RA, GRA, and RC contracts are reported at contract value which is the aggregation of contributions, plus interest, less any withdrawals. Contract value approximates a discounted cash flow value (fair value) calculated using an appropriate risk-adjusted market discount rate which correlates closely with historical crediting rates for these contracts. Fair value is determined annually for financial statement reporting purposes. When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

Note 4 - Fully Benefit-Responsive Investment Contracts

In addition to the nonbenefit-responsive TIAA Traditional Annuity described in Note 3, the Plan also holds benefit-responsive TIAA Traditional Annuities through the Group Supplemental Retirement Annuity (GSRA), Supplemental Retirement Annuity (SRA), and Retirement Choice Plus (RCP) contract types. GSRA, SRA, and RCP contracts provide for full participant-directed liquidity and are reported at contract value. Contract value is the relevant measure because that is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value is the aggregation of contributions, plus interest, less any withdrawals.

Each contract is fully and unconditionally guaranteed by TIAA. As an insurance company, TIAA is required to maintain contingency reserves to ensure that it will be able to fulfill its contractual obligations to policyholders. Sponsor initiated withdrawals from the RCP contract are allowed over a seven-year period with a 2.5% surrender charge with 30 days advance written notice from the Foundation. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and that also would limit the ability of the Plan to transact at contract value with participants.

Note 5 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF). TIAA has been authorized by TIAA Trust, N.A. to certify investments for which TIAA Trust, N.A. is the directed custodian. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Party-in-Interest Transactions

The Plan's investments include mutual funds managed by an affiliate of TIAA and fixed and variable annuity contracts issued by TIAA and CREF. TIAA is the recordkeeper for these investments. Therefore, transactions with these investments and fees paid by the Plan to TIAA and its affiliates qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 7 - Termination of the Plan

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan terminated, participants would become 100% vested in their employer contributions.

Note 8 - Tax Status

The Foundation adopted a TIAA 403(b) volume submitter plan document. TIAA received an advisory letter from the IRS dated August 7, 2017, which states that the 403(b) volume submitter plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Concentrations

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the fixed annuity contracts issued by TIAA. These investments represent approximately 20% and 22% of total Plan investments as of December 31, 2024 and 2023, respectively. The Plan's management seeks to limit its credit exposure by working with high credit quality institutions.

Note 11 - Beginning Account Balances

TIAA, the Plan's recordkeeper, was unable to provide information to support the account balances prior to January 1, 2008. In addition, because of system upgrades and changes to the Foundation's payroll system, the Foundation was not able to locate some historical payroll records and annual contribution details for years prior to January 1, 2008.
