Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 – DESCRIPTION OF PLAN

Barrett Daffin Frappier Turner & Engel, LLP established the Barrett Daffin Frappier Turner & Engel, LLP 401(k) Plan (the Plan) effective January 1, 1998. The Plan was established as a qualified defined contribution profit sharing plan which has a qualified salary deferral feature under Section 401(k) of the Internal Revenue Code of 1986. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution prototype plan covering all full-time employees of the Employer, who are aged twenty-one years or older. An employee is eligible to participate in the Plan immediately upon employment. The Plan is subject to the provisions of ERISA.

Contributions – For the current year, participants may contribute up to \$23,000 of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to contribute an additional \$7,500 to the Plan. Effective January 1, 2009, the Plan was amended to automatically defer 3% for all eligible employees unless the employee elects to change the deferral. Effective October 1, 2018, the Plan was amended to allow participants to exclude bonuses from considered compensation. Effective January 1, 2022, the Plan was amended to include an automatic increase of automatic deferral elections by 1% each January 1<sup>st</sup> until the percentage reaches 10%. Effective December 31, 2022, the automatic increase of automatic deferral elections by 1% each January was suspended. Participants direct the investment of their contributions into various investment options offered by the Plan.

Company matching – The Employer shall make a discretionary contribution based on the amount of employee salary reduction contributions. The Employer evaluates the match annually and can modify the percentage at their discretion. The Employer's matching contribution in 2024 was 33% up to the first 6% of participants' compensation. Funding of the employer matching contribution was suspended after the 1<sup>st</sup> quarter in 2024. Each eligible employee who satisfies the participant requirements may receive matching and non-elective Employer contributions after completing one year of service.

With limited exceptions, participants must complete 250 hours of service and be employed on the last day of the Plan quarter to receive an allocation of Employer matching contributions and must complete 1,000 hours of service and be employed on the last day of the Plan year to receive an allocation of Employer non-elective contributions.

Effective December 30, 2020, the Plan was amended to allow for Employer non-elective contributions to employees who terminated employment during the year due to death, disability or attainment of normal retirement age regardless of whether such Participant meets any service requirement and/or last day requirement set forth in the Plan documents.

Participant accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer’s contribution and, (b) plan earnings, and charged with allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer’s contribution portion of their accounts and earnings thereon is based on years of continuous service, as follows:

2 years	20
3 years	50
4 years	75
5 years	100
6 years or more	100

One year of service credit for purposes of the vesting schedule will include all plan years during which the participant worked at least 1,000 hours for the Plan Sponsor. Years of service before the effective date of the Plan are excluded for vesting purposes.

Payment of benefits – On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures – Forfeitures may be used to reduce future Employer contributions or pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$50,706 and \$41,102, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. In 2024, employer matching contributions of \$4,778 were paid from forfeited nonvested accounts.

Notes receivable from participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1-5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Interest rates are 4.25% - 9.50%. Principal and interest were paid ratably through bi-monthly payroll deductions.

Investment options – Upon enrollment in the Plan, a participant may direct employee and employer contributions in a variety of investment options. Participants may change their deferral percentage and investment options as often as they choose by contacting the Trustee in writing, via telephone or via the internet. Participants may terminate deferrals at any time.

Rollovers – Participants may also contribute amounts representing distributions from other qualified defined benefit or contributions plans. Contributions are subject to certain limitations. All contributions are paid in cash.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors and Trustee. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions in accordance with the terms of the Plan document.

Payment of benefits – Benefits are recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and investment management services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable regulations of the Code. The Plan has been amended since receiving the determination letter, however, the Employer and the Plan administrator believe that the Plan is currently designed and operating in compliance with the applicable requirements of the Code and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally Accepted Accounting Principles (GAAP) requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that all Plan years remain open or subject to audit.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5 – RISK/UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 – RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for such investment management services are netted against net appreciation in fair value of investments for the year ended December 31, 2024.

Fees paid by the Plan Sponsor for service rendered to the Plan in 2024 totaled \$1,870.

Parties-in-interest include fiduciaries of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or employee organization or relatives of such persons. These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

NOTE 7 – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CF 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and disclosure under Employer Retirement Income Security Act of 1974. The Trustee holds the Plan’s investment assets and notes receivable from participants and executes investment transactions in accordance with the Plan documents. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The net appreciation in fair value of investments was \$1,392,198 for the year ended December 31, 2024. Interest income was \$21,992, and dividend income was \$737,667 for the year ended December 31, 2024.

The Plan’s independent auditors did not perform audit procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

All investments of the Plan are participant-directed.

NOTE 8 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
