The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Heartview Foundation 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTE 1 PLAN DESCRIPTION**

The following description of the Heartview Foundation 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**General**

Heartview Foundation (Organization) established the Plan effective October 1, 2006. The Plan is a defined contribution plan and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is sponsored by the employer, Heartview Foundation. A third-party administrator (Bravera Wealth) serves as the trustee of the Plan, maintains the records of the participant data, and holds the Plan assets.

**Eligibility**

Effective July 1, 2024, substantially all employees are eligible to participate in the Plan immediately after reaching the age of 18. To receive discretionary matching contributions, an employee must be contributing to the Plan. To receive discretionary profit-sharing contributions, an employee must complete one year of service (1,000 hours of service during the latest 12 month period), be 18 years of age, and be employed on the last day of the plan year.

Prior to July 1, 2024, all eligibility requirements were the same as listed above with the exception of the age requirement, which was 21 for all contribution types.

**Contributions**

Participants may contribute a minimum of 1% and maximum of 100% of their eligible compensation. However, each respective participant's total deferrals in any taxable year may not exceed the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

The Plan allows for discretionary matching contributions of 100% of the participant's elective deferrals up to 4% of the participant's compensation for the Plan year.

The Plan also allows for a discretionary profit-sharing contribution. The amount of the profit-sharing contribution is determined by the Organization and is to be allocated on a pro-rata basis among all eligible participants based on compensation. For the years ended December 31, 2024 and 2023, a profit-sharing contribution of 4% was declared for each year.

Participants may roll over amounts representing distributions from other qualified defined benefit or defined contribution plans.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and employer matching and profit-sharing contributions, if any. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferrals and employer contributions to selected investments as made available and determined by the Plan Administrators. Participants may change their investment options throughout the year by contacting Bravera Wealth, the Trustee.

**Payment of Benefits**

Upon termination of employment, death, disability or retirement, the participant may request a lump sum amount or ad-hoc distributions equal to the value of the participant's vested interest. Terminated employees with account balances of \$7,000 or less are required to take a lump sum distribution upon termination. Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 ½ to qualify for in-service retirement distributions. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Vesting**

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the employer's contribution and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of service with certain exceptions for death, disability and retirement. A participant is 100% vested after five years of credited service, which is defined as the completion of at least 1,000 hours of service during the plan year.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$41,921 and \$12,306, respectively. This account is used to reduce employer contributions or pay plan expenses. During the years ended December 31, 2024 and 2023, \$12,306 and \$13,145 of forfeitures, respectively, were used to pay plan expenses.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates comparable to those charged by financial institutions for similar loans. The term of the loan cannot exceed five years, unless it qualifies as a home loan at which the term cannot exceed 15 years. Principal and interest are paid ratably through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrators to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held and transferred during the years and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and matching contributions from the Organization are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Participant loans are considered delinquent if payment is not made by the end of the 'cure period', which cannot extend past the last day of the calendar quarter following the calendar quarter in which final payment was due.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of the loan. Certain administrative expenses that are paid by the Organization are not reflected in the accompanying financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENT**

Financial Accounting Standards Codification Topic 820, Fair Value Measurements and Disclosure, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means;  
If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: A stable value fund that is composed of fully benefit-responsive investment contracts and is valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Bravera Wealth. The non-standardized pre-approved profit sharing plan has received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service, as to the plan's qualification status. The opinion letter has been relied upon by this Plan. The Plan Administrators believe the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. All required filings are current.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Bravera Wealth serves as the trustee of the Plan, maintains the records of the participant data, and holds the Plan's assets. For the years ended December 31, 2024 and 2023, the Plan paid fees to Bravera Wealth for these services provided in the amount of \$49,292 and \$36,789, respectively.

The Plan issues notes receivable to participants which are secured by the balances in the participants accounts.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Organization reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. In the event of Plan termination, the rights of all participants to benefits accrued to the date of such termination, to the extent then funded, are non-forfeitable.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
