INDEPENDENT AUDITORS' REPORT

To the Retirement Board Committee
of Grove City College

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Grove City College 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Administration, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by a qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Administration has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that administration determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Administration for the Financial Statements

Administration is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Administration's election of the ERISA Section 103(a)(3)(C) audit does not affect administration's responsibility for the financial statements.

In preparing the financial statements, administration is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Administration is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Grove City College Savings and Retirement Plan (the Plan) is provided for general information purposes only. Plan participants should refer to the Plan document or summary plan description for a more comprehensive description of the Plan's provisions.

General - The Plan is a defined contribution 403(b) plan adopted by Grove City College (College) on January 1, 1989 and amended and restated as recently as January 1, 2024. Substantially all employees of the College who meet specified service requirements are eligible to participate in the Plan. The College, with oversight by the Retirement Board Committee of the College, is the plan administrator, which is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities at the dates of the financial statements and the reported changes in assets available for benefits during the reporting period. Actual results could differ from the estimates.

Risks and Uncertainties - The Plan assets are comprised of various investment securities which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the near term could materially affect the assets available for benefits.

Contributions - Eligible employees may contribute up to 75% of compensation, as defined by the Plan, on a pretax or after tax basis subject to certain limitations under the Internal Revenue Code. Changes to contribution elections can be made at any time.

Rollover contributions result from terminated employees transferring their cash balance benefit from the Grove City College Pension Plan as well as new employees transferring amounts into the Plan from other unrelated plans.

The College's contributions are comprised of the following:

- Matching contributions, which were 50% of employee deferrals up to a maximum of 6% of eligible compensation for the years ended December 31, 2024 and 2023. Participants are eligible for the employer match upon completion of one year of service.

- Discretionary non-elective contributions, which were 5% of eligible employees' earnings for the years ended December 31, 2024 and 2023.
- Supplemental contributions, which were provided effective September 1, 2011 concurrent with the freeze of benefits under the Grove City College Pension Plan, for grandfathered employees who were 55 years or older on September 1, 2011. The supplemental contribution is 1% of eligible compensation if the employee's age plus years of service total less than 75 and 5% of eligible compensation if the total age plus years of service total 75 or more on September 1, 2011.

Neither the discretionary non-elective nor the supplemental contributions are dependent on employee deferrals into the Plan.

Participant Accounts - Participants' accounts are credited with their contributions and the College's contributions. Plan earnings, as reduced by administrative expenses, are allocated to participant accounts as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participant contributions are fully vested and nonforfeitable at all times, as are the College's contributions.

Benefits - Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the interest in his or her account. Payment options include lump-sum distributions or annuity payments. Normal retirement age is 65; early retirement age is 55. Participants age 59 1/2 are also eligible for in-service withdrawals. Terminated participants with account balances that do not exceed \$5,000 will receive distributions in the form of a lump sum payment, installment payment, annuity, or ad-hoc distribution. Effective January 1, 2024, terminated participants with balances that do not exceed \$1,000 will be automatically rolled into an IRA unless an alternative election is made. Participants may elect in-plan Roth rollover conversions of their elected deferrals and rollover contributions effective January 1, 2024.

Investment Valuation and Income Recognition - Investments are carried at their fair values, except for the fully benefit-responsive investments which are reported at contract value, determined based upon contributions, earnings and withdrawals. The Plan presents, in the statements of changes in assets available for benefits, the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on these investments. The unrealized appreciation or depreciation of investments is determined by the change in current market value from the beginning of the period to the end of the period (if held for the entire period), or from the date of purchase to the end of the period. Realized gains and losses on securities sold or redeemed are determined, on the basis of specific identification, from the date of purchase to the date of sale. Purchases and sales of securities are reflected on a trade-date basis. Dividends and interest are recorded as earned.

Investment Options - Participants direct their contributions, employer contributions, and any related earnings into various investment options provided by the custodians. Participants may change their investment election at any time, with changes becoming effective immediately. Participant accounts are invested in registered investment companies, group annuity contracts and real estate investments maintained by TIAA, Lincoln Financial Group (Lincoln), under its Multi-Fund Platform, and Transamerica (through December 2023).

Fair Value Measurements - U.S. GAAP establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered Investment Companies: Valued at the closing price reported on the active market on which the individual securities are traded (level 1 inputs), or valued at the net asset value (NAV)—which is expected to approximate fair value—of shares held by the plan at year-end (level 1 inputs).

Real Estate Investments: Valued at the market value of the underlying real estate holdings or other real estate-related investments based upon external appraisals or other independent pricing sources (level 2 inputs).

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

Notes Receivable from Participants - Participants may borrow as much as 50% of their vested account balance up to \$50,000, less the participant's highest outstanding loan amount during the preceding twelve month period. The amount of the loan must be at least \$1,000. Loans accrue interest at a rate determined by the plan administrator to be reasonable based on similar loans at the inception of the loan and are secured by the participant's account balance. All loans must be repaid in their entirety within five years, unless the purpose of the loan is to purchase a principal residence. Participant loans of \$317,315 and \$296,814 were outstanding at December 31, 2024 and 2023, respectively, with interest rates ranging from 4.25% to 9.50%.

Administrative Expenses - Administrative expenses paid by the Plan consist principally of participant account maintenance fees paid to the recordkeepers (Transamerica and TIAA), as well as investment fees related to the Transamerica (through December 2023) and TIAA investments. Fees related to the Lincoln Multi-Fund investments are netted against investment returns. These expenses serve to reduce participant accounts. The College pays certain other expenses related to the Plan.

The Plan is credited with revenue sharing, which may be used to pay the Plan's administrative expenses or credited to participant accounts. Income from revenue sharing is presented in the net appreciation (depreciation) in fair value of investments on the statements of changes in assets available for benefits. Revenue sharing received and earnings thereon in excess of paid plan expenses and credits to participant accounts resulted in balances of \$81,217 and \$66,269, included in investments on the statements of assets available for benefits, at December 31, 2024 and 2023, respectively.

Subsequent Events - Subsequent events have been analyzed for recognition and disclosure purposes through August 26, 2025, the date the financial statements were available to be issued.

2. GROUP ANNUITY CONTRACTS

The Plan holds fully benefit-responsive group annuity contracts with registered insurance companies which are contractually obligated to repay the principal and a specified interest rate determined annually that is guaranteed to the Plan. Because the group annuity contracts are fully-benefit responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan will not have the ability to execute transactions at contract value with the issuer in certain circumstances that are defined in the annuity contracts. The plan administrator does not believe that these events are likely to occur.

3. PLAN TERMINATION

The College anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts are 100% vested and would be distributed by the trustee in accordance with the trust agreement in a uniform and nondiscriminatory manner.

4. INCOME TAX STATUS

The Plan obtained its latest advisory letter on August 7, 2017, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified.

The plan administrator believes there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for years ended before December 31, 2021.

5. CERTIFICATION BY CUSTODIANS

The custodians certified the following data included in the accompanying financial statements as complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes as shown in the accompanying supplemental schedule as of December 31, 2024.

TIAA and Lincoln National Life Insurance Company certified the above information as of December 31, 2024 and 2023 and for the years then ended. During 2023, the Plan terminated its custodial agreement with State Street Bank and Trust Company and transferred the assets previously held by State Street Bank and Trust Company to TIAA. As a result, State Street Bank and Trust Company certified the above information for the period from January 1, 2023 to December 4, 2023, the date at which the assets were transferred to TIAA.
