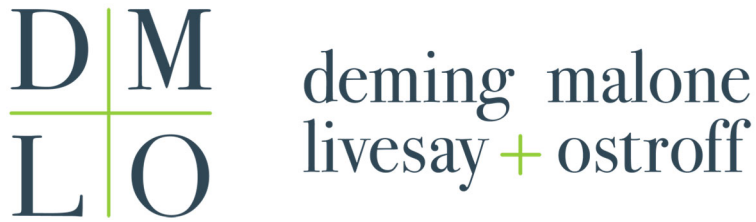

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cedar Lake 401(k) Retirement Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cedar Lake 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Cedar Lake 401(k) Retirement Savings Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan, covering substantially all employees of Cedar Lake Workforce, LLC (Employer) who have attained the age of twenty-one and completed one year of service. An employee may join the Plan on any entry date on or following the attainment of these requirements. Entry dates are the first of every calendar quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator and Retirement and Plan Committee are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, monitor investment performance, and report to the Board of Directors.

Contributions:

Each year, participants may contribute from 1% to 75% of pre-tax compensation, as defined in the Plan. Participants may also elect to defer a portion of their after-tax compensation as a Roth contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has a safe harbor employer match of 100% of the first 4% of compensation contributed by each participant. The Employer may also make an annual discretionary profit-sharing contribution, including a provision for a permitted disparity allocation of profit-sharing contributions for those participants whose wages exceed the IRS statutory limits. The Employer did not make a discretionary profit-sharing contribution for 2024 or 2023. Contributions are subject to certain IRS limitations.

Participant accounts:

Each participant's account is credited with the participant's contribution and the Employer's matching contribution, as well as an allocation of the Employer's profit sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

Vesting:

Participants are vested immediately in their contributions and the employer safe harbor contributions, plus actual earnings thereon. Vesting in the Employer's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service, with no vesting prior to that time.

Notes receivable from participants:

Effective July 2024, the plan was amended to permit participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions will be treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. The loans are secured by the balance in the participant's account and bear interest as determined quarterly by the Plan Administrator. Principal and interest are paid through payroll deductions.

Forfeited accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,436 and \$1,094 respectively. The accounts will be used either to pay plan expenses or to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$1,093 and \$1,681, respectively, from forfeited non-vested accounts.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. Upon termination of employment for other reasons, the participant may receive the value of the vested interest in his or her account as a lump sum distribution. Any terminated employee not fully vested forfeits the non-vested portion.

Participants may also be permitted to receive a distribution from their account prior to termination of employment provided they experience certain financial hardships. Any hardship distribution is limited to the amount available from the salary deferral portion of their accounts and has a minimum withdrawal of \$1,000.

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

NOTES TO FINANCIAL STATEMENTS

Basis of presentation:

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions:

Contributions from Plan participants and the matching contribution from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions requested by participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

NOTES TO FINANCIAL STATEMENTS

Payment of benefits:

Benefits are recorded when paid.

Subsequent events:

The Plan has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and interest for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company, a qualified institution.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTES TO FINANCIAL STATEMENTS

All assets have been valued using a market approach. Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used at December 31, 2024 and 2023.

Pooled separate accounts – valued at the net asset value of units held by the Plan at year-end. The net asset value is based upon quoted market price or value as determined by the Company. The net asset value is used as a practical expedient to estimate fair value.

The Plan held no assets required to be leveled within the fair value hierarchy as of December 31, 2024 and 2023. The following table sets forth the Plan’s assets measured at net asset value as of December 31, 2024 and 2023.

Investments Measured Using Net Asset Value per Share Practical Expedient:

All pooled separate accounts have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments’ net asset value (NAV). The NAV is updated daily.

Note 5. Guaranteed Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive guaranteed investment contract with Standard Insurance Company (Standard) with a contract value of \$942,573 and \$1,094,961 at December 31, 2024 and 2023, respectively. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a monthly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTES TO FINANCIAL STATEMENTS

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Plan Administrator does not believe that any events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by Standard, a market value adjustment may apply.

Note 6. Income Tax Status

The Plan operates under a standardized volume submitter plan with CODA offered by Retirement Management Services. The volume submitter plan has received its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for the tax periods in progress.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in employer contributions.

NOTES TO FINANCIAL STATEMENTS

Note 8. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts and a guaranteed investment account managed by Standard Insurance Company. Standard Insurance Company is the insurance company as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment. For the years ended December 31, 2024 and 2023, the Plan made direct payments to the Plan's insurance company of \$18,964 and \$13,599, which were not covered by revenue sharing and which are recorded as administrative expenses on the statements of changes in net assets available for benefits. The plan sponsor pays directly any other fees related the Plan's operations.

The Plan has an agreement with Standard for investment related expenses with third parties which is offset with net appreciation in fair value of investments for 2024 and 2023. The expenses netted against net appreciation in fair value of investments for 2024 and 2023 range from 0.68% to 1.51% per \$1,000 invested in the pooled separate or guaranteed return investment accounts. Expense offset arrangements generally consist of fees being paid to a third-party service provider (for example, record-keeper) directly through the use of investment fee rebates made available by the Plan's insurance company.

Certain administrative functions are performed by officers or employees of the Employer. No officer of employee receives compensation from the Plan.

Note 9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of investment risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Events

Effective January 2025, the plan was amended to remove the one year of service requirement (1,000 hours) for an employee to join and contribute to the plan. Entry dates were amended to the first of the following month, upon attainment of age twenty-one. The one year of service requirement (1,000 hours), and entry dates of the first of every quarter remain in effect for participants to receive employer match contributions.
