Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of the CHT USA 401(k) Profit Sharing Plan (the “Plan”) provides general information about the Plan’s provisions. CHT USA Inc. (the “Company” or the “Employer”) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan’s provisions, copies of which may be obtained from the plan sponsor.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of the Company and its participating subsidiaries, affiliates, and locations (collectively, the “Company” or the “Employer”). Employees are required to complete three months of service to be eligible to make deferrals and receive Employer safe harbor and profit-sharing contributions. Along with the three-month requirement, employees must also be credited with 500 hours of service during the plan year and be employed on the last day of the plan year to be eligible to receive Employer profit sharing contributions. Employees’ entry date is the first day of each month of the plan year coinciding with or the next day following upon all eligibility requirements being met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Each year, participants may elect to contribute a percentage of their annual pre-tax and post-tax wages as defined by the Plan agreement, limited to the maximum amount allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Plan allows for a safe harbor contribution to all participants in an amount equal to a percentage of the participant’s eligible compensation, as defined, for the plan year. During 2024, the Company contributed 100% of the first 3% of eligible employees’ compensation as defined by the Plan agreement. The Company may, at its discretion, make a profit-sharing contribution to the Plan on an annual basis. The Company made no profit-sharing contributions for the plan year ended December 31, 2024.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

## CHT USA 401(k) Profit Sharing Plan

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of plan earnings, and is charged with the participant's withdrawals and an allocation of plan losses and administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in all contributions plus actual earnings thereon.

##### **Payment of Benefits**

Upon separation from service with the Company due to death, disability, retirement, or termination, a participant (or their beneficiaries upon death of the participant) may elect to receive a lump-sum distribution equal to their vested account balance.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

##### **Participant Loans**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one loan outstanding at any point in time. The loans bear interest at the prime rate plus 1%. The interest rate remains fixed throughout the duration of the loan. Principal and interest are paid ratably through biweekly payroll deductions. If a participant terminates employment with the Company, the participant must pay the outstanding balance of the loan. If the loan is not repaid, it will be treated as a taxable distribution from the Plan.

## Notes to Financial Statements (continued)

### **1. Description of Plan (continued)**

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

#### **Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred.

#### **Contributions**

Participant contributions and the matching employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

#### **Risks and Uncertainties**

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statement of net assets available for benefits.

#### **Subsequent Events**

Plan management has evaluated subsequent events for recognition and disclosure through August 28, 2025, which is the date the financial statements were available to be issued.

#### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, an affiliate of Ascensus Trust Company (the trustee of the Plan).

#### **4. Fair Value Measurements**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1) and gives the lowest priority to unobservable inputs (Level 3). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or a liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

#### **Mutual Funds**

The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges.

#### 4. Fair Value Measurements (continued)

##### Collective Trusts

The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The Primary investment objective of the Collective Trust is to preserve principal while generating earnings at rates competitive over time with short-term high-quality fixed income investments, while maintaining sufficient liquidity to provide Participant-Directed withdrawals.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Party-in-Interest Transactions**

Notes receivable from participants reflect party-in-interest transactions.

Investment management expenses paid by the Plan to CAPTRUST (a service provider), which are reflected as a reduction of the Plan's investment return, qualify as party-in-interest transactions. Such transactions are in accordance with ERISA provisions.

#### **6. Tax Status**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt. As such, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
