### Note 1 – Plan Description

---

The following description of the Commonwealth Senior Living 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Commonwealth Senior Living, LLC (the “Company”) and affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

#### *Eligibility*

All employees not in specifically excluded categories, such as leased employees, are eligible to participate in the Plan upon reaching age 18 and satisfying 3 consecutive months of service. After 1 year of service, participants are eligible to receive the employer safe harbor matching and nonelective profit-sharing contributions, as defined. Entry dates for employer nonelective profit-sharing contributions are the first day of January, April, July, and October.

#### *Contributions*

Each year, participants may contribute up to the maximum allowed by law of their compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. All voluntary contributions are made by payroll deductions. The Company makes a safe-harbor matching contribution equal to 100 percent of a participant’s elective deferrals that do not exceed 4 percent of the participant’s compensation. The Company may make a discretionary profit-sharing contribution to eligible participants working at least 1,000 hours during the Plan year and employed on the last day of the Plan year. No profit-sharing contributions were made by the Company for the year ended December 31, 2024. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor matching contributions, allocations of the Company’s profit-sharing contribution, if applicable, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative fees paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their contributions and all employer contributions plus actual earnings thereon.

### *Payment of Benefits*

Upon termination of service, attainment of retirement age, or in the case of death or disability, participants may receive their accrued benefits in a single lump sum that can be rolled over into another qualified plan or paid in cash to the participant. If the participant's balance is under \$7,000 upon termination, the participant's vested interest in his or her account may be automatically distributed. Participants age 59½ or older may receive in-service withdrawals from their deferral and employer funded accounts. Hardship withdrawals are also permitted, subject to the provisions described in the Plan document.

### *Notes from Participants*

Participants may borrow from their traditional account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at market rates as determined by the Plan Administrator. At December 31, 2024, the interest rate on loans ranged from 5.25% to 10.5%. Principal and interest are paid ratably through payroll deductions.

### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$89, respectively. Forfeitures can be used to reduce future employer contributions or to pay administrative expenses of the Plan. In 2024, forfeitures of \$410 were used to pay Plan expenses.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably

possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

### *Benefit Payments*

Benefits are recorded when paid.

### *Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

### *Cash*

The Plan's cash consists of funds held in accounts with the trustee which have not yet been invested.

### *Subsequent Events*

Subsequent events have been evaluated through August 22, 2025, the date the financial statements were available to be issued.

---

## **Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### Level 1 Fair Value Measurements

### Note 4 – Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.

Plan investments were managed by Vanguard Group Inc., Cetera Investment Services, and Clearstead Advisory Solutions investment advisors. Investments in funds issued and managed by these service organizations are considered party-in-interest transactions. Fees paid for administrative services were \$91,817 for the year ended December 31, 2024.

### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### Note 6 – Tax Status

The Plan was restated and amended effective November 21, 2024, to an approved prototype plan sponsored by Ascensus, L.L.C. The Internal Revenue Service (IRS) has determined and informed the pre-approved Plan Sponsor by a letter dated June 30, 2020, that the pre-approved plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Although the pre-approved plan has been amended since receiving the advisory opinion letter, the Plan Administrator and the pre-approved Plan Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the *IRC* and, therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions
