Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Employees' Profit Sharing, Savings & Investment Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Badger Liquor Co., Inc. Employees' Profit Sharing, Savings & Investment Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Badger Liquor Co., Inc. Employees' Profit Sharing, Savings & Investment Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Badger Liquor Co., Inc., De Pere Liquor Co., LLC, and Badger Wine and Spirits, LLC (collectively referred to as the "Company") who are over the age of 21 and not considered leased employees or covered under a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Retirement Plan Committee is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Eligibility

Eligible employees enter the Plan immediately upon attaining age 21 for purposes of employee deferral, as well as Company safe-harbor and additional discretionary matching contributions.

To be eligible for the Company's discretionary profit sharing contributions, employees must be over the age of 21, employed on the last day of the plan year, and have completed at least 1,000 hours of service during the plan year. Commissioned sales employees and highly compensated employees are not eligible for discretionary profit sharing contributions.

Contributions

Each year, participants may contribute to the Plan up to 50% of annual compensation, as defined in the plan document, on a pretax or Roth basis and subject to the maximum amount allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe-harbor matching contribution to the Plan equal to 100% of the first 4% of eligible compensation that a participant contributes to the Plan. The Company may make discretionary matching and/or profit sharing contributions to the Plan. For the year ended December 31, 2024, the Company made safe-harbor matching contributions to the Plan of \$1,502,255. No additional discretionary matching or profit sharing contributions were made by the Company during 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe-harbor and additional discretionary matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions and (b) plan earnings or losses. Participant accounts are reduced by withdrawals and are charged with an allocation of administrative and investment expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All actively employed participants are fully and immediately vested in all contributions, plus actual earnings thereon. Participants who terminated employment prior to January 1, 2016, remain subject to prior vesting provisions.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability retirement, death, and termination of employment with vested interests. Benefit payments or involuntary cash-out distributions are paid to participants in the form of a lump-sum distribution or substantially equal installments. In addition, hardship distributions out of the participants' voluntary or rollover accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 65. Participants may withdraw amounts from their rollover accounts at any time.

Forfeitures

Plan forfeitures arise as a result of participants terminating service with the Company before becoming 100% vested in the Company's contributions. Forfeited nonvested account was \$2,087 at December 31, 2024. There were no forfeited nonvested accounts at December 31, 2023. Forfeitures can be used to offset Company contributions or to pay plan expenses. There were no forfeitures used during the year ended December 31, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Management Fees

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment management fees and included in net investment income on the accompanying statement of changes in net assets available for benefits. Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. Fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

The Plan receives revenue sharing income from the Plan's investment in certain mutual funds, which is included in net appreciation in fair value of investments. There is no revenue sharing income included in investments on the statements of net assets available for benefits at December 31, 2024 and 2023. For the year ended December 31, 2024, there was no revenue sharing income used to offset administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through August 25, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including non-interest-bearing cash, due to broker for securities purchased, and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Personal Trust Company, FSB ("FPTC"), the custodian of the Plan.

Note 5: Tax Status

The Plan has adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document as then designed is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

Note 6: Party-in-Interest Transactions

National Exchange Bank and Trust ("NEBT") is the trustee, as defined by the Plan; therefore, transactions with NEBT qualify as party-in-interest transactions. The Plan paid NEBT \$62,500 in fees during 2024. The Nyhart Company, Inc. ("Nyhart") is the recordkeeper, as defined by the Plan; therefore, transactions with Nyhart qualify as party-in-interest transactions. The Plan paid Nyhart \$223,037 in fees during 2024. ProManage, LLC ("ProManage") serves as investment advisor to the Plan and, therefore, transactions with ProManage qualify as party-in-interest transactions. The Plan paid ProManage \$23,030 in fees during 2024.

Certain fees incurred by the Plan for investment-related expenses are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
