### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Lydia Security Monitoring, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### **Note 1: Description of Plan**

The following description of the Lydia Security Monitoring, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was established on January 1, 1996 and restated effective February 3, 2015 and is sponsored by Lydia Security Monitoring, Inc. and its affiliates, Sutherland Capital Management Inc., Ferrol, Inc. and SNIIP LINK, LLC herein referred to as "the Companies." The Plan is a defined contribution plan covering all employees of the Companies who have completed one year of service, a minimum of 1,000 hours and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute up to 25% of their pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, in accordance with the Internal Revenue Code. Employee-elected salary deferrals are limited to \$23,000, plus up to \$7,500 for a catch-up contribution for the calendar year ended December 31, 2024. Qualified distributions from other retirement plans can also be contributed to the Plan and retained as a rollover contribution. The Companies make a matching contribution up to 50% on the first 8% of the employee's elective deferral of pre-tax compensation. The Plan administrator may limit the amount of contributions if it is determined that such limitation is necessary to comply with the requirements of Internal Revenue Code Section 401(k).

#### **Participant Accounts**

Each participant's account is credited with the employee-elected salary deferral contribution, employer matching contributions, qualified distributions from other retirement plans and an allocation of Plan earnings, (and charged with an allocation of administrative expenses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants' contributed funds arising from salary reductions and the earnings thereon, are fully vested at all times. Participants are 0% vested in employer contributions for their first three years of service. After three years of service, the employer contributions to each participant's account are deemed 100% nonforfeitable and fully vested.

### **Note 1: Description of Plan (Continued)**

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Upon termination of service because of retirement, disability, death or termination, a participant may elect to receive benefits either in a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a certain period, or defer payment up to age 65.

During the year, the Plan was amended to arrange for the automatic rollover of accounts, subject to involuntary distributions, to an IRA established by Fidelity ("the recordkeeper"), an affiliate of the recordkeeper or a third party with whom the recordkeeper maintains connectivity of services.

#### **Forfeitures**

Under the Plan, forfeited nonvested contributions may be used to reduce future employer contributions or pay plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3 and \$15, respectively. For the year ended December 31, 2024, \$13,470 of forfeitures were used to reduce employer contributions.

### **Note 2: Summary of Significant Accounting Policies**

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States and have been consistently applied in the preparation of the financial statements.

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to use estimates and assumptions that affect the accompanying financial statement amounts and disclosures. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Net realized gains and losses and unrealized appreciation or depreciation in fair value of investments is reported in the Statement of Changes in Net Assets Available for Benefits as net appreciation/depreciation in the fair value of investments. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain Plan expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to investment transactions, administration of notes receivable and benefit payments are paid by the Plan.

#### **Expense Offset Arrangements**

Fees incurred by the Plan for investment management services or recordkeeping are included in net appreciation/depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Note 3: Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4: Fair Value Measurements (Continued)

*Common collective trust fund:* Valued at the net asset value (NAV) of units of Fidelity Advisor Stable Value Fund, an investment fund offered by Fidelity (the Trustee). The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Note 5: Tax Status

The Internal Revenue Service has determined and informed the Companies by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### Note 6: Related-Party Transactions and Party-in-Interest Transactions

A portion of the Plan investments at December 31, 2024 and 2023 are shares of mutual funds and common collective trusts managed and/or held by Fidelity Management Trust Company, the Trustee. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

Fidelity Investments Institutional is the recordkeeper for the plan and, therefore, fees paid to them also qualify as party-in-interest transactions. Fees paid directly by the Plan to Fidelity Investments Institutional for recordkeeping services amounted to \$4,363 for the year ended December 31, 2024.

Certain fees incurred by the Plan for investment-related services are included in net appreciation/depreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. These amounts totaled \$33,161 for the year ended December 31, 2024 to Citizens Bank North America for Investment Management Services.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 7: Plan Termination

Although the Companies have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate their participation in the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their share of employer contributions and earnings thereon.

### **Note 9: Risks and Uncertainties and Concentration of Investments**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, three investment securities represented 39% and 37% of Plan net assets, respectively.

### **Note 10: Excess Contributions Payable**

Benefits paid to participants in 2024 and 2023, include payments of \$41,114 and \$34,544, respectively, to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. These amounts are recorded in the Plan's Statement of Net Assets Available for Benefits as excess contributions payable at December 31, 2024 and 2023.

### **Note 11: Subsequent Events**

In preparing these financial statements, management has evaluated events and transactions for potential recognition or disclosure through August 15, 2025, which is the date the financial statements were available to be issued.
