Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of EI & EI Wood Products 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of EI & EI Wood Products 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 DESCRIPTION OF PLAN

The following description of El & El Wood Products 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was adopted by El & El Wood Products Corp. (the Company), effective January 1, 2011, and is subject to the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986 (IRC), as amended. The purpose of the Plan is to provide retirement benefits for substantially all employees of the Company who have reached the age of 21 and have performed 30 days of service.

Acquisition of Plan Sponsor and Plan Termination

In April 2022, El & El Wood Products Corp. announced its planned acquisition of the Company. As of the date of acquisition, plan participants became employees of Metrie which made them immediately eligible to participate in the Metrie 401(k) Retirement Savings Plan. Coinciding with the acquisition, all participants in the Plan are now considered terminated. Since there are no longer any eligible participants in the Plan, the Plan is effectively frozen as of this date. In January 2023, management approved a plan of liquidation and resolved to terminate the plan effective December 31, 2022. Management is actively working on administrative steps to distribute all Plan assets to participants by the end of 2025. Participants were notified of distribution options on April 30, 2025. The option included rolling over their vested account balance to another eligible retirement plan with no tax penalties, rolling over their vested account balance to an individual retirement account with no penalties, or having their vested account balance sent directly to them as a lump sum distribution which is subject to mandatory tax withholding and may be subject to an early withdrawal penalty. In accordance with the plan termination, distribution requests are being process and forfeitures are being used to pay any outside expenses. Any remaining forfeitures were reallocated to the participants on a pro-rata basis. In August 2025, \$98,239 was allocated to participants on a pro-rata basis of their account balances to the total balances as of August, 8, 2025.

Contributions

Prior to Plan termination, participants may elect to contribute up to 100% of their pre-tax annual compensation not to exceed the maximum deferral limitation, as defined by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Contributions (Continued)

The Company may make profit sharing contributions at the discretion of its Board of Directors. The Plan requires participants to complete 1,000 hours of service to become eligible to participate in the profit sharing part of the Plan. After meeting the service requirement, participants may enter the profit sharing part of the Plan on either January 1 or July 1 of the Plan year. In addition to being eligible to receive an allocation of profit sharing contributions, participants are required to be employed by the Company on the last day of the year. For the year ended December 31, 2024, the Company did not make any made profit sharing contributions to the Plan. Contributions were discontinued as a result of the plan termination on December 31, 2022.

Participants direct the investment of their contributions into various investment options offered by the Plan and may change their investment allocations at any time.

Participant Accounts

Prior to Plan termination, each participant's account is credited with the participant's contributions and allocations of (a) Company contributions and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Some of the general Plan administrative expenses are paid by the Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Prior to Plan termination, participants are immediately vested in their contributions plus actual earnings thereon. Profit-sharing contributions and earnings thereon are subject a two-year cliff vesting requirement whereby such contributions become 100% vested after two years of service and are completely forfeited if the two-year service requirement is not met. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability. At the time of Plan termination, December 31, 2022, all participants became fully vested.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum distribution equal to the vested portion of his or her account or installments over the life of the participant or designated beneficiary, as defined in the Plan document. For termination of service for other reasons, a participant will receive the value of the vested interest in his or her account as a lump sum distribution. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59½, a participant is allowed to withdraw certain funds from the Plan.

Forfeitures

Forfeitures of the employees' nonvested portion of the Company's contributions may be used to reduce future Company contributions or pay for Plan expenses. At December 31, 2024 and 2023, the Plan's forfeited nonvested balances totaled \$136,012 and \$134,117 respectively. There were no forfeitures used to pay Plan expenses or to reduce future Employer contributions for the year ended December 31, 2024.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Additionally, certain administrative functions related to the Plan are performed by officers or employees of the Company; however, neither the Company nor any officer or employee received compensation from the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

In January 2023, management approved a plan of liquidation and determined liquidation of the Plan is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 and 2024 financial statements. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities measured would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. As of December 31, 2024, accrued costs expected to be incurred of \$58,712 and accrued investment income of \$67,828 expected to be earned, were recorded under the liquidation basis as the amount was reasonably estimable.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

The Plan's mutual fund and fixed annuity investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Fair value of the Plan's collective trust investments are measured using net asset value (NAV) per share as a practical expedient. Each unit in a collective trust invests directly in a unit of the underlying investment. Unit values are calculated based on the observable NAV per share of the underlying investments in the funds (see Note 9).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The process of preparing financial statements in accordance with U.S. GAAP requires the use of estimates and assumptions regarding certain types of assets and liabilities, revenues and gains, and expenses and losses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

NOTE 3 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, Empower Annuity Insurance Company of America, the custodians of the Plan. Net appreciation (depreciation) in fair value of investments, dividends, and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, Empower Annuity Insurance Company of America, the custodians of the Plan.

NOTE 5 TAX STATUS

The Plan is based on a pre-approved profit-sharing plan under a cash or deferred arrangement, and the Internal Revenue Service (IRS) issued a favorable opinion letter, stating that the pre-approved plan was designed in accordance with the provisions of the IRC. The Plan has not yet filed for its own determination letter from the IRS. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The related trust, therefore, is not subject to tax under present income tax law. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore also believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions.

NOTE 6 PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In January 2023, management resolved to terminate the plan effective December 31, 2022 and is actively working on administrative steps to distribute all remaining Plan assets by July 31, 2025. Upon termination, all participants became immediately 100% vested in their accounts.

NOTE 7 PARTIES IN INTEREST

The Plan's investments in fixed annuities were managed by Empower during the year ended December 31, 2024. Empower was the Plan's custodian; therefore, these investments qualify as party-in-interest transactions. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

NOTE 8 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There has been no change in the methodology used at December 31, 2024 and 2023. The following is a description of the valuation methodology used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds: Valued at the net asset value of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

Fixed Annuity Contract: Value is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations while considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
