## NOTES TO FINANCIAL STATEMENTS

### Allen Aircraft Products, Inc. 401(k) Profit Sharing Plan

#### 1 Description of Plan

The following description of the Allen Aircraft Products, Inc. 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### *General:*

The Plan, which began April 15, 1986, is a defined contribution plan covering all employees of Allen Aircraft Products, Inc. (“Company”) who meet the service requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan was restated effective December 7, 2020 to comply with Department of Labor (“DOL”) regulations and incorporate all previous amendments.

Effective January 1, 2025, the Plan was restated to make the Plan safe harbor.

##### *Eligibility:*

Employees who are members of a collective bargaining unit are excluded from Plan participation. All other employees are eligible to become participants on the first day of the quarter after completing six consecutive calendar months of service, including 500 hours, after their date of hire.

The Plan allows for automatic enrollment upon initial entry into the Plan. Upon enrollment, 3% of compensation per payroll period is withheld, unless the participant affirmatively elects a different percentage.

##### *Contributions:*

Participants may elect salary reduction contributions of up to 50% of their base pay, which includes overtime and bonuses. Catch-up contributions are allowed in accordance with Internal Revenue Service guidelines. The employer matching contribution is equal to 100% of the first 3% of the participant's salary reduction contributions.

At the end of each Plan year, the Company may provide a contribution on a discretionary basis on behalf of all eligible employees irrespective of salary reduction contributions for the Plan year. These contributions are referred to as non-matching contributions. Participants share in the non-matching contributions if they were employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year. For the years ended December 31, the Company contributed \$100,000 (2024) and \$100,000 (2023) of non-matching contributions.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

**1 Description of Plan, Continued**

***Allocation of Non-Matching Contributions and Forfeitures:***

A participant's share of forfeiture amounts from the non-vested portion of terminated participants' accounts are first used to pay expenses and then allocated in proportion to each participant's annual compensation as compared with the aggregate compensation of all participants for the Plan year. Total forfeitures allocated to participants were \$4,047 (2024) and \$4,896 (2023). Forfeitures due to termination from the Plan before a participant is 100% vested shall be allocated to remaining participants in the same manner as the employer's contribution. Forfeitures for the years ended December 31, 2024 and 2023 were \$113,419 and \$53,725, respectively.

A participant's share of non-matching contributions from the Company is allocated based on job classification allocations.

A participant whose employment is terminated before the end of a Plan year does not share in non-matching contributions unless termination is due to death, disability, or retirement.

Rollover contributions from other plans are also accepted.

Participants having 10 years of vested service are eligible to receive distributions before normal retirement age if they elect early retirement on or after age 55.

***Vesting:***

A participant's salary reduction and rollover contributions are fully vested. Employer matching and non-matching contributions are vested as follows:

***Notes Receivable from Participants:***

Loans are valued at unpaid principal balance plus accrued interest. The Plan permits participants to borrow against their vested interest in the Plan. The maximum loan amount available within any 12-month period is the lesser of (i) \$50,000 or (ii) 50% of the participant's vested interest in their account. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

## NOTES TO FINANCIAL STATEMENTS

### Allen Aircraft Products, Inc. 401(k) Profit Sharing Plan

#### 1 Description of Plan, Continued

##### *Notes Receivable from Participants, Continued:*

Generally, loans must be repaid within five years and bear interest at rates equivalent to those charged by local lending institutions. Principal and interest are paid ratably through payroll deductions. The availability of hardship withdrawals and further limitations are discussed in greater detail in Plan documents.

##### *Payment of Benefits:*

Upon termination of service by reason of retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account. Benefit payments to participants are recorded upon distribution.

##### *Hardship Withdrawals:*

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

##### *Investment Options:*

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

#### 2 Summary of Significant Accounting Policies

##### *Basis of Accounting:*

The Plan's transactions are reported on the accrual basis of accounting.

##### *Valuation of Investments:*

Investments held in the Plan are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### *Use of Estimates:*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

## NOTES TO FINANCIAL STATEMENTS

#### **2 Summary of Significant Accounting Policies, Continued**

##### ***Administrative Fees:***

Certain professional fees of the Plan were paid on behalf of the Plan by the Company. Administrative fees are paid directly from investment earnings. Plan forfeitures may also be used to pay reasonable Plan expenses.

##### ***Risks and Uncertainties:***

The Plan includes investments in mutual funds and common collective trust funds holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

##### ***Plan Termination:***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

##### ***Contributions:***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### ***Subsequent Events:***

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through August 8, 2025, which is the date the financial statements were available to be issued.

#### **3 Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

#### 3 Tax Status, Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

#### 5 Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and common collective trust funds managed by Putnam Fiduciary Trust Company, an affiliate of Great-West Trust Company. Usual and customary fees were paid by the mutual fund for the investment management services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest transactions.

#### 6 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for identical assets or similar assets or liabilities in inactive markets
- \* Inputs other than quoted prices that are observable for the asset or liability
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds:***

The fair value of the mutual funds is based on quoted market prices.

#### ***Common Collective Trust Funds:***

The fair value of the common collective trust funds is based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. Short-term securities with remaining securities of 60 days or less, are valued at amortized cost. These fall into the Level 2 category of the valuation hierarchy.

For the S&P 500 Fund, subscriptions to the fund will be accepted on a daily basis. Units will be credited based upon the net asset value per unit as of the close of the business on the date the subscription is received by the Trustee. Withdrawals generally will be permitted daily at a redemption price equal to the net asset value per units redeemed, as determined by the Trustee. Withdrawals request must be received by the Trustee prior to the closing of the New York Stock Exchange on the date on which the withdrawal is desired in order to receive the net asset value per unit for such date.

For the Stable Value Fund, the Fund invests in high-quality guaranteed investment contracts ("GICs") and similar contracts issued by insurance companies, banks, and other financial institutions. The Fund is valued on a daily basis by the Stable Value trustee. All income and expenses shall be deemed to be accrued, received, or paid at an equal rate from day to day. Contributions and redemptions to the Fund may be made daily at the current net asset value and are considered as made immediately after the daily valuation.
