## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Fidelity Deposit & Discount Bank Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### NOTE 1 Description of plan

The following description of Fidelity Deposit & Discount Bank Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Fidelity Deposit & Discount Bank (the "Company"), who have 0.25 years of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Trustee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Each year, participants in the Plan may contribute up to 100% of pretax compensation, as defined. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan also provides for a Qualified Automatic Contribution Arrangement ("QACA") for all employees hired by the Company subsequent to December 31, 2007 whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The QACA contribution as defined provides for a 3% employee contribution in the initial employment period and period two, a 4% employee contribution in period three, a 5% employee contribution in period four and a 6% employee contribution for period five and future periods as defined. The Company makes matching contributions of 100% of the first 6% of compensation that a participant contributes to the Plan. The Plan also provides for a discretionary Company profit sharing contribution. There was no profit-sharing discretionary contribution in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant accounts

A separate account is maintained for each participant. Each participant's account is credited or charged with the participant's contributions, QACA contributions, and company matching contributions and allocations of the Company's profit-sharing contributions, if any, Plan earnings or losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

##### Vesting

Participants are vested immediately in their contributions, including QACA contributions, plus actual earnings thereon.

Vesting for the Company's employer matching contributions, company profit sharing contributions, and earnings is according to a cliffed vesting schedule of 0% vesting for one year of service or less and 100% vesting for more than 2 years of service.

##### Payment of benefits

On termination of service due to death, disability, or retirement a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments or a form of an annuity. For termination of service for other reasons a participant will receive the value of the vested interest in his or her account as a lump sum distribution. Distributions between \$1,000 and \$5,000 are automatically rolled over to an IRA unless the participant directs otherwise. Benefits are recorded when paid.

##### Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,421 and \$16,499, respectively. Also, in 2024, forfeitures from nonvested accounts resulted in an increase in the forfeiture account of \$20,716 and employer contributions and administrative expenses reduced by \$15,794 and \$10,000, respectively, from forfeited nonvested accounts.

##### SECURE 2.0 Act

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for the provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

##### NOTE 2 Summary of significant accounting policies

##### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment committee determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income, if any, is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

### Expenses

Investment management and recordkeeping service fees are borne by Plan participants. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are reflected in net appreciation of fair value of investments.

### NOTE 3 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* The stable value collective trust fund is composed primarily of fully benefit-responsive investment contracts that is valued at net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer currently reserves the right to require 60 days' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. As of December 31, 2024 and 2023, the Plan did not have any unfunded commitments related to the collective trust fund.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 4 Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Company's contribution portion of their accounts.

### NOTE 5 Tax status

The Plan is a standardized prototype plan for which the prototype sponsor obtained a determination letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust were in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving this letter, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

Plan management is required to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 6 Related party transactions and party in interest transactions

Certain Plan investments are shares of mutual funds managed by John Hancock Trust Company, LLC, the "trustee" and, therefore these transactions qualify as party in interest transactions. Fees incurred and paid directly by the Plan for certain administrative expenses at December 31, 2024 were \$65,332. Investment related expenses are included in net appreciation in fair value of investments.

The trustee provides certain administrative services to the Plan pursuant to Service Agreements between the Company and the trustee. The trustee receive revenue from certain service providers for services the trustee provides to the funds. This revenue is used to offset certain amounts that would be owed to the trustee from the Plan for their administrative services to the Plan had the arrangements with the service providers not been in place.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

### NOTE 7 Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect
