Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the Fisher & Thompson, Inc. 401(k) Trust an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C)(ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the 2024 financial statements.

Opinion on the 2024 Financial Statements

- The amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Notes to Financial Statements

Note 1 – Plan Description

The following description of the Fisher & Thompson, Inc. 401(k) Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan, established January 1, 2009, restated on January 1, 2023, is a defined contribution plan covering all eligible employees of Fisher & Thompson, Inc. (the Company) and provides for retirement, death, and disability benefits. Employees of the Company who have completed 1 year of service and have attained the age of 21 are eligible to participate in the Plan. The plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s offerings and monitors investment performance.

Contributions – Participants may elect to contribute up to 100% of eligible compensation, not to exceed the annual amount permitted by Federal law. Catch-up contributions are permitted for eligible participants age 50 or older by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company matches participant contributions to the Plan. For the year ended December 31, 2024, the Company matched 50% of employee elective deferrals up to a maximum of 6% of the employee elective deferrals. The Company made matching contributions of \$254,844 for the year ended December 31, 2024.

The Company may also make discretionary employer profit sharing contributions at the option of its Board of Directors. There were no such profit sharing contributions made for the year ended December 31, 2024. Additionally, the Company may make a qualified non-elective contribution that is sufficient to satisfy certain required regulations.

Participant Accounts – Each participant's account is credited with the participant's contribution and the participant's share of the employer contributions, an allocation of Plan earnings or losses based on the participant's directed investment accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investments for their account.

Vesting – Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Participants are vested in employer contributions based on years of continuous service as follows:

A participant is 100% vested after six years of credited service.

Payment of Benefits – Upon termination of service, a participant may elect to receive either a lump-sum distribution equal to the vested value of his or her account or a partial distribution. Automatic distributions will be made to terminated participants with vested balances less than \$1,000. If a terminated participant's vested balance is in excess of \$1,000 but not greater than \$5,000, the plan administrator will make the distributions to an individual retirement account (IRA) absent a distribution directive from the participant. If the terminated participant's vested account balance exceeds \$5,000, a written request from the participant is required before distribution. A participant may also elect to have the amount rolled into an IRA or another qualified plan. Hardship withdrawals are permitted from fully vested employee deferral accounts. In-service distributions are permitted for participants who have reached age 59 ½.

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$19,880 and \$6,493, respectively. These amounts can be used to reduce Plan administrative expenses or reduce employer contributions. Forfeitures used to reduce Plan expenses totaled \$0 for the year ended December 31, 2024.

Note 2 – Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's trustee. Mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. The money market funds are valued at the quoted redemption value at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investment income is recorded on the accrual basis. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statements of changes in net assets available for benefits.

Note 2 – Significant Accounting Policies – Continued

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through August 25, 2025, which is the date the financial statements were available to be issued.

Note 3 – New Accounting Standards

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

Note 4 – Investments

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought, sold, and held during the year) appreciated in value by \$560,249.

Note 5 – Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 5 – Fair Value Measurements – Continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds: Valued at the quoted redemption price at year end.

Mutual Funds: Valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination or partial plan termination, participants will become 100 percent vested in their accounts.

Note 7 – Parties-In-Interest Transactions

Administrative expenses were paid to Capital Bank and Trust. Capital Bank and Trust is the trustee and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid to Capital Bank and Trust by the Plan totaled \$550 for the year ended December 31, 2024.

Note 8 – Tax Status

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The opinion letter stated that the Prototype Plan, as then designed, is in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype has been amended since receiving the determination letter for various amendments. However, the plan administrator and third-party administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and the Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Information Prepared and Certified by Trustees

Note 10 – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
