## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of The Bank of Princeton Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Bank of Princeton (the Bank) established the Plan on January 1, 2021. A Plan Committee (the Committee) appointed by the Board of Directors of the Company makes rules, regulations, computations, interpretations, and decisions, and maintains records and accounts, as is necessary to administer the Plan. TI-Trust, Inc. is the Plan's Trustee (Trustee). Blue Ridge ESOP Associates is the Plan's recordkeeper.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the IRC).

Effective January 10, 2023, Princeton Bancorp, Inc. (the Company), a corporation formed by the Bank, acquired all of the outstanding stock of the Bank in a corporate reorganization. As a result, the Bank became the sole direct subsidiary of the Company, the Company became the holding company for the Bank and the stockholders of the Bank became stockholders of Company. In the reorganization, each share of the Bank's common stock converted into one share of the Company's common stock.

#### **Eligibility**

Employees are eligible on the first day of the month after they attain the age of twenty-one and complete 1,000 hours of service during a consecutive six-month period. Employees who were twenty-one years of age on January 1, 2021, were automatically eligible to participate in the Plan.

#### **Voting Rights**

Shares of Company stock which have been allocated to Participants' accounts shall be voted by the Trustee in accordance with the Participants' written instructions. The Trustee is required to vote any allocated shares for which the Trustee has not timely received written instruction regarding voting and all unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

**1. Description of the Plan (continued)**

**Contributions and Participant Accounts**

The Bank may make contributions to the Plan in amounts determined by the Bank's Board of Directors. Participant contributions, including rollover contributions and trustee-to-trustee transfers, are not allowed. Cash contributions made to the Plan will be used to purchase voting common stock of the Company.

During 2024, the Bank approved a discretionary cash contribution of \$331,000.

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee. Except for terminations due to death, disability or the attainment of normal retirement age of 65, only those participants who are eligible employees of the Bank as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Receivables from the Bank for cash contributions, if any, are unsecured.

**Payment of Benefits**

A participant whose employment terminates for any reason shall receive the entire vested portion of their account in the Plan year following the termination.

Distributions of participant accounts of \$1,000 or less will be paid in a single lump sum. Effective January 1, 2024, the Committee will roll over distributions of terminated participant accounts greater than \$1,000 but not more than \$7,000 (previously \$5,000), who do not affirmatively elect within 30 days after receiving the appropriate notices, to an individual retirement account (IRA) designated by the Committee.

Effective January 1, 2024, participants may elect to defer the distribution of their accounts if it is in excess of \$7,000 (previously \$5,000) until April 1 following the calendar year in which they attain age of 73 (previously 72) or the year in which they retire, whichever is later.

If the Committee so provides, a participant may elect that their benefits be distributed in the form of Company stock, cash or a portion thereof.

**Vesting**

If a participant's employment with the Bank ends for any reason other than death, disability or attaining normal retirement age, the participant will vest in the balances in their account based on total years of service with the Bank.

**Put Option**

The Plan's Company stock includes a put option. The put option is a right to demand that the Bank purchase the Company stock for its current fair market value. However, the put right shall not apply to the extent that the Company stock, at the time the put right would otherwise be exercisable, may be sold on an established market in accordance with federal and state securities laws and regulations.

**Forfeitures**

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Plan forfeitures are generally allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures in cash totaled \$244 during 2024 and 543 shares of Company stock were reallocated to eligible participants as of December 31, 2024.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

**2. Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition**

The shares of Company common stock are reported at fair value. See note 4 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefits Paid to Participants**

Benefits are recorded when paid.

**Plan Expenses**

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Bank.

**Subsequent Events**

The Plan has evaluated subsequent events through July 28, 2025, the date the financials were available to be issued.

  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy for assets and liabilities is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Common stock:* Valued at the daily closing price as reported by The Nasdaq Global Select Market. The common stock is registered with the Securities and Exchange Commission and actively traded.

**5. Dividends**

The Bank declared and paid cash dividends of \$0.30 per share to the Plan in each quarter during the year ended December 31, 2024. Dividends are allocated to participants based on their number of outstanding shares.

**6. Related Party Transactions and Party-in-Interest Transactions**

The Trustee or Bank pays all plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions.

**8. Tax Status**

The Company believes the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC and is therefore, not subject to tax under present income tax law. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with the investment in the common stock, it is reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
