### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Clever Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Clever Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### **Note 1 – Description of the Plan**

The following description of the Clever Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

**General** –The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Clever Inc., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA)

The Company is the plan sponsor and plan administrator. The Plan is administered by Company employees who are responsible for selecting investment options offered under the Plan and monitoring investment performance.

**Eligible participants** – Eligible employees, age 21 or older as defined by the Plan, may participate in the Plan any time as of their date of hire.

**Contributions** – Participants may make contributions to the Plan through pre-tax or post-tax salary reductions up to 80% of annual compensation, as defined, subject to certain limitations under the Code. Participants who have reached the age of 50 may elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

The Company may make discretionary employer match and profit sharing contributions to the Plan, as determined by the Company's board of directors. The Company has not made any discretionary employer match or profit sharing contributions to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

**Participant accounts** – Participant accounts are credited with participant contributions; Company contributions, if any; rollovers; and an allocation of the Plan net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. A participant may authorize transfers among investment options at any time.

## Clever Inc. 401(k) Plan Notes to Financial Statements

---

**Vesting** – Participants are immediately vested in their contributions and profit sharing contributions, plus actual earnings and losses thereon. Vesting in the Company’s match contribution portions of their accounts is based on years of continuous service. Participants vest in these contributions based on the following schedule:

Less than 1	0%
1	25%
2	50%
3	75%
4 or more	100%

**Notes receivable from participants** – Participants may borrow up to one half of their account balance up to \$50,000 for a period not to exceed five years, except for notes used to purchase a primary residence, for which a longer term may be granted. Participant notes are evidenced by a written note, secured by the balance in the participant’s account, and bear interest at a rate that is commensurate with local prevailing rates, as determined by the plan administrator under the note policy. Participants may not have more than one note outstanding at any time. Repayment of principal and interest is generally made through payroll deductions. Outstanding notes receivable at December 31, 2024, carried an interest rate ranging from 6.50% to 9.50% with a maturity through June 2029.

Notes receivable from participants would be measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes would be reclassified as distributions based upon the terms of the Plan Agreement.

**Payment of benefits** – On termination of service, benefits are paid in a lump-sum cash distribution equal to the value of the participant’s account. Accounts below \$1,000 may be automatically distributed directly to participants without participant approval. All distributions are subject to the applicable provisions of the Plan Agreement. Benefits are recorded when paid.

**Plan expenses** – Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund’s prospectus. All such fees are charged directly against the fund’s investment performance and, thus, are not separately disclosed in the accompanying financial statements. Certain account maintenance fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan’s financial statements.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The Plan’s financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's trustee, Fidelity Management Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments consists of both the realized and unrealized gains and losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation.

**Subsequent events** – Subsequent events have been evaluated through the date of the independent auditor's report, August 27, 2025, which is the date the financial statements were approved by the Plan and available to be issued.

### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation technique used for assets measured at fair value. There had been no change in the technique used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds and money market fund)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Stable value fund* – A collective trust that is composed primarily of fully benefit-responsive investment contracts that is valued using the net asset value (NAV) practical expedient, an estimate of fair value. This NAV practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The T. Rowe Price Stable Value Fund can be redeemed daily and there are no redemption restrictions or notice requirements.

The valuation method used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4 – Tax Status

The Plan has adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 5 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividends and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year), except for participant loans.

### **Note 6 – Party-in-Interest Transactions**

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore transactions with this entity qualify as exempt party-in-interest transactions.

### **Note 7 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

### **Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA.

#### **Note 1 – Description of the Plan**

The following description of the Clever Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

**General** –The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Clever Inc., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA)

The Company is the plan sponsor and plan administrator. The Plan is administered by Company employees who are responsible for selecting investment options offered under the Plan and monitoring investment performance.

**Eligible participants** – Eligible employees, age 21 or older as defined by the Plan, may participate in the Plan any time as of their date of hire.

**Contributions** – Participants may make contributions to the Plan through pre-tax or post-tax salary reductions up to 80% of annual compensation, as defined, subject to certain limitations under the Code. Participants who have reached the age of 50 may elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

The Company may make discretionary employer match and profit sharing contributions to the Plan, as determined by the Company's board of directors. The Company has not made any discretionary employer match or profit sharing contributions to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

**Participant accounts** – Participant accounts are credited with participant contributions; Company contributions, if any; rollovers; and an allocation of the Plan net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. A participant may authorize transfers among investment options at any time.

**Vesting** – Participants are immediately vested in their contributions and profit sharing contributions, plus actual earnings and losses thereon. Vesting in the Company’s match contribution portions of their accounts is based on years of continuous service. Participants vest in these contributions based on the following schedule:

**Notes receivable from participants** – Participants may borrow up to one half of their account balance up to \$50,000 for a period not to exceed five years, except for notes used to purchase a primary residence, for which a longer term may be granted. Participant notes are evidenced by a written note, secured by the balance in the participant’s account, and bear interest at a rate that is commensurate with local prevailing rates, as determined by the plan administrator under the note policy. Participants may not have more than one note outstanding at any time. Repayment of principal and interest is generally made through payroll deductions. Outstanding notes receivable at December 31, 2024, carried an interest rate ranging from 6.50% to 9.50% with a maturity through June 2029.

Notes receivable from participants would be measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes would be reclassified as distributions based upon the terms of the Plan Agreement.

**Payment of benefits** – On termination of service, benefits are paid in a lump-sum cash distribution equal to the value of the participant’s account. Accounts below \$1,000 may be automatically distributed directly to participants without participant approval. All distributions are subject to the applicable provisions of the Plan Agreement. Benefits are recorded when paid.

**Plan expenses** – Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund’s prospectus. All such fees are charged directly against the fund’s investment performance and, thus, are not separately disclosed in the accompanying financial statements. Certain account maintenance fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan’s financial statements.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The Plan’s financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's trustee, Fidelity Management Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments consists of both the realized and unrealized gains and losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation.

**Subsequent events** – Subsequent events have been evaluated through the date of the independent auditor's report, August 27, 2025, which is the date the financial statements were approved by the Plan and available to be issued.

### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation technique used for assets measured at fair value. There had been no change in the technique used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds and money market fund)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Stable value fund* – A collective trust that is composed primarily of fully benefit-responsive investment contracts that is valued using the net asset value (NAV) practical expedient, an estimate of fair value. This NAV practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The T. Rowe Price Stable Value Fund can be redeemed daily and there are no redemption restrictions or notice requirements.

The valuation method used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
