Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hicuity Health and Critical Care Services Retirement Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Note 1. Description of the Plan

The following description of the Hicuity Health and Critical Care Services Retirement Savings Plan (the “Plan”), provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan’s provisions, which are available from the Plan Administrator.

General

The Plan, which became effective January 1, 1992, is a defined contribution plan covering all employees, except union, leased, non-resident alien and independent contractors of Hicuity Health, Critical Care Services, PC and Critical Care Medical Services, New York, PC (collectively the “Company” or the “Employer”). Part-time employees are eligible to participate in the Plan upon achieving one year of service or at least 1,000 hours during the 12-month period immediately following the date of hire.

Employees who have completed 30 consecutive days of service and are age 21 or older are eligible to become participants in the Plan. Participants may enter the Plan for salary deferral contributions on the first day of the month coinciding with or following the satisfaction of eligibility requirements.

Plan entry dates for employer matching contributions are the quarterly entry dates of January 1, April 1, July 1, and October 1. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Charles Schwab Trust Bank serves as Plan custodian. Certain Company management serve as Trustees of the Plan.

Contributions

The Plan provides for automatic enrollment upon meeting the eligibility requirements. Participants are automatically enrolled at a default salary deferral of 5% of compensation, with an annual auto-escalation of 1% up to a maximum of 10%. Participants have the option of changing their elections or opting out of participation.

Participants may contribute up to 100% of their annual wages. Employee rollover and catch-up contributions are also permitted. Each year, the Company may make a discretionary matching contribution equal to a percentage of the amount contributed by eligible participants. The Company elected to match 100% of eligible participants’ contributions up to 1.5% of eligible compensation for the years ended December 31, 2024 and 2023, respectively. The Plan also provides for discretionary profit sharing contributions to be determined by the Company. Employees must be employed on the last day of the year to receive such contributions. During the years ended December 31, 2024 and 2023, the Company contributed \$1,754 and \$1,102 of profit sharing contributions, respectively. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution and Plan earnings and is charged with an allocation of administration expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their salary deferral contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of service. Participants become fully vested upon death, total and permanent disability, or attainment of early or normal retirement age. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce future Company contributions.

Payment of Benefits

Upon termination of service, an employee may elect to receive a lump-sum amount or substantially equal installment payments equal to the vested value of their account. Active participants who reach age 59 ½ may withdraw all or part of their vested account.

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loan is based on local prevailing rates at loan inception as determined by the Plan Administrator.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$59,421 and \$18,478, respectively. These accounts are used to reduce the employer contributions accrued at each year-end.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interests in the common collective trust funds are valued daily utilizing the values of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Plan Tax Status

The Plan Sponsor adopted a volume submitter profit sharing document which obtained a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated the form of the Plan was acceptable under the applicable requirements of the Internal Revenue Code (IRC) for use by employers for benefit of their employees. The Plan has not received a determination letter specific to the Plan itself. However, the Plan's Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Subsequent Events

Subsequent events have been evaluated through August 27, 2025, which is the date the financial statements were available to be issued.

Note 3. Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Recurring Measurements

Investments

If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan has no Level 3 investments.
