## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of the Plan

The following description of the McNichols Company Profit Sharing and 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

#### (a) General

The Plan is a defined contribution plan adopted September 30, 1967 that covers eligible employees of McNichols Company (the “Company” or the “Plan Administrator”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Vanguard Fiduciary Trust Company (“Vanguard”), the trustee, is responsible for maintaining the investments of the Plan and reporting on the earnings and investments of the Plan.

#### (b) Eligibility

Certain employees of the Company are eligible to participate in the Plan after one hour of service. Effective January 1, 2015, the Plan provided for automatic enrollment of newly hired employees at 3% of the employee’s compensation, unless an election not to participate in the Plan or to contribute an alternate percentage of compensation is made online with Vanguard. Automatic enrollment went into effect for existing employees effective April 2015, with the additional condition that any employee contributing less than 3% would have their deferral percentage increased to 3%.

Effective January 1, 2021, automatic enrollment of newly hired employees was changed to 4% of the employee’s compensation with annual increases of 1% up to 12% of employee’s compensation.

#### (c) Contributions

The Plan includes a 401(k) benefit to allow employees who have completed one hour of service to contribute amounts to their accounts up to the maximum allowed under Internal Revenue Code Section 402(g). For the year ended December 31, 2024, the maximum allowed was \$23,000. As allowed by the Internal Revenue Service, the limit on catch-up elective deferrals for participants age 50 and over was an additional \$7,500 for the 2024 plan year. In conjunction with the automatic enrollment program initiated in 2015, the Plan also provides for automatic increases of deferrals by 1% every January until a participant reaches 12%. Effective April 1, 2021, the Company increased its discretionary matching contribution to be equal to 50% of the employee’s 401(k) contribution up to a maximum of 10% of the elected contributions.

#### (1) Description of the Plan - Continued

##### (c) Contributions - Continued

The Company's profit-sharing contribution is allocated to the account of each active participant in the same proportion as such participant's total compensation bears to the aggregate compensation of all participants. During the year ended December 31, 2024, the Company's Board of Directors elected not to make a profit-sharing contribution to the Plan.

The Plan accepts rollovers and direct transfers from other tax-qualified plans.

##### (d) Participant Accounts

A separate account is maintained for each investment option of a participant. Earnings and losses of the Plan are allocated to each participant based upon the ratio of their account to the total of all participants' accounts. All allocations are made on a daily basis.

Individual participant accounts for the common /collective trust are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

##### (e) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting for Company contributions and earnings thereon is based on years of continuous service, with a participant being 100% vested after three years of credited service. A year of credited service is defined as 1,000 hours worked based on the participant's date of hire.

##### (f) Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 with a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or a reasonable period of time for the purchase of a primary residence. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. If a participant ceases to make loan repayments, the loan balance is reduced and a benefit payment is recorded.

Notes receivable from participants are valued at unpaid principal and accrued interest.

### Notes to Financial Statements - Continued

#### (1) Description of the Plan - Continued

##### (g) Payment of Benefits

In the event of the termination of employment with the Company, a participant shall be entitled to a lump sum benefit payment equal in value to the then vested interest in the participant's account as of the valuation date immediately preceding or concurring with the date of the termination of employment, and the remaining portion of the balance of the account, if any, shall be forfeited. Participants are also allowed to receive in service distributions upon reaching age 59 ½. The Plan also allows for hardship withdrawals. Benefits are recorded when paid.

##### (h) Forfeitures

Forfeitures are used to reduce future employer contributions and pay plan expenses. Forfeitures available to pay plan expenses and for reduction of future employer contributions were approximately \$60,000 and \$46,000 as of December 31, 2024 and 2023, respectively. During 2024, approximately \$60,000 of forfeitures was used to pay for plan expenses and reduce employer contributions.

#### (2) Summary of Significant Policies

##### (a) Basis of Presentation

The financial statements of the Plan are presented on the accrual basis of accounting, except for participant benefits, which are recorded when paid.

##### (b) Use of Estimates in the Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### (c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Units of the Vanguard Retirement Savings Trust are valued at net asset value at year end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

##### (c) Investment Valuation and Income Recognition - Continued

The Vanguard Retirement Savings Trust (the “Fund”) is a common/collective trust stable value fund. The Fund invests principally in guaranteed interest contracts (“GICs”) issued by insurance companies, investment contracts issued by banks, synthetic investment contracts (“SICs”) issued by banks, insurance companies, and other issuers, and securities supporting such SICs, and other similar instruments which are intended to maintain a constant net asset value. The Fund is valued by Vanguard based on the unit value of the funds. Unit values are determined by dividing the fund’s net assets, which represents the fair value of the underlying investments, by its units outstanding at the valuation dates.

##### (d) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### (e) Plan Expenses

Expenses incurred by the Plan for certain investment advisory, accounting and management fees are paid by the Plan. All other operating expenses of the Plan are paid by the Company.

##### (f) Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

#### (3) Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### (4) Income Tax Status

Effective January 1, 2021, the Plan adopted a non-standardized pre-approved profit-sharing plan, which received an opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, constituted a qualified trust under Section 401(a) of the Internal Revenue Code and was thus exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended and restated subsequent to issuance of the opinion letter. However, the Plan Administrator and management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

#### (4) **Income Tax Status - Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (5) **Information Certified by Vanguard**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Total investments, and notes receivable from participants as of December 31, 2024 and 2023, as shown in the Statements of Net Assets Available for Benefits;
- Total investment income, interest income from notes receivable from participants and related investment activity for the year ended December 31, 2024, as shown in the Statement of Changes in Net Assets Available for Benefits;
- The Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### (6) **Parties-in-Interest**

The Plan invests in shares of registered investment companies managed by an affiliate of Vanguard. Vanguard acts as trustee for only those investments as defined by the Plan. Additionally notes receivable from participants are managed by Vanguard. During 2024, the Plan paid Vanguard approximately \$50,000 for these services. Additionally, the Plan paid approximately \$36,000 for investment advisory, audit, and other services. These transactions qualify as party-in-interest transactions, as defined in Section 3(14) of ERISA; they are expressly exempted from the prohibited transaction rules.

#### (7) Fair Value Measurements

Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies:* Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

*Common/Collective Trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the net asset value (“NAV”) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
