INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Mid-State Group, Inc. Savings & Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Mid-State Group, Inc. Savings & Retirement Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended November 30, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of November 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Mid-State Group, Inc. Savings & Retirement Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to November 30, 2024 through July 31, 2025, which is the date the financial statements were available to be issued.

Key parties of the plan - Mid-State Group, Inc. is the plan sponsor/employer and the plan administrator. Nationwide Trust Company, FSB ("NTC") is the investment agent that maintains investment and participant records and holds custody of the plan's mutual fund investments. Nationwide Life Insurance Company ("NLIC") is the investment agent that holds custody of the plan's guaranteed investment contract. Tax Favored Benefits Inc. is the third party administrator and performs various compliance tests as tax counsel and is the plan's investment advisor. Two owners of the plan sponsor are the plan trustees. Subsequent to year end, the plan sponsor switched investment agents and transferred all plan assets to Principal.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold, and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - The mutual funds are held by NTC and are offered outside of an annuity contract. NTC uses unit values to perform daily account valuations. The unit value is NTC's method for valuing accounts and is not the same as the net asset value ("NAV") reported by the mutual funds, although the financial trend should be the same. After the close of the stock market, NTC receives a daily price from each mutual fund. This figure includes the NAV and any dividends and capital gains declared and is adjusted by NTC with the addition of a daily administration charge to arrive at the unit value available daily to plan participants on the plan website

Investments at contract value - The plan has a fully benefit-responsive guaranteed investment contract with NLIC. NLIC maintains the contributions in a general account. NLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The interest crediting rate is reset quarterly. The average yield earned by the fund was 2.21% and 2.37% during 2024 and 2023.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by NLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time. Amounts may be transferred from the participant's account balance in the fund at any time.

The NLIC contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor can request a lump sum distribution with a market value adjustment or an installment payout, at contract value, over a period of years. The NLIC contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on NLIC's ability to meet their financial obligations. NLIC's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with NLIC. At this time, the plan administrator is not aware of any events that may limit the ability of the plan to transact at contract value with NLIC or that would limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General - The plan was established on December 1, 2001 as a defined contribution plan and has a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible once they have completed six months of eligible service and have reached 21 years of age. An employee will be allowed to enter the plan on December 1 or June 1 after meeting the eligibility requirements.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- a. Participants may contribute a percentage of their annual wages or a set amount per pay period, subject to certain limitations (elective deferral contributions). The plan allows Roth elective deferrals.
- b. Participants may make rollover contributions to the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. The discretionary matching contribution was 35% of the first 5% of compensation that a participant contributed to the plan for 2024 and 2023.
- d. Employer discretionary nonelective contributions may be made at the employer's discretion. No such contributions were made in 2024 or 2023.

Participant accounts - Contributions are remitted to NTC who invests them in accordance with the investment options selected by the participants. The values of the investments are adjusted daily to reflect the earnings plus the fair value appreciation (depreciation). Participants are allowed to transfer funds between the various investment options and change their deferral percentage at any time.

Vesting - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Participants begin vesting in employer contributions and related earnings upon completing two years of service at which time they are 20% vested. The participant then vests at the rate of 20% for each year thereafter. Upon death, disability or qualified retirement, participants become 100% vested.

Payment of benefits - Benefit payments are recorded when paid. Benefit payments may commence upon death, disability, attainment of normal retirement age (defined as age 63) or termination of employment. Participants may elect their distribution to be in the form of a single lump sum or installment payments. In-service withdrawals can commence upon attaining the age of 59 ½. Hardship withdrawals are not permitted under the plan.

Forfeitures - Forfeitures may be used to pay administrative expenses or reduce employer contributions. Forfeitures of \$3,000 and \$0 were used in 2024 and 2023. Unapplied forfeitures were \$3,000 and \$1,500 as of November 30, 2024 and 2023.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other fees are paid using plan assets and recorded as administrative expenses in the accompanying financial statements. Administrative expenses paid by the plan consist of participant directed charges for participant loan, distribution and managed account service fees and nonparticipant directed charges for service and administrative and investment management fees. Non participant directed fees are allocated to the participants on an account value basis.

Notes receivable from participants - Participants may obtain a loan against their accounts with the approval of the plan administrator. Each participant may only have one loan outstanding at any time. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000. The repayment term generally cannot exceed 5 years, the exception being when the loan is for the purchase of a primary residence. As of November 30, 2024, loans outstanding had various repayment schedules through March 2048 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions and related earnings.

4. INCOME TAX STATUS

Effective July 1, 2022, the plan was restated and adopted a new non-standardized pre-approved profit-sharing plan with a favorable opinion letter dated June 30, 2020. The opinion letter received from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) if the plan has taken any uncertain positions that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of November 30, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by NLIC and NTC. NLIC and NTC act as agents of the plan and, therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the plan to the agents were \$24,000 and \$23,000 in 2024 and 2023. In addition, the agents provide certain administrative and recordkeeping services for the plan pursuant to service agreements between the plan and the agents. The agents receive indirect compensation from mutual fund providers for services they provide to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed by the plan to the agents for certain administrative and recordkeeping services provided to the plan.

Notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
