### Note 1. Plan Description

The following description of the Logistic Specialties, Inc. 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document and any amendments for a more complete description of the Plan's provisions:

#### General

The Plan is a contributory defined contribution plan covering substantially all employees of its sponsor, Logistic Specialties, Inc. (Plan Sponsor). Employees are eligible to participate in the Plan when they have completed 60 days of service and are eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and related Department of Labor regulations.

#### Contributions

Each year, participants may contribute up to the maximum allowed by the IRS of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions for other qualified defined benefit or contribution plans. The Plan Sponsor contributes 100% of the first 3% of base compensation that a participant contributes to the Plan, excluding employees contracted under CalFire. The Plan Sponsor contributes to those employees 100% of the first 3% and 50% between 3% and 8%. The matching Plan Sponsor contributions are invested directly as participants have directed. Additional amounts may be contributed at the option of the Plan Sponsor's board of directors. Contributions are subject to certain limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions and allocations into various investment options offered by the Plan. The Plan currently offers several registered investment company funds and an insurance investment contract as investment options for participants.

#### Vesting

Plan participants are immediately vested in their contributions and rollovers, plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of the participants' accounts plus actual earnings thereon is based on years of continuous service based on the following vesting schedule:

#### Notes Receivable from Participants

Participants may borrow from their salary deferral contributions up to a maximum of 50 percent of their vested balance or \$50,000, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate that is determined when the loan is made. The loan plus interest, which is credited to the participant's account, must be repaid within a five-year period, if the loan is used to acquire a principal residence longer repayment terms may be permitted. Principal and interest is paid ratably through payroll deduction.

#### Payment of Benefits

On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or monthly installments over an established period of time or the participant's life. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or, if the participant's vested account balance exceeds \$5,000, the participant may elect to leave the account in the Plan. Participants may also receive hardship distributions from the Plan based upon certain criteria established by the Plan.

During the year ended December 31, 2024, the Plan paid benefits to withdrawing participants totaling \$590,703. There were no amounts allocated to withdrawing participants for claims that were processed and approved for payment prior to December 31, 2024, but not yet paid as of that date.

#### Forfeited Accounts

At December 31, 2024, the forfeited nonvested account balances not yet applied to reduce Plan Sponsor contributions totaled \$8,306. These accounts are used to reduce future Plan Sponsor contributions. Plan Sponsor contributions were not reduced from forfeited nonvested accounts during the year ended December 31, 2024.

### Note 2. Summary of Significant Accounting Policies

#### Basis of Accounting

As described in Financial Accounting Standards Board Staff Position, FSP AAG INV-1 and SOP 94-4-1, Reporting of Fully Benefit-Responsive Investment Contracts Held by Certain Investment Companies Subject to the AICPA Investment Company Guide and Defined-Contribution Health and Welfare and Pension Plans (the FSP), investment contracts held by a defined-contribution plan are required to be reported at fair values, except for fully benefit-responsive investment contracts. However, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. As required by the FSP, the Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

### Note 2. Summary of Significant Accounting Policies, Continued

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024, no allowance for loan losses had been recorded. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

#### Payment of Benefit

Benefits payments to participants are recorded when distributions are made.

#### Operating Expenses

All expenses of maintaining the Plan are paid by the Plan Sponsor.

#### Plan Expenses

Administrative expenses paid by the Plan were \$27,432 for the year ended December 31, 2024.

#### Subsequent Events

Subsequent events were evaluated through August 21, 2025, which is the date the financial statements were available to be issued.

### Note 3. Financial Information Certified by Trustee

In accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Report and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), all of the investment information including investment income, shown in the financial statement and supplemental schedule has been certified as complete and accurate by the Trustees of the Plan.

### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

**Registered Investment Companies:** Valued at the daily closing price as reported by the investment provider. The registered investments held by the Plan are deemed to be actively traded.

### **Note 5. Common Collective Trust with Insurance Company**

Morley Stable Value Fund and Federated Hermes Capital Preservation Fund were formed for the purpose of allowing participating plan sponsors, who maintained defined contribution plans qualified under Sections 401(k) of the IRC, to invest in the funds ("Contracts") issued by Principal Global Investors Trust Company and Federated Hermes, Inc., respectively. Units are issued and redeemed daily at contract value. As of December 31, 2024, contract value approximated estimated fair value.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit responsive investment contracts because this is the amount received by a participant if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Global Investors Trust Company, represents contributions made under the contract plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) termination of the contract if any of these events were to occur a market value adjustment may apply. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plans participants were the issuer are probably of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guideline (2) a breach of material obligation under the contract (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### **Note 6. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note 7. Notes Receivable from Participants

Notes receivable from participants represents loans that are permitted under the terms of the Plan. Participants may borrow from their accounts up to a specified percentage of their vested account balance, subject to certain minimum and maximum limits. Loans are secured by the participants' account balances and bear interest at rates commensurate with local prevailing rates at the time the loans are made. Principal and interest are paid ratably through payroll deductions.

As of December 31, 2024, notes receivable from participants totaled \$69,538 and bear interest at rates ranging from 4.25% to 9.50% with maturities through 2029.

### Note 8. Tax Status

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 9. Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and are distributed to participants.

### Note 10. Party in Interest Transactions

Certain Plan investments are unit accounts managed by Reliance Trust, who provides retirement services to the Company. Reliance Trust is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return on each fund.
