NOTE A - DESCRIPTION OF PLAN

The following description of NutraCo LLC 401(k) Plan (formerly NutrasourceRD LLC 401(k) Plan) ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2016. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering substantially all employees of NutraCo LLC (formerly NutrasourceRD LLC) (the Company) who have completed three months of service, are age 18 or older, and are not nonresident aliens or residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 1, 2023, the Plan was amended to change its name to NutraCo LLC 401(k) Plan from NutrasourceRD LLC 401(k) Plan due to the change in the legal name of the Company to NutraCo LLC from NutrasourceRD LLC.

Contributions

Participants may elect to contribute on a pre-tax basis or post-tax (Roth) basis to the Plan from 1% up to 90% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may, at its discretion, make matching contributions and nonelective contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary matching contributions or nonelective contributions to the Plan. To be eligible to receive an allocation of any nonelective contributions made to the Plan, participants must be employed on the last day of the Plan year and earn at least 500 hours of service during the Plan year. Participants direct the investment of their Company contributions into various investment options offered by the Plan. Company contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, if any, an allocation of any Company discretionary nonelective contributions, and Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested account balance. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants vest immediately in their contributions, Company discretionary matching contributions, if any, Company discretionary nonelective contributions, if any, plus actual earnings thereon.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship withdrawals are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments may be made in the form of lump sum distributions, partial withdrawals subject to a minimum of \$500, and equal installments. Participants who terminate employment with a balance of less than \$1,000 may receive an automatic lump sum distribution of their balance. Effective January 1, 2024, participants who terminate employment with a balance of less than \$7,000, but more than \$1,000, may receive an automatic direct rollover of their account balance into an individual retirement account. Effective through December 31, 2023, participants who terminated employment with a balance of less than \$5,000 but more than \$1,000, may have received an automatic direct rollover of their account balance into an individual retirement account.

Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. Forfeitures may be used to pay Plan expenses or reduce Company contributions. There was no forfeiture balance as of December 31, 2024 and 2023. No forfeitures were used during the years ended December 31, 2024 and 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and Company contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for recordkeeping and third-party administration are included in administrative expenses and are allocated to participant accounts based on a pro rata formula. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund: The Invesco Stable Asset fund is a collective investment trust fund. The investment is valued at the NAV of units of the collective investment trust. The NAV is used as a practical expedient to estimate fair value. The fund is composed primarily of guaranteed investment contracts. The fund is not registered with the SEC. There are no unfunded commitments. The redemption notice period is 90 days and redemption frequency is daily. The Plan will receive the lesser of book value or market value if it chooses to terminate the fund as an investment option and the issuer reserves the right to require a 12-month written notice.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE F – TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan is designed in accordance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ADP, Inc. and its affiliates provide the third-party administration, recordkeeping, and investment advisory services to the Plan. Fees paid to ADP, Inc. have been included in administrative expenses. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Notes receivable from participants and related interest income also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the audit of the Plan for the year ended December 31, 2022, it was discovered that the Company erroneously failed to remit \$2,499 of participant contributions to the Plan related to the Plan years ended December 31, 2019, 2018, and 2017. The delinquent participant contributions are prohibited transactions and are recorded as participant contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023. The Company corrected the delinquent participant contributions in 2025.

NOTE K – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan changed service providers from ADP Retirement Services to Paychex Retirement Services. As a result of the change in service providers, the Plan adopted a new nonstandardized Plan document on January 1, 2025. The following changes were made to the Plan effective January 1, 2025:

- The Plan name was changed to NutraCo 401(k) Profit Sharing Plan and Trust
- The three month eligibility service requirement requires three consecutive months of service
- Participants may contribute from 0% up to 92% of compensation in increments of 1%
- Participants will be entitled to apply the vested portion of their account towards the purchase of an annuity contract
- There is no partial withdrawal minimum for benefit payments

As a result of the change in service providers, on January 31, 2025, assets totaling \$2,027,168 were transferred from Reliance Trust Company to Mid Atlantic Trust Company dba American Trust Custody.
