## Independent Auditors' Report

NOTE 1      Description of plan

The following description of The Weston Group, Inc. 401(K) Profit Sharing Plan (the "Plan"), provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who effective March 1, 2024, are age eighteen and have completed two consecutive months of employment. Prior to March 1, 2024, those who were age eighteen and had completed three consecutive months of employment were eligible. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees governance of the Plan, and determines the appropriateness of the Plan's investments and monitors investment performance.

Contributions

Each year, participants may contribute up to 90% of their annual compensation, as defined in the Plan, but not more than the statutory maximum. Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision for all newly hired participants unless they elect otherwise. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a qualified default investment alternative until changed by the participant. The Company may make matching contributions equal to a discretionary percentage to be determined by the Company of the participant's elective deferrals. The Company did not make a matching contribution during 2024. The Company may also make profit sharing contributions equal to discretionary percentage of a participant's compensation or a discretionary dollar amount, the percentage of the dollar amount to be determined by the Company. The Company did not make any profit-sharing contribution to the Plan during 2024. Plan contributions are subject to certain IRS limitations.

The Plan document states that in order to share in the matching and profit-sharing contributions, the participant must satisfy the following conditions:

- If participant is employed on the last day of the Plan Year, the participant will share regardless of the amount of service you completed during the Plan Year.
- If participant terminates employment (not employed on the last day of the Plan Year), the participant will not share regardless of the amount of service the participant completed during the Plan Year.
- Participant will share in the matching and profit-sharing contributions for the Plan Year regardless of the amount a service you completed during the Plan Year in which your death, disability or termination of employment after Normal Retirement Age occurs. This waiver of allocation conditions will only apply once during our employment history with the Employer (e.g., if you retire, are rehired and then retire again, the waiver only applies to your initial retirement).

Setting Every Community Up for Retirement Enhancement Act (SECURE) 2.0 Act

President Biden signed the Consolidated Appropriations Act (CAA) --including SECURE 2.0 Act of 2022--into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019, and the Plan document has been amended for provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and company matching contributions, if any, and an allocation of (a) the Company's profit-sharing contribution, if any, (b) plan earnings (losses) and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the company contributions portion of their accounts plus earnings thereon is as follows:

Payment of benefits

Withdrawals are allowed under the following circumstances: (a) termination of employment, (b) retirement, (c) attainment of age 59 ½, (d) disability, and (e) death. Distributions under the Plan are payable at the election of participants (or their beneficiaries in the case of death during active employment) in one lump-sum payment, installments over a period of not more than your assumed life expectancy (or the assumed life expectancy of you and your beneficiary), or partial withdrawals.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus one percent when the borrowing was made. Principal and interest are paid ratably through payroll deductions.

### Forfeited accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. The employer may use forfeitures to pay Plan expenses. In some cases, remaining forfeitures will be used to reduce employer contributions.

### NOTE 2 Summary of significant accounting policies

#### Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America. ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Executive Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and recordkeeper. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### Payment of benefits

Benefits are recorded when paid.

### Contributions

Contributions from the Plan participants and any matching contributions, if applicable, from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### NOTE 3 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs used in determining valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (“mutual funds”) are valued at the daily closing price as reported by the fund. They are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price and are deemed to be actively traded.

The stable value collective trust fund is composed primarily of fully benefit-responsive investment contracts that is valued at net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer currently reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### NOTE 5 Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

#### NOTE 6 Tax status

The Plan operates under a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA with a cash or deferral arrangement, which received an opinion letter dated October 6, 2020 from the Internal Revenue Service ("IRS") indicating this plan was an acceptable plan under applicable sections of the Internal Revenue Code ("IRC") for use of employers for the benefit of their employees. An employer who adopts this plan will be considered to have a plan qualified under Code Section 401(a), providing all the terms of the Plan are followed and the eligibility requirements and contribution or benefit provisions are not more favorable to officers, owners or highly compensated employees than for other employees. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
