INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Dugan Truck Line, LLC 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dugan Truck Line, LLC 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Reliance Trust Company (Reliance), the trustee of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information prepared by Automatic Data Processing, Inc. (ADP) on behalf of Reliance, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTE A - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 2007, is a defined contribution plan. Employees of Dugan Truck Line, LLC. (the Company) who have been employed for one month or more and are twenty-one or older may contribute to the Plan. Employees become eligible to participate in the Plan on the first day of the plan entry date following the date on which eligibility requirements are met. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides that active participants may make annual pre-tax and Roth after-tax contributions of up to 90 percent of their eligible compensation to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a group of mutual funds. The Company may make discretionary matching contributions as determined by plan management. Participants are eligible for the matching contribution after one year of service. For 2024 the Company made a match of the lesser of 0.5% of compensation and 10% of employee deferral. Contributions are subject to certain Internal Revenue Code limitations.

Participant Accounts

Each participant's account is credited with the participant's deferral and an allocation of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts are used to pay reasonable plan expenses or to reduce future employer contributions. \$1,430 of forfeitures were used to reduce employer contributions during 2024. Unallocated forfeitures at December 31, 2024 and 2023 were \$99 and \$998, respectively.

Payment of Benefits

On termination of service due to disability, retirement, or other reason, a participant (or beneficiary) will receive a lump-sum amount equal to the participant's vested account. Participants with vested balances in excess of \$5,000 may elect to receive a lump-sum amount or delay payment until normal retirement date.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits (Continued)

Payment of the death benefit will be a single lump-sum or partial distribution subject to reasonable limits the plan administrator may impose. Each such partial distribution must be at least equal to the required minimum distribution amount.

Vesting

Participants immediately vest in their elective deferrals plus actual earnings thereon. Participants shall be fully vested with respect to Company contributions upon normal retirement age, as defined by the Plan, or death. Otherwise, vesting in the Company's contribution portion of their account is based on years of service as follows:

Participants receive credit for one year of service for each plan year, provided 1,000 or more hours of service were completed during the plan year.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The financial statements of the Plan have been prepared using the accrual method of accounting and present the net assets available for plan benefits and changes in those net assets based on fair value.

Investments

All investments are stated at fair value, which is based on quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid. There were no withdrawals requested but unpaid at December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

NOTE C - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's account shall be fully vested and nonforfeitable.

NOTE D - PLAN EXPENSES

Certain administrative expenses for the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in the value of investments.

NOTE E - TAX STATUS

The IRS has determined and informed the prototype's sponsor by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - CONCENTRATIONS

Three funds with the highest value comprised approximately 47% and 46% of net assets available for benefits as of December 31, 2024 and 2023, respectively.

NOTE I - FAIR VALUE MEASUREMENTS (CONTINUED)

FASB ASC 820-10, Fair Value Measurement, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were used by the Plan.

Level 1 Fair Value Measurements

The Plan invests in Vanguard Treasury Money Market Fund which is a highly liquid money market fund and is considered to be a cash equivalent.

The fair value of the money market fund and mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

NOTE J - RELATED PARTY TRANSACTIONS

Plan investments are in custodial control and managed by ADP and Reliance, the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest.

NOTE K - SUBSEQUENT EVENTS

Effective January 1, 2025, ADP Retirement Trust Services, LLC became the trustee of the Plan.

Management has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued and determined that no additional disclosures were necessary.
