## INDEPENDENT AUDITORS' REPORT

The Plan Administrator  
Infinity Systems Engineering, LLC 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Infinity Systems Engineering, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 

## Notes to Financial Statements

### December 31, 2024 and 2023

#### 1. Description of Plan

---

The following description of the Infinity Systems Engineering, LLC 401(k) Plan (“the Plan”) sponsored by Infinity Systems Engineering LLC (“the Company”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a participant-directed defined contribution plan, under which participants may direct their contributions into various investment options (generally mutual funds) offered by the Plan. An employee may participate on the first day of the month after completing two consecutive months of eligibility service and after reaching age 18. Excluded employees are union employees, nonresident aliens, leased employees and residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Board of Trustees (composed of sponsor management) is responsible for the oversight of the Plan. An Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

##### **Contributions**

Participants may generally defer annual compensation to a specified limit (\$23,000 in 2024), as defined in the Plan and by statute. Annual additions to the plan are also limited to the lesser of annual compensation or a statutory limit (\$69,000 in 2024). Participants may also transfer in amounts representing distributions from other qualified plans (rollovers). Contributions are also subject to other statutory limitations, with certain “catch-up” adjustments also permitted for participants age 50 or older.

For employees hired before January 1, 2021, the company contributes Safe Harbor non-elective contributions and discretionary profit-sharing contributions of 3% and 7%, respectively, of compensation.

Effective January 1, 2021 for all new employees, the company contributes Safe Harbor non-elective contributions and discretionary profit-sharing contributions of 3% and 3%, respectively, of compensation.

Beginning October 1, 2023 for only employees of the IBEW Local 543 Union, the Company contributes 100% of the first 4.5% of the employee contribution.

Participants may designate all or a portion of their elective deferrals as Roth elective deferrals.

Rollovers from other qualified plans are permitted.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company Safe Harbor contributions, as well as allocations of the Company discretionary contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses (primarily ADP and investment advisor fees) that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions, Safe Harbor contributions, and earnings thereon. Vesting in non-Safe Harbor Company contributions and earnings thereon is based on total years of vesting service and shall be allocated only to participants who were employed on the last day of the plan year. A year of service is determined by the hours of service method.

Effective January 1, 2019, an adoption was made for participants to become 100% vested in non-safe harbor employer contributions after one year of service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts an amount equal to the lesser of \$50,000 (with certain reductions for loans already outstanding) or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4% to 9.5%, which are commensurate with prevailing rates at the origination of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions, generally over terms not exceeding five years, with longer terms for loans used to acquire a primary residence. Participants may only have one loan at a time.

**Payment of Benefits**

Distributions under the Plan are generally made in lump sums although partial withdrawals are permitted. Hardship distributions are permitted, and in-service distributions may be made if the participant has reached age 59 ½. Distributions of less than \$5,000 do not require participant consent.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10. Forfeitures may be used to reduce employer contributions and to pay Plan expenses (\$4,517 and \$18,544 were used to reduce contributions in 2024 and 2023, respectively).

**2. Summary of Significant Accounting Policies**

---

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are generally reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determine the Plan's valuation policies based on input from the custodian and recordkeeper. See note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is reported on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS, if any, are recorded as a liability with corresponding reduction to contributions.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the related participant and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

The Company paid for certain direct Plan administrative and other expenses, which are excluded from these financial statements. Additionally, Company employees provide certain administrative duties at no charge to the Plan. Fees assessed to ADP Retirement Services were fees from trust and assessed pro rata to all participants with plan balances.

**3. Tax Status**

---

The Plan has not obtained a determination letter, but the volume-submitter plan document has received a letter dated October 6, 2020, from the IRS that its form is acceptable under section 401 of the Internal Revenue Code. The Plan has since been amended, but the Plan Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable tax authorities.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Because plan management believes that the Plan had no taxable income, no income tax returns have been filed for 2024 or prior years.

**5. Plan Termination**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

---

**6. Party in Interest Transactions**

---

Reliance Trust acts as the trustee/custodian and ADP Retirement Services is the recordkeeper. Therefore, these transactions qualify as party in interest transactions.

ADP and its affiliates and the plan's investment advisor was able to receive 12(b)(1) fees or similar fees from Plan investments for plan advisory services.

**7. Risks and Uncertainties**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

---

**8. Fair Value Measurements**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Section 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 from those used in the prior year.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Comprised of mutual funds and common stock, valued at reported daily closing prices.

*Common Collective Trust:* Valued at NAV of units in a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**9. Stable Value Investment**

The Plan has investments in the Invesco Stable Value Asset Fund, which a collective trust fund in the Invesco Stable Asset Trust. The fund invests exclusively in the Invesco Stable Value Trust (Class C shares), a bank collective trust fund. The fund invests in a diversified portfolio of investment contracts issued by banks and insurance companies. These contracts allow for participants to transact at book value.

Because of the indirect holding nature of this investment, it is not considered to be fully benefit-responsive.

There were no reserves against unit value for credit risk of the contract issuer or otherwise.

This information is only a summary of certain key provisions of the investment, and participants should refer to the Stable Value contract for a complete review of its provisions, including the impact of events such as mergers, layoffs, bankruptcy, full or partial Plan termination, and early retirement incentive programs as defined therein. Management does not believe such events are likely to occur in the near future.
