## Notes to Financial Statements

December 31, 2024

### **1. Plan Description**

The following description of Bluemont Group Holdings, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of this publication are available from the Plan Sponsor.

#### **General**

The Plan is a defined contribution plan covering substantially all full-time employees of Bluemont Group Holdings, LLC, BMG Bakery, LLC, Bluemont Group, LLC, Bluemont Group KC Acquisition Operations, LLC, Bluemont Group TN Acquisition Operations, LLC, and Bluemont Group Services Co., LLC (collectively referred to as the “Plan Sponsor”) who have completed three months of qualifying service and are 21 years of age or older. Eligible employees may enter the Plan on the first day of each quarter after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor is responsible for oversight of the Plan and has entrusted the maintenance of records and day-to-day administration to Automatic Data Processing Retirement Services (ADP). Transactions are processed through Reliance Trust Company (Reliance).

#### **Plan Contributions**

Each year, participants may contribute, on a pre-tax or post-tax basis, to the Plan, up to 99% of their eligible wages, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change the investment options previously elected at any time.

The Plan Sponsor contributes a safe harbor matching contribution equal to 100% of the first 4% of compensation each participant contributes to the Plan. The Plan Sponsor may also make discretionary matching contributions to the Plan; no such discretionary matching contributions were made during 2024.

Cash contributions receivable, if any, are unsecured.

### Notes to Financial Statements (continued)

#### **1. Plan Description (continued)**

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Plan Sponsor contributions, investment earnings and losses that are allocated based on each participant's relative account balance within the respective fund, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Payment of Benefits**

Upon termination of service, death, disability, or retirement, a participant (or his or her beneficiaries) may receive a lump sum amount equal to the vested value of his or her account. Partial withdrawals or installments are only permitted for participants who must receive required minimum distributions in accordance with the Internal Revenue Code (IRC). In-service hardship withdrawals are also available in certain circumstances.

##### **Vesting**

Participants are immediately vested in all contributions, including Plan Sponsor contributions, and earnings allocated thereon.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to under plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **2. Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP), as are the annual returns filed under applicable provisions of ERISA and the IRC.

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

### Notes to Financial Statements (continued)

#### **2. Significant Accounting Policies (continued)**

##### **Investment Valuation and Income Recognition**

The Plan's investments in mutual funds are reported at fair value. Net appreciation or depreciation in the fair value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits. This includes all investments bought or sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis.

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, incurred by the Plan if the counterparties to the Plan's investments failed to perform and any collateral was insufficient, would be the recorded amount of such investment.

##### **Benefit Payments**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Certain investment related expenses are included in net realized and unrealized appreciation or depreciation in the fair value of investments.

##### **Subsequent Events**

Plan management has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.

#### **3. Income Tax Status**

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan sponsored by ADP, LLC that received a favorable opinion letter from the IRS dated October 6, 2020, which states the plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

### Notes to Financial Statements (continued)

#### 4. Certified Information (Unaudited)

Reliance holds the Plan's investments assets and executes transactions therein. Financial information relating to those assets disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, net realized and unrealized appreciation in the fair value of investments, and dividend income, is based upon information provided to the Plan Administrator and agreed to or derived from information certified as complete and accurate by Reliance.

#### 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### 5. Fair Value Measurements (continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes to the methodologies used as of December 31, 2024 and 2023.
