## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Make A Wish Foundation of Greater Ohio, Kentucky & Indiana, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Make A Wish Foundation of Greater Ohio, Kentucky & Indiana, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion section of our report, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Make A Wish Foundation of Greater Ohio, Kentucky & Indiana, Inc. 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Make A Wish Foundation of Greater Ohio, Kentucky & Indiana, Inc. 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of Make A Wish Foundation of Greater Ohio, Kentucky & Indiana, Inc. 401(k) Retirement Plan (“Plan”) is provided for general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan covering all employees of Make A Wish Foundation of Ohio, Kentucky & Indiana, Inc. (the “Company”). Employees are eligible to participate in the Plan upon the first day of the month after the month of eligible service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**Fiduciary** – Effective January 1, 2020, The Edwards Group at Morgan Stanley Group will serve the Plan in a fiduciary capacity meaning the fiduciary burden for investment monitoring and changes, plan implementation and plan management shifts to The Edwards Group at Morgan Stanley while the Plan still maintains fiduciary responsibility for plan design, investment/governance/cost structures, and monitoring the investment manager’s performance.

**Contributions** – Participants may elect to contribute to the Plan a percentage of compensation, subject to certain limits under the Plan and established by the Internal Revenue Service (“IRS”). The Company provides a matching contribution equal to 25% of an employee’s elective deferral that does not exceed 12% of compensation for the plan year.

**Participant Accounts** – Participants direct the investment of their contributions and their share of Company contributions into various investment funds. Individual accounts are maintained for each Plan participant. Each separate account is increased or decreased with pro rata allocation of each selected investment fund’s earnings or loss. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account. The Plan modifies the investment line-up as approved by the Plan’s investment review committee. The majority of the investment options are in a common collective trust versus the historical registered investment company options as part of an investment strategy to reduce fund costs to participants.

**Vesting** - Participants are immediately vested in their voluntary contributions. Vesting in the Organization’s matching and discretionary contributions, and actual earnings thereon, is based on years of continuous service. Participants become vested in the Organization’s matching and discretionary contributions based on the following schedule:

**Forfeitures** - In accordance with the Plan document, if employment with the Plan Sponsor is terminated, the non-vested portion of the employer contributions are forfeited. Forfeitures, if any, may be used to reduce any employer contribution on a per payroll basis. For the year ended December 31, 2024, forfeitures applied to reduce employer matching amounted to \$2,635.

**Participant Loans** – A participant may borrow from his or her account up to a maximum amount equal to the lesser of \$50,000 or 50% of the nonforfeitable account balance. Loan terms range from one to five years or up to thirty years if the loan is to acquire a principal residence. The loans are collateralized by the balance in the participant's account and provide for interest at a fixed rate of prime plus 2% at the time of the loan. Principal and interest are paid through payroll deductions in accordance with the payment schedule in the promissory note.

**Payment of Benefits** – Plan benefits are based solely on the amount contributed to the participant's account by the Company and the participant and the cumulative share of any income and gains and losses. Payment of benefits upon retirement, disability, death, or other termination of employment may be made at the participant's option directly to the participant or in the form of a rollover. Withdrawals of a participant's interest in his or her account may be made prior to termination, subject to certain restrictions.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting** – The financial statements of the Plan are prepared using the accrual basis of accounting.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related loan-origination fees are charged directly to the borrower's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, notes receivable from participants totaled \$16,654 and \$26,617, respectively. No allowance for credit losses was considered necessary at either date.

**Valuation of Investments and Income Recognition** – The Plan's investments are reported at fair value, which are reported at net asset value per share, or contract value, as practical expedient under ASC 820, "Fair Value Measurement." Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. The change in the difference between current value and the cost of investments and the gain or loss on the sale of investments is reflected in the statements of changes in net assets available for benefits as net appreciation in fair value of investments. The cost of investments sold is based on the average cost of the investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Expenses** – As permitted by the Plan Document, administrative expenses are paid by the Plan Sponsor, with the exception of investment fees which are paid by the Plan and directly debited from the participant accounts. For the years ended 2024 and 2023, the total administrative charges amounted to \$9,198 and \$11,132, respectively.

**Payment of Benefits** – Benefits are recorded when paid.

**Subsequent Events** – Subsequent events have been evaluated for potential recognition and/or disclosure through August 27, 2025, the date the financial statements were available to be used. The management found no subsequent events that need to be disclosed in the financial statements.

**NOTE 3 – INCOME TAX STATUS**

The adopted prototype plan document sponsored by ADP, LLC received an opinion letter from the Internal Revenue Service dated October 6, 2020, which provides that the Plan and the related trust qualify under the provisions of Section 401(a) of the Internal Revenue Code and therefore, are exempt from federal income taxes under the provisions of Section 501(a) of the Code. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audit by tax authorities; however, there are currently no audit for any tax periods in progress.

**NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE**

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Reliance Trust Company, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustees that such information is complete and accurate.

**NOTE 5 – FAIR VALUE OF FINANCIAL INSTRUMENTS**

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. In accordance with generally accepted accounting principles, the Plan classifies its investments into Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques** — Valuation technologies maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Company Funds* — Valued at the daily closing price as reported by the fund. Registered Investment Company funds are registered with the Securities and Exchange Commission. Investments by Registered Investment Companies include mutual funds, closed-end funds and unit investment trusts. These funds are required to publish their daily net asset value and to transact at that price. The funds invested with Registered Investment Companies by the Plan are deemed to be actively traded.

*Cash Equivalents* — Held primarily in short-term money market commingled funds, which are valued at cost plus accrued interest.

**Transfers Between Levels** — The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended, December 31, 2024 and 2023, there were no transfers between levels.

The following table sets forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis as of December 31, 2024 and 2023, respectively. Common Collective Trust funds investments are measured at fair value using the net asset value per share (NAV). Such investments are not categorized in the fair value hierarchy but are provided to permit reconciliation of the fair value hierarchy to the amounts presented in the Statement of Net Assets Available for Benefits. The NAV has been applied as a practical expedient for estimating fair value as these investments can be redeemed at the net asset value.

**NOTE 6 – INVESTMENT IN COMMON COLLECTIVE TRUST FUND**

The Plan maintains various investment options with the State Bank and Trust Company (the Fund). The funds are designed to provide long-term investors with an asset allocation strategy designed to maximize their retirement savings consistent with an acceptable level of risk tolerance, ranging from aggressive to conservative, and projected retirement date associated with each fund. To pursue its investment objectives, the funds are diversified across an international equity, global real estate, commodities, intermediate-term bonds and inflation-protected bonds. Common collective trust funds have been valued using the net asset value per share as a practical expedient of the fair value for these investments.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to alter, suspend, or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Plan assets will be distributed to the participants under federal law.
