Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of DG3 Local Union 318 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to, or derived from, the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).



NOTE 1 PLAN DESCRIPTION

The DG3 Local Union 318 401(k) Plan (the Plan) is administered by Diversified Global Graphics Group, Inc. (“the Company”, the Plan Sponsor or the Plan Administrator). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Company.

General

The Plan is a voluntary, participant-directed, defined contribution plan that became effective July 1, 1992. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees are eligible to participate in the Plan, except for nonunion employees, who are serviced under a separate plan, nonresident aliens, and leased employees. The Plan does not have any minimum age or service requirements to be eligible. Employees are eligible to begin contributions on the next payroll date following their date of hire.

Contributions

Participants may make voluntary pretax contributions and Roth 401(k) contributions to the Plan up to 20% of eligible compensation, up to the annual IRS dollar limit. The Plan accepts rollover contributions from other qualified retirement plans in accordance with ERISA. The Plan only accepts in-plan Roth rollover contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with, and subject to, IRS limitations. Participants may elect to change their deferral percentage at any time during the Plan year.

The Plan includes an employer-matching provision that is discretionarily based upon the Company’s collective bargaining agreement with the employees’ union. Employees are eligible for the employer-match contribution upon entrance to the Plan. The Company shall contribute a matching contribution to the Plan of 50% of all eligible employees’ contributions up to 5% of the employee’s base salary, pursuant to the original collective bargaining agreement put in place on July 18, 2011, and extended through June 30, 2025. The matching contribution calculation will be in effect for the entire length of the collective bargaining agreement.

The Plan includes a profit-sharing provision that is discretionary and determined on an annual basis as of the last day of the Plan year. The profit sharing contribution is allocated based on each participant’s percentage of total participant compensation. There were no profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, the matching contribution in accordance with the collective bargaining agreement, an allocation of the profit-sharing contribution, Plan earnings or losses, and administrative expenses. Allocations are based on a participant's compensation or account balances, as defined in the Plan Document. The Plan allows for amounts to be transferred into the Plan from other IRS tax-qualified plans. The amounts transferred are set up as separate accounts for vesting purposes.

Vesting

Participants are immediately vested in their voluntary employee contributions, rollover contributions, qualified nonelective contributions such as profit sharing, plus earnings thereon. Employer-matching contributions vest based on a six-year graded vesting schedule. Participants with less than two years of credited service are 0% vested. Vesting increases annually by 20% from year two through year five. Participants become 100% vested upon attainment of their sixth year of service.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures shall occur on the earlier of the last day of the Plan year in which a former participant incurs five consecutive one-year breaks in service or the distribution of the entire vested portion of the participant's account. Forfeitures are used to offset employer-matching contributions. The Plan used \$3,722 and \$362 during the years ended December 31, 2024 and 2023, respectively, to reduce employer contributions. There was a remaining balance in the forfeiture account of approximately \$8 and \$10, respectively, as of December 31, 2024 and 2023.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum of the lesser of 50% of their vested account balance or \$50,000, reduced by the difference between the highest loan balance outstanding from the Plan during the preceding 12 months. Loans must be repaid by payroll deductions over a maximum period of five years unless the loan is a principal residence loan, which must be repaid over a maximum period of 30 years. Loans are secured by the participants' vested interest in the Plan. The interest rate with respect to participant loans shall be the prime lending rate plus 1% as published in the Wall Street Journal on the 14th day of each month. An employee may not have more than one loan outstanding at any given time.

Payment of Benefits

Upon termination of service due to retirement, disability, or death, participants are entitled to receive a lump-sum distribution, or direct rollover as soon as administratively feasible following such valuation date provided. The Plan's normal retirement age is 65. There is no early retirement date under the Plan. Upon termination, a participant may receive the value of the vested interest in their account as a lump-sum distribution or direct rollover. If the vested balance is over \$5,000, the participant's funds will be left in the Plan until the participant submits a written request to the Company for payment or no later than the April 1st following the end of the year of attaining the age of 72. If the amount of distribution exceeds \$1,000 and the participant does not elect to receive it or roll it over, then the distribution will be automatically rolled over to an individual retirement account without consent. Benefits and taxes withheld are recorded when the participant is paid out.

In-Service Withdrawals

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account. Hardship withdrawals are subject to approval by the Plan Administrator and also subject to income tax withholding and penalty. The minimum withdrawal amount is \$500.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses and Participant Transaction Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participant-level fees, such as fees related to the administration of notes receivable from participants, investment fees, and certain Plan administration fees not covered by the Company are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated its subsequent events and transactions occurring after December 31, 2024 through August 12, 2025, the date that the financial statements were available to be issued.

NOTE 3 INVESTMENTS CERTIFIED BY THE PLAN TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the Plan Sponsor; Automated Data Processing, Inc., the Plan Recordkeeper; Reliance Trust Company, the Plan Trustee; the accountant involved with the Plan; and the third-party administrator, are considered party-in-interest transactions. Notes receivable from Plan participants qualify as party-in-interest transactions.

The Plan Sponsor paid certain administrative expenses on behalf of the Plan during the year. Additionally, certain administrative functions are performed by employees of the Plan Sponsor who do not receive compensation from the Plan for such functions.

NOTE 7 PLAN TERMINATION

Although the Company has not expressed intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions and earnings thereon, as of the termination date.

NOTE 8 TAX STATUS

The Plan Sponsor obtained an opinion letter from the Internal Revenue Service on October 6, 2020, in which the IRS stated that the prototype Plan Document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is being designed and operated in compliance with the Plan Document and applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, including interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits. The Plan's exposure to a concentration of credit risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into various financial instruments.
