## Independent Auditor's Report

To the Plan Administrator and Participants  
Telestream 401(k) Employee Savings Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Telestream 401(k) Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

**1. Plan Description**

The following description of Telestream 401(k) Employee Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan established March 1, 1998 by Telestream, LLC (“Telestream” or the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. Standard Insurance Company (“Standard”) serves as the custodian of the Plan. The Plan is administered by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

b. Eligibility

Employees of the Company who are 18 years of age or older are eligible to participate in the Plan upon completion of 2 months of service except nonresident aliens, part time, temporary or seasonal employees unless regularly scheduled service for the Plan year is at least 1,000 hours, interns and on-call employees, and residents of Puerto Rico. Beginning October 1, 2024, interns and on-call, part time, temporary or seasonal employees are eligible to participate in the Plan.

c. Contributions

Participants may contribute a percentage of their eligible compensation as a pre-tax or Roth deferral, as defined in the Plan document, subject to certain limitations under the IRC. Participants who are 50 years of age or older during the Plan year may also make catch-up contributions as allowed by the IRC.

The Company makes matching contributions equal to 50% of the first 8% of a participant’s elective contribution. Participants may also contribute amounts representing distributions from other qualified plans.

d. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. Participants can direct their account into a variety of investments offered by Standard. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant’s vested account.

e. Vesting

Participants are fully vested at all times in the portion of their accounts attributable to their own contributions and earnings thereon. Participants vest in employer matching contributions as follows:

1	30%
2	60%
3 or more	100%

Effective March 1, 2024, participants are fully vested in their employer matching contributions, except for participants with balances who terminated prior to the effective date.

f. Notes Receivable from Participants

Participants may borrow from their accounts a maximum of \$50,000 not to exceed 50% of the participant's account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Loan terms may not exceed 5 years unless the purpose of the loan is for the purchase of a primary residence in which case the term may be extended. The interest rate on notes receivable from participants as of December 31, 2024 ranged from 3.25% to 8.50% and the loans mature through 2029.

g. Payment of Benefits

On termination of service, death, or attainment of age 59½, a participant or their beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, a partial distribution subject to a minimum of \$1,000 or substantially equal installments. Terminated participants with a vested account balance less than \$5,000 may have their balance distributed in the form of a direct rollover to an individual retirement account designated by the Plan Administrator.

h. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their contributions as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

## **2. Summary of Significant Accounting Policies**

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value, except for the guaranteed investment contract which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses

during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

d. Contribution Receivables

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company or the participants. Contribution receivables are recorded at cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

e. Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable from participants are fully secured by the participants' vested accounts and as such, the Plan did not establish any allowance for credit losses. Delinquent notes receivable from participants may be treated as a distribution based on the terms of the Plan document.

f. Payment of Benefits

Benefits are recorded when paid.

g. Administrative Expenses

Administrative expenses, including custodial, recordkeeping, legal and accounting fees, are paid by the Company. Direct expenses totaling approximately \$30,000 and \$9,000 were paid by the Plan during 2024 and 2023, representing transactional fees incurred and allocated to specific participants. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

h. Forfeitures

At December 31, 2024 and 2023, unallocated forfeited nonvested accounts totaled approximately \$64,000 and \$38,000, respectively. Forfeitures are used to pay administrative expenses. During 2024 and 2023, approximately \$3,000 and \$2,000, respectively of forfeitures were utilized to pay administrative expenses.

### **3. Investments**

Plan investment assets are held by Standard. Participants can direct their accounts among various pooled separate accounts and a guaranteed investment contract.

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Standard, the Guaranteed Interest Fund ("GIF"). The assets of the GIF are held in the general assets of Standard. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The crediting rate was 3.03% as of December 31, 2024.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may

ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **4. Fair Value Measurements**

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* The Plan's interest in the pooled separate accounts is valued at the net asset value (“NAV”) of each pooled separate account's underlying investments as based on information reported by the investment advisor using the daily reported NAV of the pooled separate account at year-end.

## 5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

## 6. Information Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedules was provided and certified by Standard Insurance Company, the custodian of the Plan, as of December 31, 2024 and 2023, and for the years then ended, as complete and accurate:

- Investments, at fair value
- Investment, at contract value
- Notes receivable from participants
- Investment income
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

## 7. Related-Party Transactions

The Plan's investments are offered by Standard. Standard is the custodian of the Plan. Certain investment fees are paid by the custodian and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in interest transactions, which are exempt from the prohibited transaction rules.

The Plan sponsor, Telestream, is a party-in-interest to the Plan; however, there were no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan which are exempt transactions.

## 8. Income Tax Status

The Plan has been restated using the Standard Retirement Services, Inc. Volume Submitter 401(k) Profit Sharing Plan prototype document which received a favorable opinion letter dated March 31, 2014. The Plan has been amended since the date of the opinion letter. However, management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, management believes that the Plan is qualified and the related trust is tax exempt as of and for the years ended December 31, 2024 and 2023.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, participants would become 100% vested in all their accounts.

Certain participant contributions that occurred in 2022 were identified that were not remitted to the Plan by the Company within the time period required by the Department of Labor. These late remittances constitute prohibited transactions as defined by ERISA. Management remitted the lost earnings for the 2022 late contributions during 2024.
